

When a Veteran graduates from the Veterans Treatment Court program, they are given an opportunity to share their thoughts with other participating Veterans. It is so gratifying to listen to the graduating Veteran explain their successful journey through this valuable program. Of course, as mentors for this program - we always strive to be a positive influence and a ray of "hope" for these But what a profound impact the "Graduating Veteran" has as he/she stands with the Judge and faces his peers to emphasis how the program changed their life by providing a "second chance". Recently, there have been some changes in the 'staff' involved with the program. These "new staff" members are bringing 'new ideas' to the table - in the form of "Gift Incentives" - and so far, it's manifesting some encouraging results. In the past, Chapter 27 provided incentives by helping Veterans purchase a car, pay a utility bill or assist with housing needs. It is so rewarding to see the benefit of these For example, one of the 'graduating actions. Veterans' came back to the program as a Mentor – and rode a bicycle to get to court to help us. We

found a good vehicle for him and assisted with the purchase. With dependable transportation, this Veteran has now secured a good paying job with Mercedes. On the December 10th, we shared in the 'Spirit of Giving for Christmas' when we "paid" for the cost of a HUD application so another Veteran could obtain housing – just in time for Christmas. To become a more "positive" influence in this Veteran Treatment Program, Chapter 27 plans to provide "other" gift incentives such as "Food cards, Visa cards and Uber Transportation cards". 
I urge everyone to always check out the Commanders Action Network (CAN). It will pay off.



- 1. Ensure Veterans Exposed Toxic Substances Receive Full and Timely Benefits, Particularly for Burn Pits, Agent Orange and Other Known Exposures 2.
- 2. Enhance Veterans' Survivor Benefits

- Fully and Faithfully Implement the VA MISSION Act
- 4. Strengthen Veterans Mental Health Care and Suicide **Prevention Programs**
- 5. Enact Legislation to Address Gaps and Inequities in the VA's Women Veterans Health Care Program

These goals were provided to each of the legislators' offices in Washington and I distributed these critical goals to the chapter BPTL's. Plus it is on the DAV's website: https://www.dav.org/learnmore/legislation/. Everyone needs to contact the local office of our Congressional Representatives and Senators plus get on the Commander's Action Network and make your voices heard. Another thing I have discovered is that e-mails are just about the only effective means of communication with those offices. You can also stay abreast with BPTL Issues if you go to "BPTL" on Facebook and join. There is a lot of good info on that site concerning what is going on in Washington and what is being done by our Legislative Staff. Joy Ilem and all her folks put in a lot of hour attending committee meetings and testifying before those committees representing the welfare of all veterans and their families.

There are many issues before our State Legislature, which began its session on February 4. State Commissioner Kent Davis had the pleasure of letting the Legislature know exactly what the State Department of Veterans Affairs does. Here are the main items. Just control/click on the number and you can read everything about the proposed bill.

SB51 - Allowing military dependents to maintain in-state tuition even if the sponsor is relocated

<u>SB53</u> - Allowing for tax benefits for developments adjacent to Maxwell Air Force Base

<u>SB99</u> - Requiring notification of the state military department before granting permits for erecting tall structures

<u>SB105</u> - Requiring school systems to allow military families the opportunity to apply for magnet schools

<u>SB106</u> - Allowing for the formation of charter schools on or near military installations

SB88 was also introduced which authorizes the State Board of Education to issue alternate certifications to certain members of the armed forces.

On February 18, the State Military and Veterans Affairs Committee held a hearing regarding <u>SB143</u>, which allows military dependents to enroll in virtual schools upon receipt of orders to relocate to Alabama, and <u>SB163</u>, which would expand the Alabama Armory Commission from nine members to fifteen members.

On February 19 the Senate Finance and Taxation General Fund Committee met regarding <u>SB8</u>, which would increase Survivor Benefits for members of the National Guard.

In the House, the Military and Veterans Affairs Committee held a hearing on February 19 regarding three pieces of legislation:

<u>HB40</u> - Providing for lifetime hunting and fishing licenses for veterans

<u>HB100</u> - Allowing military dependents to enroll in virtual schools upon receipt of orders to relocate to Alabama

<u>HB115</u> - Extending the application of USERRA to active members of all uniformed services.

In other State news, Governor Ivey has encouraged the US and Alabama Secretaries of Labor to recruit and hire Alabama veterans.

Though it is not a BPTL issue, putting on my hat as the Vice Chairman for the State Board of Veterans Affairs, it is my pleasure to announce that the City of Enterprise was chosen by the Board as the site for the fifth State Veterans Home. All of us on the Board are really excited about it and I know the City of Enterprise is, as well. It will take us a couple of years to get it done, but it will be well worth the wait.

# DOS & Don'ts FOR MEMBERS DURING ELECTION YEAR CAMPAIGNS

DAV encourages you, as an individual, to register to vote, to vote in elections and to actively support the candidates of your choice. However, as a member of DAV, you have the responsibility to ensure your activities as a private citizen do not give the appearance that DAV supports or opposes any political candidate. To do so would violate our congressional charter, national Constitution and Bylaws and the law and regulations governing DAV's tax exempt status.

### Dos and Don'ts

- DO get involved in political campaigns, rallies, forums and town hall meetings, as an individual. It's your right as an American citizen—and a disabled veteran—to support the candidate of your choice.
- **DON'T** support a candidate, or attend political events in support of a candidate, in the name of DAV, nor should you give the appearance that DAV is supporting a particular candidate. Wearing DAV caps and shirts can give the appearance of support by the organization.
- D0 hold open candidate forums or town hall meetings so the candidates can discuss their positions on issues affecting disabled veterans, their families and survivors.
- DON'T forget to invite all candidates to the open forum/
  town hall meeting and make reasonable attempts to
  accommodate their schedules. It is not necessary that all
  candidates accept the invitation or attend for you to hold
  the event or that the candidates appear on the same day
  or at the same time.
- DO make candidates aware of the issues facing wounded, injured and ill veterans, their families and survivors, either as an individual or as a member/leader of DAV or its subdivision.
- **DON'T** forget to review DAV's national resolutions to ensure your position is in line with—and not contrary to or unsupported by—DAV's adopted resolutions when speaking on behalf of the organization.
- **DON'T** forget that, while DAV provides services to all veterans, our legislative goals focus on the betterment of wartime disabled veterans their families and survivors.

### **DAV National Policies**

- "The corporation [DAV] shall be nonpolitical and nonsectarian, and may not promote the candidacy of an individual seeking public office." Title 36 U.S.C. § 50306.
- Under the law and regulations governing the Internal Revenue Service (Title 26 U.S.C.), the federal tax-exempt status of certain charitable, nonprofit organizations, including DAV, shall be withheld or removed if they: "Participate or intervene, directly or indirectly in any political campaign on behalf or in opposition to any candidate for public office...Activities which constitute participation or intervention in a political campaign in behalf of or in opposition to a candidate include, but are not limited to, the making of oral or written statements on behalf of or in opposition to such a candidate.
- DAV National Constitution, Article II Purpose: "...to advance the interests and work for the betterment of all wounded, gassed, injured and disabled veterans...."
- DAV National Bylaws, Article 2, Section 2.1—Nonpartisanship: The Organization shall be non-political and non-sectarian and the name of this Organization or name of any subdivision thereof shall not be used in representing the desires or wishes of its membership in any political, sectarian or labor dispute, except as provided hereinafter...the forgoing shall not prevent this Organization or any subdivision thereof from participating in political issues which have a direct bearing upon the welfare of America's disabled veterans."
- DAV National Bylaws, Article 2, Section 2.2,—Legislative Activities, Para. 1: No member shall speak in the name of the DAV taking a position contrary to a standing resolution.
- DAV National Bylaws, Article 2, Section 2.2, Para. 2: Federal legislation cannot be sponsored or endorsed without a resolution.

February is "Go Red for Women" – American Heart month. Cardiovascular diseases continue to be Women's greatest health threat. Make a commitment to yourself, to take better care of "YOU". Signs and Symptoms of Heart Attack

If you have any of these signs, call 9-1-1 and get to a hospital right away.

- 1. Uncomfortable pressure, squeezing, fullness or pain in the center of your chest. It lasts more than a few minutes or goes away and comes back.
- Pain or discomfort in one or both arms, the back, neck, jaw or stomach.
- 3. Shortness of breath with or without chest discomfort.
- 4. Other signs such as breaking out in a cold sweat, nausea or lightheadedness.

5. As with men, women's most common heart attack symptom is chest pain or discomfort. But women are somewhat more likely than men to experience some of the other common symptoms, particularly shortness of breath, nausea/vomiting and back or jaw pain.

Please take these symptoms seriously, it can make a difference that can save or end your life.
