

Our day began @ 8:30am, helping to set up the distribution site in the front side parking lot @ MOPC, erecting canopy tents and setting up tables as workstations. Multiple cases of various food items were downloaded, and an assembly line was organized, and all, went to work pre-bagging groceries. The quality and quantity of food was remarkable such as: raisins, walnuts, canned beans, powdered milk, eggs, assorted breads. assorted pastries, cakes & pies, small rolls of ground beef, boxes of cheese, packages of de-boned chicken, fruit, just to name a few.

The event was well attended by local veterans in the drive-thru lines/ID checks were made. The clinic staff took charge of polling veterans about if any had COVID-19 Vaccinations or if any wanted an injection on site or get scheduled on another date.

Staff / volunteers had broken down boxes and discarded trash as the event progressed, so shortly

after all veterans had been served, the reverse process was done with tents and tables taken down.

Again, it was such a pleasure to enjoy this work fellowship. Hoorah!..

### Congressman takes time to honor fallen warriors and reconnects with local military constituents -

On Memorial Day - 2021, a memorial service was held at Sunset Memorial Park, Funeral Home and Crematory to honor the nations fallen heroes from all wars and conflicts. Mr. Robert Byrd, the owner of Sunset Memorial Park, hosted the event for the 15<sup>th</sup> year in a row which featured Congressman Barry Moore (AL-02), Dothan Mayor Mr. Mark Saliba and Afghanistan War veteran Mr. Brian Fleming who was featured as a motivational speaker for the event.

Congressman Moore took to the podium and gave a short prayer in which he gave tribute to the fallen and present-day veterans, both home and abroad. After the ceremonies, Congressman Moore made himself available to mingle and speak with many of his constituents and friends. Present among the attendees were two members of the Dothan Disabled American Veterans (DAV), Commander Daniel Blackman and Senior Vice Commander John Johnston of local Chapter-87.

Both Blackman and Johnston were briefed by Congressman Moore of an upcoming veterance workshop to be held locally on August 24<sup>th</sup> at the Harvest Church (2727 Fortner Street, Dothan, AL) from 8 am. noon. Discussions may include veterance access to critical care, survivorsq benefits, disability benefits and key locations that offer the COVID vaccinations to both veterans and their spouses.

Congressman Moore spoke with Blackman and Johnston about separate issues but emphasized his concerns for future military funding and how important it is for constituents to step up and get involved with their local government. The upcoming workshop will be an % pen forum+type format in which any concerned veterans, including local citizens who never served in the military, can voice their thoughts and suggestions for improvement. The service was concluded with a military flyover and participants placing flowers at the grave site of their chosen fallen hero.







My first item has nothing to do with benefits or government or legislation, but it is to honor Past National Commander Jim Sursely. COVID knows no boundaries when it chooses who to attack and it took Jim from us on May 31. If you knew Jim, you were blessed, as he was one of the finest persons on this earth and was a mentor and inspiration to many thousands of people, veteran, and non-veteran. The State Legislature got busy during their last few days in session and made some forward steps for veterans. On May 14, Governor Ivey announced publicly that the legislatures Task Force on Veteranso Suicide was being combined with the Governors Challenge to Prevent Suicide Among Service Members, Veterans, and Their Families (SMVF). This effort will now be titled Alabamacs Challenge and will receive additional funding from the State Legislature. I proudly serve as a member of that task Force.

On August 1 access to Alabama National Guard facilities, including gas stations and post or base exchange will be expanded to certain veterans, which will include all service-disabled veterans and registered caregivers for those veterans.

Effective June 1 there is an expansion of Alabama National Guard Survivor Benefits. This includes an increase in benefits to the survivors of ANG members. who die as a result of a service-related incident when on state active duty. Changes were also made to allow more access to the G.I. Dependent Scholarship Program.

Changes were also made to expand the eligibility requirements for applicants for the Veteran Service Officer positions throughout the state.

A pilot program has been launched by the VA in order to try to significantly reduce the time to review disability claims decisions. The CARS program (Claims Accuracy Request) will adjudicate claims within 30

days, as opposed to the normal 125 days. The pilot continues through August.

Did you know that the DAV National Headquarters is moving? I did not know it either until I received a letter from Membership saying to destroy all membership materials that had the 3725 Alexandria Pike, Cold Spring, KY on them. They become obsolete in June due to the Headquarters moving to 800 Dolwick Avenue, Erlanger, KY 41018. A membership supplies order form was included with that letter. So, if you have not done that, please get on it. Along with that, a new membership system is supposed to be introduced at the National Convention July 31. August 3 in Tampa. Hopefully, Commanders, Adjutants and SVCs will be able to access the information they need without contacting membership and requesting whatever report or roster they may need. It will sure eliminate a lot of phone calls and e-mails and time spent just making requests or waiting for responses.

On June 17, House Veterans Affairs Committee Chairman Mark Takano introduced his monumental Honoring our Promise to Address Comprehensive Toxics Act of 2021 or the Honoring our PACT Act to the Committee. This act will be an even more detailed act concerning all possible exposures to any toxic materials and will also add more presumptive diseases to the existing lists.

On June 23, National Legislative Director Joy Ilem testified before the Senate Veterans Affairs Committee on 23 different pieces of legislation that DAV is supporting. https://www.veterans.senate.gov/hearings/hearing-on-pending-legislation-6-23-2021 to view that testimony.



H.R. 845, the VA Billing Accountability Act is currently before Congress, and it would eliminate veterans being punished monetarily for errors made by the VA. The DAV supports this legislation and even hopes that the end result is the elimination of co-pay by serviceconnected disabled veterans.

Senate Bill 1664, introduced by SEN Amy Klobuchar, has been sent to the Committee on Veterans Affairs. This is a very significant bill as it proposes to significantly reduce the time for the resolution and decision on PTSC disability claims. How many of us would that affect? Many, I am sure.

HR 1282, the Major Richard Star Act provides that combat-disabled uniformed services retirees with fewer than 20 years of creditable service may concurrently receive, without reduction, veterans' disability compensation and retired pay or combatrelated special compensation. This was introduced in the House in February and did not make it to the Subcommittee on Disability Assistance until April. Thats the last that was done on it.

If you are not a member of the Commanders Action Network, please go to the DAV National website and join. There you will find DAV | Commander's Action Network (quorum.us) which will list all of the bills and

resolutions that are currently before the House and the Senate. I cannot cover all the legislation that is pending or has passed, but you can follow them here. After you peruse that list, you will wonder what our legislators in Washington are doing or have been doing during the last year and a half. Bills Pending US Congress Senate Veterans' Affairs Committee | LegiScan will take you to an overall list of what is in the Senate. It will really open your


