The Fort Rucker Thrift Store gave the chapter a grant for \$841 to help the chapter pay for the expenses incurred by sending individuals to Montgomery to participate in the mandatory training.

As the Doc Sees It

A Perspective on PTSD--Part II

As I stated in the previous article on PTSD, PTSD is the only behavioral problem that, when significant enough to be diagnosed, is not considered to be abnormal behavior. PTSD is a normal reaction to a life incident or event(s) which human beings are not expected to encounter during his or her normal life span.

In order to be diagnosed with PTSD, first the person must be exposed on some way to an event or events that involved actual death, threaten death, injury, OR a threat to the physical integrity of his or her self OR others. Second, the individual's response to the event or events at some point at the time of the incident or in the future after the incident involved intense fear, horror, and/or hopelessness.

Furthermore, the individual has to show a minimum of six (6) behaviors out of seventeen (17) within three subsets:

- A. The incident is experienced at present in at least one (1) of the five (5) ways:
 - 1) recurrent and intrusive distressing recollections of the event;
 - 2) recurrent distressing dreams of the event;
 - 3) acting or feeling like the event is recurring;
 - 4) intense distress at exposure to anything that remains the individual of the event;
 - 5) physiological reactivity at exposure to anything that remains the individual of the
- B. Persistent avoidance of anything associated with the event and numbing of emotions as a result of the event is present in a least three (3) of seven (7) ways:
 - 1) trying to avoid thoughts, feelings, or conversations related to the event;
 - 2) trying to avoid activities, places, people related to the event;
 - 3) inability to recall an important part of the event; 4). markedly lack of interest in or participation in significant life activities;
 - 5). feeling detached from others or from life in general; 6). unable to feel normal feelings such as being unable to have love feelings;
 - 7). sense of a foreshortened future.
- C. Persistent feelings of increased arousal is present in as least two (2) of the five (5) ways: difficulty falling and/or staying asleep; irritability or outbursts of angry; concentration problems; hypervigilance; and, exaggerated startle response.

There are a significant number of related disorders and symptoms either associated with or secondary to PTSD. These can be stand-alone issues with PTSD, or a combination of all of these can be determined to influence PTSD: Obvious symptoms secondary to PTSD include the following: adjustment disorders; alcohol related disorders; avoidant, antisocial, borderline, paranoid, obessive-compulsive personality disorders; bipolar disorder; brief reactive psychosis; bulimia; delusional disorder; chronic depression; disruptive behavioral disorders; generalized anxiety disorder; induced mood disorder; hypochondrias; impulse control disorder; intermittent explosive disorder; major depression; nightmare disorder; panic disorder; primary insomnia or hypersomnia; schizoaffective disorder; schizophrenia; shared - psychotic disorder; sleep terror disorder; sleep walking disorder; social phobia. Subtle symptoms associated with PTSD include the following: Agitation night-terrors, hyper-vigilance; scanning, avoidance, flight/fight, numbing, flashbacks, reliving experiences, loss of pleasure in things once enjoyed; hallucinations, illogical thinking, intrusive thoughts, poor concentration, irritability, anger, startled responses. Other symptoms include the following: survivor guilt; suicidal ideation; homicidal ideation; unrealized poor self-esteem; poor hygiene; thoughts of superiority; invincibility; reoccurring roles pertaining to power; irrational rationalizing; lone warrior syndrome (won the war alone), and over-exaggeration of deeds and event.

Today there is help available to those who have developed PTSD as result of involvement in an event or series of events causing emotional trauma. Veterans can participate in various activities available through VA. In addition, there are trained individuals within the local civilian health care system who are available to try to be of assistance. Anyone who is bothered by any combination of the main 17 symptoms is encouraged to seek assistance in a timely manner.






















This Month's Q&A for the Sage

Sometimes you come up with a great idea for a fundraiser and don't know if you can do it or not. When this happens you first need to make sure your commander knows about the proposed money making opportunity. Next you need to know how much money you might make. Lastly you need to ensure it passes the test of being in line with the National, State and Chapter Constitution and ByLaws which are available online or in the chapter reading file.

Anything inside or outside of your chapter's area needs to be approved by the department. A simple call to the Department Adjutant and you might be allowed to conduct the fundraiser.

> If you are anticipating a gain of >\$5000.00 during this opportunity the fundraiser needs approval of the Department Ways and Means committee. Don't sign a contract before approval.

Do not misrepresent the DAV at an unapproved or approved fundraiser.
