CHAPLAINS NOTES

We, as Disabled American Veterans, like everyone else, must march to the seasons. Summer is now in the air and we are putting long-sleeved blouses and shirts away and tucking our heavy coats and gloves into closets. Flowers are blooming and even the birds are chirping away happily in leaf-filled trees. A new season is upon us and I for one am ready.

The summer months are truly a great time of the year. Family "stuff" is the best. Reunions and picnics offer fun events and a chance to get in touch and to get closer to family and friends. This is especially true with our DAV family when we gather in Montgomery in June for Convention. Here we will meet with friends that make up our DAV family. We will catch up on news. We get to brag about how well our Chapters are doing and complain about those people who make our lives, too interesting. Conventions are fun and are an important part of our DAV mission.

For those of you who are concerned about returning vets from Afghanistan and Iraq, I would ask you to consider attending the Convention this year. It will start on Friday June 6th and continue through Sunday June 8th. Information shared by the VA and other chapters and districts are important. Did you know that the VA has established five polytrauma centers across the country that are funded and set up to handle our brother and sister vets who have been injured while in service. They include traumatic brain injury Traumatic brain injury (TBI), traumatic injuries to the brain, also called intracranial injury, or simply head injury, occur when a sudden trauma causes brain damage. TBI can result from a closed head injury or a penetrating head injury and is one of two subsets of acquired brain, spinal cord injury Approximately 10,000 new spinal cord injuries (SCIs) occur each year in the United States. , blind rehabilitation and post-traumatic stress disorder (PTSD). PTSD is a disorder that occurs among survivors of severe environmental stress such as a tornado, an airplane crash, or military combat operations. Symptoms include anxiety, insomnia, flashbacks, and nightmares. . I did not know this information until I sat through a briefing at last year's convention.

Hello comrades!

Women have served on the battlefields in every major conflict in which the United States of America has participated even before the revolution. It wasn't long ago, considering, that women were finally recognized as and given a place in the ranks as soldiers.

Judith A. Bellafaire wrote a pamphlet titled *The Women's Army Corps: A Commemoration of World War II Service.* I have included a brief excerpt from the pamphlet and a hyperlink for you to read the rest of the article.

The Women's Army Corps in World War II

Over 150,000 American women served in the Women's Army Corps (WAC) during World War II. Members of the WAC were the first women other than nurses to serve within the ranks of the United States Army. Both the Army and the American

public initially had difficulty accepting the concept of women in uniform. However, political and military leaders, faced with fighting a two-front war and supplying men and materiel for that war while continuing to send lend-lease material to the Allies, realized that women could supply the additional resources so desperately needed in the military and industrial sectors. Given the opportunity to make a major contribution to the national war effort, women seized it. By the end of the war their contributions would be widely heralded.
