Chapter 18's Veterans' Spotlight

Comrade Enochs was born in Terre Haute, Indiana. He lived there until he was drafted into the U.S. Army in 1944. His induction center was Camp Atteberry, Indiana. He was then transferred to Camp Wheeler, Georgia for 16 weeks of Infantry Basic Training. His next assignment was to Fort McClellan, Alabama where he became a Military Policeman (MP) and his outfit was assigned the duty of guarding 1,200 German Prisoners of War (POWs). Murphy's oufit also escorted POWs to various points on and off post to work, on post examples would be the bakery, mess halls, etc., and off post examples would be farms. The average work detail would consist of from five (5) to 20 POWs with one (1) MP guard. At the end of World War II he and his outfit took the 1,200 German POWs to Camp Kilmer, New Jersey for subsequent travel back to their homeland of Germany. Camp Kilmer is where Murphy was discharged. He served a total of two (2) years and three (3) months in the Army. He came back to Alabama in 1950 and enrolled in the Alabama School of Trades, it lasted two (2) years. Then he secured a civil service job at the Gadsden Air Force Depot, sometime later he transferred to Brookley Air Force Base at Mobile, Alabama. The next move was to Redstone Arsenal at Huntsville, Alabama. Comrade Enochs used to like to hunt and fish and do mechanic work. Currently he visits the Arab Senior Center daily.

Encourage the President to Support the Omnibus Appropriations Act

January 3, 2008

We want to thank you for your assistance in support of the Omnibus Appropriations Act for Fiscal Year 2008 by the many responses you sent to your respective members of Congress, followed by communication to the President. As you know, House and the Senate passed the appropriations bill, and forwarded the bill to the president wherein he has until January 18, 2008, to request \$3.7 billion as emergency funding. He has signed the appropriations bill, but as of this date, he has not signed the emergency designation.

Therefore, we once again ask that you contact the President and urge his support of the needed \$3.7 billion increase in emergency funding for the Department of Veterans Affairs. This total budgetary increase would equal \$6.6 billion more than last year.

Without the proposed \$3.7 billion in increased funding, the VA would most likely fail once again

to meet the challenge imposed upon it by the ongoing wars in Afghanistan and Iraq. This proposed funding comes at a time when the VA is desperately struggling to solve problems ranging from reducing the alarming spike in veteran suicides, treatment for complex traumatic brain injuries, rising rates of post-traumatic stress disorder among veterans of the ongoing wars, an evergrowing, seemingly unstoppable, disability claims' backlog and homelessness among the nation's newest generation of veterans.

Whatever the name of this bill maybe there are a host of benefits for the active military, veterans, and their families, I will mention two: (a) first it should allow Chapter 61 (Medically Retired) military retirees to participate in the Combat Related Special Compensation program with no limit in years served, and (b) Individual Unemployability 100% VA disabled retirees should be eligible for 100% concurrent receipt. These should be effective from January 1, 2005.

Please contact the President immediately by telephone or email and urge him to sign and request the emergency funding contained in the Omnibus Appropriations Act for Fiscal Year 2008. If you prefer, you may visit the DAV website, www.dav.org, to send a prepared email to the President.

As always, we greatly appreciate your efforts on behalf of our nation's disabled veterans.

Disability Claims – VA has fallen further behind with its backlog this year according to a recent VA briefing to Congress. This continues to pose a true problem for many disabled veterans and their families by delaying decisions and pensions for disability claims. This is VA's third year in a row to have this occur. On average 183 days were required to process a claim in fiscal 2007, which exceeded the 2007 goal of 160 days and its long-term goal of eventually reducing processing time to 125 days. During this time the backlog of pending claims rose from 377,681 to 391,257. The VA is now hiring more than 1,000 workers, boosting overtime and revamping training to attack this continuing problem. The problem continues to be exacerbating by the escalating number of disability claims that continue to exceed those anticipated by VA. As a positive note, VA reports that 95 percent or

Shingles – Let's look at this again, it is near painless and I trust a great safeguard against much suffering. The new shingles vaccine is a now a TRICARE and Medicare (Part D) covered vaccine. Shingles is a painful viral disease that affects more than I million Americans every year. More than half of those cases happen to people age 60 or older. The CDC recommends a single dose of shingles vaccine for everyone within this age range. In a VA study the drug Zostavax was more than 50 percent effective in reducing the incidence of shingles and more than 60 percent effective in reducing some of its associated symptoms. Even in people who suffer from the disease, most of those who were vaccinated experienced less pain. Shingles is caused by the varicella-zoster virus, the same virus that causes chickenpox in children. It remains in the body for decades, sleeping in nerve cells along the spinal column. A shingles rash usually appears on one side of the face or body and lasts between two and four weeks. It is painful and can be accompanied by fever, headache, chills and upset stomach.
