New Housing Bill has Vet Provisions: The housing and economic recovery legislation that was recently signed into law (PL 110-289) includes several VFW-supported provisions designed to safeguard service members and veterans during the mortgage and foreclosure crisis.

Some of the provisions in the bill will:

**Prohibit foreclosure of service members property for at least nine months following deployment.

**Increase the amount of VA's Home loan guarantee program.

**Authorize VA to provide assistance for specially adapted housing to active-duty members with certain service-connected disabilities.

**Allows individuals with severe burn injuries to be eligible for specially adapted housing assistance.

**Extend through December 31, 2011, the period of assistance for individuals residing temporarily in housing owned by a family member.

I am grateful to those of you that attend our meetings regularly or as often as you are able. This summer, attendance has been down because of illnesses, family obligations and vacations. Low attendance has prevented us from doing some things we talked about doing. Our bylaws require us to vote on issues like fundraising events and service projects and require a quorum of at least 5 members at a meeting for voting to occur.

If we can't vote, we can't spend money on service. If we can't spend money on service we don't need fund raising events. The only way out of this unproductive circle is to recruit more members and inspire current inactive members to attend meetings. If you know men or women that qualify for Auxiliary membership, please invite them to join us. If you are an inactive member that needs transportation to the meetings, call me.

Food and Beverage Table

I am thankful to those members that bring food to our snack table which we started because Auxiliary Units all over Alabama seem to provide meals for their Chapter members. Having food available before/during or after the meeting was expected to draw new members and retain existing members that don't have time for a meal during the commute between their work location and the DAV meeting location (and be on time for the 6 PM roll call).

Chapter 18 functioned well for a long time without food being offered at meetings. As a result, many Chapter members are in the habit of eating at home or at a restaurant before coming to the 6 PM meeting. Some Chapter members have special dietary requirements that are contrary to what we are offering at our snack table. Other Chapter members appreciate the fact that meetings start at 6 PM and end an hour latter allowing them to return home early. As a result, some members eat and some don't. The Auxiliary would appreciate feedback from Chapter members on the food and beverage offerings. Would you like to see this practice continue? And if so, what can we improve upon?

Community Service

Several Auxiliary and Chapter members represented our organization at the Moving Wall while it was in Guntersville July 10-14. During the closing ceremony, the volunteer coordinator publically extended his appreciation to the Arab Disabled American Veterans for their hours of volunteer service. None of you heard him speak, but you know who you are and you know that volunteering is rewarding in ways that are not always seen but can be felt by you and by those you come in contact with.

Legislative Activity

During the June meeting, Auxiliary members discussed the importance of the Veterans Disability Claims Modernization Act (HR 5892) and learned about the Stand Up For Veteran website as a means of communicating the DAV position to our elected representatives.

At the August meeting we discussed how Mandatory VA Health Care Funding (HR 2514 and S 2639) legislation would improve delivery of healthcare benefits to veterans. Each Auxiliary member took home letters to sign and mail to: Representative Aderholt, Senator Sessions, and Senator Shelby on these important issues. Members also took home letters to sign and mail encouraging their representatives to support and vote in favor of the Military Construction Veterans Affairs and Related Agencies Appropriations Act 2009 (HR 6599) and Fiscal Year 2009 Defense Authorization Bill (S 3001) as well as a "thank you" letter to Representative Aderholt for his support of the Veterans Disability Claims Modernization Act (HR 5892). Prepared letters and stamped, pre-addressed envelops were mailed to other active members that were absent from the meeting so they could also communicate the DAV position on these legislative issues.

So far, everyone who signed and mailed these letters received written responses back from Representative Aderholt, Senator Sessions and Senator Shelby. In total, Auxiliary members signed a total of forty eight letters in one month! Our costs were minimal and the potential benefits will be monumental if these pieces of legislation are approved.

A Recurring Topic

During the course of the last four or five Auxiliary meetings, the subject of widows has come up. Arab Chapter 18 has widows that we are worried about because they are absent from us. If your deceased husband was a member of Arab Chapter 18, we are here for you and your family. Keep our names and numbers handy.

LEGISLATIVE AFFAIRS

Social Security Special Extra Earnings for Military Service: Since 1957, if you had military service earnings for active duty (including active duty for training), you paid Social Security taxes on those earnings. Since 1988, inactive duty service in the Armed Forces reserves (such as weekend drills) has also been covered by Social Security.

Under certain circumstances, special extra earnings for your military service from 1957 through 2001 can be credited to your record for Social Security purposes. These extra earnings credits may help you qualify for Social Security or increase the amount of your Social Security benefit.

Special extra earnings credits are granted for periods of active duty or active duty for training. Special extra earnings credits are **not** granted for inactive duty training.

If your active military service occurred

From 1957 through 1967, we will add the extra credits to your record when you apply for Social Security benefits.

From 1968 through 2001, you do not need to do anything to receive these extra credits. The credits were automatically added to your record.

After 2001, there are no special extra earnings credits for military service.

How You Get Credit for Special Extra Earnings

The information that follows applies **only** to active duty military service earnings from 1957 through 2001. Here's how the special **extra** earnings are credited on your record:

Service in 1957 Through 1977, you are credited with \$300 in additional earnings for each calendar quarter in which you received active duty basic pay.

Service in 1978 through 2001, **for every \$300 in active duty basic pay, you are credited with an additional \$100 in earnings up to a maximum of \$1,200 a year. If you enlisted after September 7, 1980, and didn't complete at least 24 months of active duty or your full tour, you may not be able to receive the additional earnings. Check with Social Security for details.**

Online Filing of VA Claims: VA is now accepting online applications from veterans, survivors, and other claimants filing initial applications for disabilities, education, and vocational rehabilitation / employment benefits without signature. Submission may be made at the [Veterans Online Applications \(VONAPP\) Web site](#). Normal rules of evidence still apply. More information is available at www.va.gov or call (800) 827-1000.
