All the vans have been acquired by donations from the general public and we are proud to announce we have purchased a new 12 passenger van for our Veterans and Caregivers providing a total of three vans for the two chapters. No Government funds are provided for the purchase of these medical transportation vehicles.

The Henry County Veterans van will arrive on Monday and Fridays for transportation to the Tuskegee VA hospital and the Chantilly VA Clinic and Perry Hill Road Hospital in Montgomery, Alabama. It arrives at 5:30 am at the SunStop on Hwy 431 north Headland for boarding. All passengers will be returned at the end of the day to the SunStop in Headland. Please arrive 10 minutes early. You may wait inside for the vans' arrivals. Reservations are recommended due to limited seating capacity. All Patients must be ambulatory as we have no wheelchair accommodations.

The Fort Novosel VA Clinic van will arrive at 7:20 am at the SunStop on Tuesdays and Wednesdays and also will return at the end of the day to the SunStop in Headland.

All Veterans boarding for Fort Novosel should have at least their VA ID Cards and their caregivers should also have their VA and Post Passes with them. If not you will have to have at least two forms of ID acceptable to the Fort Novosel Visitors Center or will be rejected and returned to the McDonalds in Ozark while the van proceeds back to the Fort's VA Clinic and will return to McDonalds to pick up anyone who had been rejected for admission to the Fort Novosel VA Clinic for the return trip back to Headland SunStop at the end of the day.
