## Meet Our Future Leaders

## Foundation Holds Graduation Ceremonies

If there was ever any doubt that our community is filled with dedicated and strong individuals who would be willing and able to take on the role as area future leaders, then let us introduce you to the graduating 2023 Youth Leadership Dothan-Houston County and Leadership Dothan classes.

Forty-three high school juniors from eight area schools in Houston County graduated from Youth Leadership Dothan-Houston County Class 31. Held May 17 at Wiregrass Rehabilitation Center Inc's Sterling Event Services Rotary Hall, the guest speaker was Mayor Jesse Nelson, city of Lynn Haven, Florida, and a Youth Leadership Alumni. McKinley Watford from Dothan High School also provided attendees with an overview of the year's high from visiting the Wiregrass Safety Center during Public Safety Day to reading to students at Dothan City Schools Head Start Center during Education Day.

The Leadership Dothan's Class 41 had 40 graduates and held its graduation ceremony June 8, at the Dothan Area Botanical Gardens. During the evening event, course highlights were provided by class leaders Jared Cannon, Southern Nuclear Operations Co./Plant Farley. Closing remarks were given by Betsey Marshall, Leadership Dothan Steering Committee chair and Towne Place Suites.

Both leadership programs are operated through the Dothan Area Chamber Foundation and serve as important leadership resources to this area. These programs not only help raise a participant's awareness of the local issues and increase their understanding of different perspectives, but also help to encourage the individual to become involved in solving the challenges facing their community. Youth Leadership Dothan-Houston County is a seven-month training program that prepares high school juniors for leadership, involvement and participation in the future of the Wiregrass region. The program's goal is to interest students in civic and volunteer activities, encourage them to recognize their potential and assist them in identifying their special skills and talents.

Leadership Dothan is a nine-month program that focuses on community resources, education, local and state government, health care, public safety, agricultural and quality of life.

Each year, both classes are required to complete a community service project or fundraising effort to enhance the community. For their service project, Youth Leadership selected two community projects: volunteered at Landmark Park and at the 2023 Dothan Adolescent Community Youth Advisory Council's Feel Good Field Day.

Leadership Dothan's community service project was a Bags and Brews Cornhole Tournament held in downtown Dothan's Porter Park. Approximately 32 teams participated in the tournament, which raised over

\$16,030. The funds were donated to five nonprofit organizations: The Exchange Center for Child Abuse Prevent, Girls Inc. of Dothan, Wiregrass Angel House, Wiregrass Habitat for Humanity and Wiregrass 2-1-1.

## Dothan Continues To Offer Low Cost Of Living In US ACCRA Cost of Living Index First Quarter 2023

Among the 271 urban areas that participated in the first quarter 2023 Cost of Living Index, the Dothan area is in the top 25 percent for lowest cost areas in the United States. Published quarterly by The Council of Community and Economic Research, the Dothan Area Chamber of Commerce participates in this study periodically.

The Dothan area came out with an overall cost index of 89.3, which represents 10.7 percent below the national average of 100 percent. To put this in perspective, Manhattan, New York, had an overall index of 222 and when compared to Dothan, it is more than two times the cost to live there than in Dothan.

"The Cost of Living Index is important research for our economic and community development efforts as it provides timely and comparable information to business prospects and persons moving or considering moving into the area. It is also important to note that this quarter's report indicated the Dothan area was the lowest cost area in Alabama to purchase a can of peaches, get a tire rotation and total overall energy costs for utilities. Our area continues to shine by providing low costs in housing, health care and utilities," said Colton Cureton, DACC's vice president of economic development.

The COLI measures regional differences in cost of consumer goods and services, excluding taxes and non-consumer expenditures, for professional and managerial households in the top income quintile. Covering 61 different items, prices are collected quarterly by chambers of commerce, economic development organizations and university applied economic centers in each participating urban area. The composite index is based on six component categories – housing, utilities, grocery items, transportation, health care, and miscellaneous goods and services.

## All In Credit Union To Acquire SunSouth Bank

All In Credit Union announced recently that it has entered into an agreement to acquire SunSouth Bank, the banking subsidiary of SunSouth Bancshares Inc. The transaction will be structured as a purchase and assumption transaction, and the consideration will be all-cash.

Founded in 1954 and rebranded in 2002, SunSouth Bank is a fullservice community bank with total assets of nearly \$115 million providing localized service to clients in its Wiregrass markets. Upon completion of the transaction, All In will have total assets of approximately \$3 billion and 33 locations across southern Alabama and the Florida Panhandle.

"We are delighted at the combination of these two institutions. Southeastern Alabama is our home base and we are excited to expand our presence in this part of our footprint. We look forward to welcoming SunSouth's employees and customers to the All In family," commented Bobby Michael, All In president and CEO.

The transaction, which has been unanimously approved by the Board of Directors of both institutions but remains subject to customary conditions including the approval of SunSouth Bancshares Inc.'s shareholders and the receipt of required regulatory approvals, is expected to close no later than the first quarter of 2024.



In May 2023, the Wiregrass Museum of Art reached 2,189 people, with an approximate economic impact of \$66,275.26 from visitor spending. Total economic impact since October is \$1,100,960.44. Visitors came from Alabama, Arizona, California, Florida, Georgia, Michigan, Mississippi, Nevada, North Carolina, Pennsylvania, Texas and Mexico.

WMA tracks visitor zip codes and number of overnight stays. Spending shown is calculated using average spending for overnight and daytrip visitors, by party, as defined by Visit Dothan's Visitor Profile Research. This economic impact is only an estimation of monthly visitor spending, not a comprehensive look at WMA's complete economic impact, which would include total expenditures, full-time jobs, household income, and local and state government revenue.



## **Dothan City Schools Finishes Strong In Science Fair Competitions**

\* Any book valued at \$30 or less


