#### **Report and Prevent VA Benefit Scams**

Scammers are targeting Veterans and their VA benefits through misleading commercials, emails, texts, cold calls, or online ads. Some may even pose as someone from VA or an organization providing discounts on fees for services. But VA **never** charges you for processing a claim. Keep your benefits safe from fraudsters by knowing what to look out for and reporting fraudulent activity to <a href="mailto:vaoighotline@va.gov">vaoighotline@va.gov</a> or call **1-800-488-8244.**

# Can Someone PLEASE Explain this to me?

The Department of Florida has <u>51</u> chapters but only <u>20</u> chapters that report LVAP hours each month to the department.

LVAP (Local Veterans Assistance Program) is a critical and an integral part of everything we do as DAV chapters. I would think that it would be virtually impossible for a chapter to exist without accruing LVAP hours.

The only chapters that <u>ARE REPORTING LVAP</u> hours are: 1, 4, 11, 16, 18, 22, 38, 42, 49, 82, 83, 84, 85, 86, 94, 108, 109, 123, 133, and 150.

Is this because 31 of our chapters have no activities (including monthly meetings) that would qualify as LVAP hours? Is it because no one in any of these chapters provides any assistance to fellow veterans within their respective communities? Is it because these chapters do no fund-raising activity? Is it because these chapters do no service officer work? Is it possible that these 31 chapters have no members that take the time to visit sick or homebound veterans or members?

<u>Or could it be</u> that the officers and members of these chapters simply do not know what LVAP is or how important it is to the overall success of our organization?

#### WHY are reporting LVAP hours so important?

Because we are an organization that is chartered by congress to provide specific services to our fellow veterans. We must report these services, including the volunteer hours donated through LVAP to Congress, watchdog groups, members, and donors to maintain our position, respect, and influence with all these stakeholders. Every hour that we report strengthens our organization and amplifies our ability to serve our fellow veterans. The stronger we are the more we can do to serve.

Recently about 25 of us earned over 40 LVAP Hours each by attending our Mid-Winter Conference in Arlington, VA.

The Local Veterans Assistance Program (LVAP) was established in 2007 to facilitate and recognize initiatives in which volunteers can contribute their skills, talents, professional abilities, and time in ways that benefit veterans residing within their local communities.

The program empowers individuals to find and develop new and unique ways to support veterans and their families by providing resources, assistance or help with everyday needs. LVAP initiatives are carried out through departments, chapters, auxiliary units, associated organizations, corporations, and individuals. Since the inception of the program, 57,513 volunteers have donated nearly 11.5 million hours to veterans residing in their local communities.

LVAP Volunteers can dedicate their time in the following ways:

- Chapter and Department Service Officer work.
- DAV Specific outreach efforts.
- Fundraising efforts. DAV/DAVA Special Events (State Fair, Homeless Assistance including Stand Downs, Etc.)
- Direct assistance to veterans, surviving spouses, or families.
- Seminars, Training, and Activities designed to Operate Chapter / Department smoothly.
- Grassroots Legislation.

I believe that every chapter in the department is performing many, if not all, of the above functions. The problem is that the hours are not being reported to the department monthly as required. This is a serious problem with such a simple solution – just report your hours each month.

<u>Membership Report – End of February 2023:</u> Ten (10) chapters have achieved membership quota. The department is at 98.75%

We have 12 Chapters that have met or exceeded their goal 1; 13; 18; 29; 30; 57; 73; 82; 83; 101; 109; 123. Congratulations to those listed above.

Four (4) months left in the membership year – ending June 30<sup>th</sup>.



## DEPARTMENT JUNIOR VICE COMMANDER CHIP HANSON



This month I am going to pass along information about our National Cemeteries.

ALL Veterans with an honorable discharge are eligible to be interned in any National Cemetery. No one can reserve a spot in any National Cemetery. The exception Is if both Spouses are Veterans, and one dies the remaining Spouse can reserve the spot next to the deceased.

Burial benefits available include a gravesite in any of our National Cemeteries with available space, opening, and closing of the grave, perpetual care, a Government headstone or marker, a burial flag with Military Honors from their Branch of the Military, and a Presidential Memorial Certificate, at no cost to the family. Some Veterans may also be eligible for Burial Allowance.

Burial benefits available for spouses and dependents buried in a national cemetery include burial with the Veteran, perpetual care, and the spouse or dependents' name and date of birth and death will be inscribed on the Veteran's headstone, at no cost to the family. Eligible spouses and dependents may be buried, even if they predecease the Veteran.

Cremated remains represent about 75% of interments in National Cemeteries, they receive the same honors as casketed remains. However, with cremated remains, there are 4 separate ways of interment. They can be buried in the same manner as a casket, with the same headstone as a standard casket grave, the cremated remains can also be placed in the columbarium,(a wall with areas for the urns)or the ashes can be placed in the Ossuary( a common grave in a Memorial Garden) and the name placed on the Memorial Wall. If the Family chooses to spread the ashes in a manner that cannot be visited(such as spreading them around in the Ocean or a meadow or other ways the Veteran wanted to interned), the name of the Veteran can be placed on the Memorial Wall. The Ossuary and the Memorial Wall are available in National Cemeteries completed after 2007.

There is never a charge for any interment at a National Cemetery or the Memorial Wall.

# John Markiewicz Department Judge Advocate

Some information and guidelines for our Chapters.

#### **APPROVAL**

When a Constitution and Bylaws, or amendments thereto, have been adopted, they must be forwarded immediately, in triplicate, to the State Department for approval by the Department Judge Advocate and signed by both the Chapter Commander and the Chapter Adjutant. Following that, the document will be forwarded to National Headquarters for approval by the National Judge Advocate. Until the National Judge Advocate has affixed his/her approval, the document is neither effective nor binding. In drafting a Constitution and Bylaws, you should refer to the Department's Constitution and Bylaws and the National Constitution and Bylaws to avoid any conflict in content. You are strongly encouraged to utilize the Model Chapter Constitution and Bylaws provided on the National Website at:

https://www.dav.org/wp-content/uploads/Model Chapter Const Bylaws.pdf

You can copy and paste this link onto your computer browser. The closer you adhere to this Model the greater the likelihood of quick approval. Specific times dates and locations of meetings should be documented in your Chapter Standard Operating Procedures (SOP) that can be changed without further approval and effective immediately locally by vote of membership and should then be referred to in your Constitution and Bylaws indicating "as specified in the Chapter SOP". This will allow you to make changes to meeting dates and times without having to revise your Constitution and Bylaws every time you do so and without having to delay until you get Department and National approval of the revised date/time.

#### **INCORPORATION**

Chapters may wish to incorporate under their respective state laws as a non-profit corporation. Articles of Incorporation must follow the guidelines and contain the provisions as set forth in Article 17 of the National Bylaws.

Furthermore, the Articles of Incorporation must be approved by the respective DAV Department Judge Advocate and the National Judge Advocate prior to filing the document with the proper state corporation authorities.

#### REFERENCE GUIDELINES

It is suggested that every Chapter should make and maintain current copies of the National Constitution and Bylaws, the Department Constitution and Bylaws and have available for ready reference a current copy of Robert's Rules of Order, Revised. These documents, if followed judiciously, should eliminate misunderstanding and internal disputes within the Chapter. These three copies of Constitution & Bylaws were placed on a flash drive and provided to those chapters in attendance at our January Mid-Winter Conference and will be provided to all other chapters who attend the scheduled Department Officer Training in their Area.

#### Senate Bill S 10 VA Careers Act of 2023

Sen. Jon Tester (Mont.), Chairman of the Senate Veterans' Affairs Committee and Sen. John Boozman (Ark.) introduced S. 10—the VA CAREERS Act of 2023, legislation to bolster efforts to recruit and retain strong clinical and managerial leadership in the Department of Veterans Affairs (VA) health care system and make other important improvements to attract clinicians in scarce medical specialties.

In the wake of COVID-19, physicians, nurses and other clinical and administrative executives are in short supply throughout the health care industry. In addition, the Veterans Health Administration (VHA) has been hampered with salary caps which prohibit them from effectively recruiting and retaining critical health care professionals in their local markets. In addition to modification of pay limitations for specialty medical positions and increasing pay caps for certain leadership positions in VHA, the bill would allow VA to pay for licensure costs for recipients of VA scholarship programs; require additional staff training on care models for managing older veterans' health care needs; expand leave options for clinicians during national emergencies; provide reimbursement for continuing medical education costs for certain employees; and modernize VA's human resources program.

DAV supports the VA *CAREERS Act* of 2023, in accordance with DAV Resolution No. 056, which urges our support of efforts to recruit and retain a robust VA clinical workforce. We commend Senators Tester and Boozman for their bipartisan leadership in ensuring the VA health system can remain competitive with the private sector in attracting and retaining health care professionals who are able to provide the highest quality care to our nation's veterans.

#### S. 42 – the BUILD for Veterans Act of 2023

Sen. Jon Tester, Chairman of the Senate Veterans' Affairs Committee, recently introduced S. 42, the Build, Utilize, Invest, Learn and Deliver (BUILD) for Veterans Act of 2023, which would improve staffing to manage construction of VA assets and ensure that there are concrete plans to improve planning, management, and budgeting for construction and capital asset programs at the Department of Veterans Affairs (VA).

The legislation would also ensure VA completed climate resilience surveys for all of its facilities and projected needs for capital assets into the future. Importantly, the bill would assure that VA's infrastructure planning considers the needs of women veterans and veterans' needs for dental and long-term care services.

With the growing number of veterans expected to enter the VA health care system in the coming decades, it has become increasingly imperative that Congress take the lead in strengthening VA's health care infrastructure, and S. 42—the *BUILD for Veterans Act* is a critical first step toward achieving that goal.

VA increases maximum life insurance coverage for Veterans and service members by \$100,000

**WASHINGTON** — Beginning March 1, VA is increasing the maximum amount of life insurance coverage available to Veterans and service members from \$400,000 to \$500,000 for Veterans' Group Life Insurance

(VGLI) and Servicemembers Group Life Insurance (SGLI).

This increase in coverage reflects the current cost of living and helps ensure that the families of Veterans and service members will have the financial support they deserve after their loved ones pass away.

Veterans who are under age 60 and currently enrolled in VGLI will be able to purchase additional coverage in \$25,000 increments up to \$500,000. All active duty, guard, and reserve service members eligible for SGLI will automatically receive the increased coverage on March 1.

#### West Virginia State

# Senate passes bill allowing veterans and retired law enforcement officers to protect schools

A bill that would allow honorably discharged veterans, retired state troopers, deputy sheriffs, and federal law enforcement officers to protect West Virginia schools has passed in the Senate.

Senate Bill 282, introduced by Senator Eric Tarr (R-Putnam), would establish the West Virginia Guardian Program. The program would allow county boards of education to contract with honorably discharged veterans, retired state troopers, retired deputy sheriffs, or retired federal law enforcement officers to provide West Virginia Guardian Services.

The purpose of the contract is to provide public safety, and or security on public school grounds and buildings.

According to the bill, public safety or security means the protection of students, faculty, and staff of a public school from violence, bullying, theft, substance abuse, sale or use of illegal substances, exposure to weapons, and threats on school grounds. The "Guardian" may carry a concealed weapon upon meeting all requirements. Guardians will not act as law enforcement and will not have the authority to perform an arrest. Senator Tarr says that this bill will not mandate county boards of education to hire "West Virginia Guardians."


"It is permissive by counties, no county has to participate in this," Tarr said. "If they want to run a levy to do this, they can run a levy and do this in their schools, if they wanted safer schools in their county," Tarr explained. Potential Guardians must provide proof of current U.S. and West Virginia residency, possess a high school diploma or GED, hold a concealed carry permit, and pass the law enforcement professional standards program at the West Virginia State Police Academy.

Ensuring the <u>Department of Veterans Affairs</u> does not get overwhelmed by the influx of new patients and claims coming from the sweeping toxic exposure law passed last year will be a priority of the new House Veterans Affairs Committee chairman, the lawmaker told Military.com in an interview.

Rep. Mike Bost, R-III., said he sees no signs yet that the VA is being overwhelmed, noting that the law, known as the <u>PACT Act</u>, also gave the department the funding and flexibility to hire more claims processors and medical staff. But he added that it will be important for Congress to stay on top of the issue as the implementation progresses.

"That's 3.5 million-plus new people receiving services. That's a lot of people on a system that's already a big system," Bost said "We got to make sure that we're ready to roll and no one loses out on what they're already receiving. "The department began accepting benefits claims shortly after the law was enacted and processing them at the start of January.

As of Tuesday, the VA had received 278,000 PACT Act claims and processed 39,250, approving nearly 85% of them, VA Secretary Denis McDonough told reporters at his monthly news conference. The claims backlog, defined as claims older than 125 days, has grown by roughly 50,000 since September to 200,140, but the department has hired about 2,000 new claims processors and is using an automated system to process some

#### **US Congress Senate Bill 280**

A bill to ensure that only licensed health care professionals furnish disability examinations under a certain Department of Veterans Affairs pilot program for use of contract physicians for disability examinations, and for other purposes.

#### **SB 112**

A bill to amend title 38, United States Code, to strengthen benefits for children of Vietnam veterans born with spina bifida, and for other purposes

Action: 2023-01-26 - Read twice and referred to the Committee on Veterans' Affairs

#### **HB841**

To amend title 38, United States Code, to allow a surviving spouse of a Medal of Honor recipient to receive a special pension concurrently with dependency and indemnity compensation, and for other purposes.

#### <u>HB608</u>

To terminate the Electronic Health Record Modernization Program of the Department of Veterans Affairs.

#### **HB 196**

## **HB 41**

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to ensure the timely scheduling of appointments for health care at medical facilities of the Department of Veterans Affairs, and for other purposes.

Action: 2023-01-09 - Referred to the House Committee on Veterans' Affairs

## H.R. 232,

The Real Justice for Our Veterans Act, would authorize the Department of Justice (DOJ) to provide grants to local governments for improving retention rates in veterans' treatment courts and specialized programs that integrate substance use treatment services with criminal justice proceedings. The bill also would allow veterans to participate in a regular drug court program if no veterans' treatment court is available. This bill would also require DOJ to report to Congress three years after its enactment on the effectiveness of veterans' treatment court programs, including an assessment of access to such programs for women and other demographic groups.

Years of experience from the veterans' treatment courts have resulted in a reduction of recidivism rates for veterans compared with persons in other treatment courts and individuals not involved in any sort of alternative or diversionary court program. DAV supports H.R. 232, in accordance with DAV Resolution No. 030, which supports the continued growth of veterans' treatment courts in addition to appropriate goals and metrics to determine the program's effectiveness.
