Remember Pearl Harbor, December 7, 1941, Japan attacked America killing thousands.

I was given 10 days to report to my new unit. I found a convoy that was headed to the 1Rst Division Headquarters. There was no room for me in the convoy, so they gave me a place in the back of a truck. When we stopped for the night, I was not fond of the idea of sleeping on the bed of a truck. I noticed that we were in front of a Navy Seabee Camp. Of course, as a Marine I was a little nervous about asking the Navy for a place to sleep. I knew all they could say was no. It was late when I found the Headquarters tent, I spoke to the Master Chief, He not only welcomed me, he had the cook make me a steak, let me take a hot shower and gave me a bed with a mattress and pillow with sheets. The next morning, I again rejoined the convoy. By afternoon I was at the First Division Headquarters. I reported in and I was told to stow my gear, and Staff Sargent said, "let's go for a ride". We drove to Danang, where I and several thousand others were treated to the Bob Hope Christmas show.

Happy Hanukkah, Merry Christmas and Happy New Year to all.





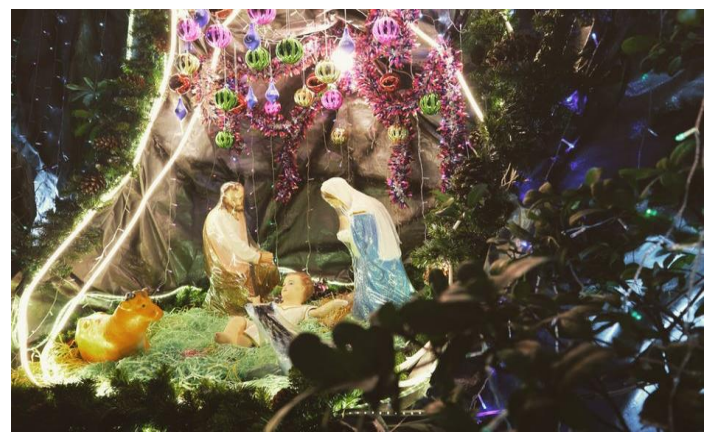
## John Markiewicz Department Judge Advocate

### Changes coming soon for some TRICARE Select retired beneficiaries

Starting on January 1, 2021, TRICARE Select Group A retired beneficiaries must pay monthly enrollment fees in order to maintain their TRICARE health coverage. This is a change, and for the first time this beneficiary group will pay enrollment fees. If you or your sponsor's initial enlistment or appointment occurred before January 1, 2018, you are in Group A. This change was mandated by Congress.

What do you need to do if this change applies to you? You must set up a monthly allotment through your DoD pay center, where feasible for your monthly payments to start on January 1, 2021. For sponsors who don't receive funds through a DoD pay center, you can establish payments via electronic funds transfer, credit or debit card. Your regional contractor will soon issue instructions to set up payment.

He enrollment fees will be collected via monthly installments from the sponsor's military pay system where retired pay is Disbursed. Individual plan: \$12.50 per month—Family plan: \$25.00 per month.

TRICARE Open Season applies to beneficiaries eligible to enroll in TRICARE Prime (including the United States Family Health Plan) TRICARE Prime Remote or TRICARE Select. TRICARE Open Season doesn't apply to active duty service members. It also doesn't apply to TRICARE for Life (TFL). TFL coverage is automatic if you have Medicare Part A and Part B. Open Season also doesn't apply premium-based plans.

Federal Benefits Open Season allows you to enroll in the Federal Employees Vision and Dental Insurance Program (FEDVIP). This program is managed by the United States Office of Personnel Management. It offers eligible TRICARE beneficiaries a choice between multiple vision and dental plans and carriers.

If you're already enrolled in FEDVIP dental and/or vision plan, your enrollment will automatically continue in 2021. If you wish to make changes to your existing plan, you must do so during the open season. Learn more about FEDVIP eligibility to see whether this program is an option for you and your family.

To get ready for the Open season, you can use tools on the TRICARE website, like the TRICARE Plan Finder and TRICARE Compare Cost Tool. If you want to get updates about open season and other TRICARE News, sign up for email alerts at:

#### You need a DS Logon and here's why...

A DOD Self-Service Logon, is a guarantee for secure, self-serviced access for Retired Soldiers, surviving spouses, and families to several informative government partner websites. The free DS Logon ID account allows its members access to all sites using a single username and password. It can be used for unlocking personal profiles, health information, pending applications, open claims, full records, and custom benefits. The DS Logon can be used 24 hours a day, 7 days a week. All individuals requesting a DS Logon must be enrolled in DEERS because new user accounts are verified through DEERS.

In order to obtain a DS Logon, all applicants must be affiliated with the DOD or VA and have a listing in DEERS under one of the following categories: active duty, Reserve Component, retiree, or veteran; eligible family members over age of 18; DoD civilians and contractors. There are many ways in which a potential user can apply depending on their applicable category. Retired soldiers and family members can find a link to obtain a DS Logon Premium Account on the MyArmyBenefits homepage. Alternatively, retired soldiers can sign up using their Defense Finance Accounting Service (DFAS) myPay Login ID; using their email on file with DEERS when registering and selecting the "I have an active DoD card and email on file with DEERS" option; requesting a DS Logon when getting a DoD ID card issued at a RAPIDS facility; or by visiting the VA Regional Office to establish a DS Logon account. You have likely heard this through other channels, but just in case you haven't I want to ensure that you are aware. **Effective January 1, 2021**, all fax lines used for incoming claims submissions will be decommissioned. VBA is working now to remove all fax information on websites, letters, correspondence, forms, other forums to remove conflicting information. After January 1, 2021, claims can still be submitted electronically through Direct Upload or Benefits Intake API (VA.gov connection).

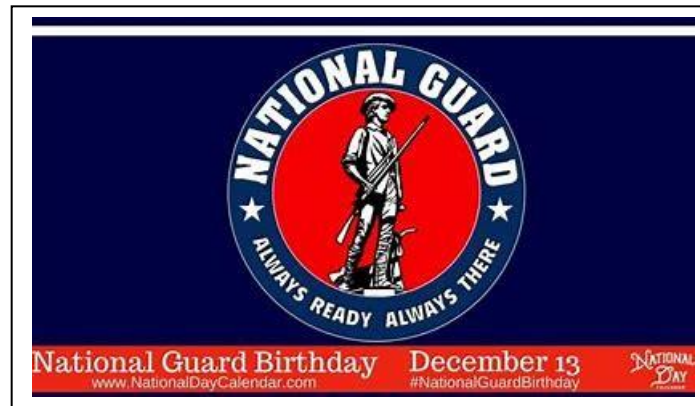

## Adjutant's Column Continued

**S. 4594** Caring for the Survivors and Families of Veterans Act of 2020

**Sponsor:** [Sen. Tester, Jon \[D-MT\]](#) (Introduced 09/16/2020)

**Committees:** Senate - Veterans' Affairs

**Latest Action:** Senate - 09/16/2020 Read twice and referred to the Committee on Veterans' Affairs.

**H.R. 6933** is the companion bill

This Bill, the Caring for Survivors and Families Act would expand eligibility for DIC by replacing the "10-year" rule with a graduated scale of benefits that begins at 5 years for initial eligibility at 50%, and gradually reaches the full benefit at 10 years after determination of disability. For example—if a veteran is rated as totally disabled for 5 years and dies of a nonservice-connected cause, their survivor would be entitled to 50% of the DIC benefit. Presently, DIC pays \$1, 340.14 monthly thus they would receive under the proposed legislation \$670.00 monthly. In addition, the Bill would reduce from 57 to 55 years, the age a surviving spouse may remarry and maintain their benefits, consistent with eligibility for other federal benefits for survivors.

**S. 4790**

A bill to improve the ability of separating or retiring members of the Armed Forces to seek services provided by accredited veterans service officers, and for other purposes.

**Status:** (Introduced) 2020-10-01 - Read twice and referred to the Committee on Veterans' Affairs.

**HB 7795****Veterans Benefits Fairness and Transparency Act of 2020**

This bill requires the Department of Veterans Affairs (VA) to publish on its website the disability benefit questionnaire forms for non-VA medical providers submitting evidence regarding a disability of a claimant for purposes of VA benefits. If the VA updates the questionnaire form, previous versions of the form filed by claimants must be accepted for up to one year after the form was updated. The VA may waive interagency approval processes required to approve a modification to a form if such requirement applies by reason of the form being made public on the website as required by the bill. The Inspector General of the VA must, through 2026, annually report on the use of such forms.

**H.R. 6092****Veteran's Prostate Cancer Treatment and Research Act**

This bill requires the Department of Veterans Affairs (VA) to implement programs and resources related to the diagnosis and treatment of prostate cancer. Specifically, the bill requires the VA to establish in its National Surgery Office a national clinical pathway for all stages of prostate cancer that includes specified elements. A clinical pathway is a health care management tool designed around research and evidence-backed practices that provides direction for the clinical care and treatment of a specific episode of a condition or ailment. The VA must publish the proposed clinical pathway in the Federal Register for public comment. Additionally, the bill requires the VA to publish the established clinical pathway on a public VA website and to update the clinical pathway at least annually. Under the bill, the VA must submit (1) a plan to establish a comprehensive prostate cancer program, and (2) a plan that provides for continual funding for supporting prostate cancer research through the VA Office of Research and Development. The VA must also establish a program evaluation tool to learn best practices of multidisciplinary disease-based implementation. Finally, the VA must establish a real-time, actionable, national prostate cancer registry that is accessible to clinicians and researchers.

Action: 2020-09-23 - Received in the Senate and Read twice and referred to the Committee on Veterans' Affairs.

**S. 4572****Presumptive Benefits for War Fighters Exposed to Burn Pits and Other Toxins Act of 2020**

To amend title 38, United States Code, to provide for a presumption of service connection for certain diseases associated with exposure to toxins, and for other purposes.

**PRESUMPTION OF SERVICE CONNECTION.**

For the purposes of section 1110 of this title, and subject 11 to section 1113 of this title, a disease specified in paragraph (2) becoming manifest in a veteran described in paragraph (3) shall be considered to have been incurred in or aggravated during active military, naval, or air service, notwithstanding that there is no record of evidence of such disease during the period of such service.

The diseases specified in this paragraph are the following:  
(A) Asthma that was diagnosed after service in a country or territory listed under paragraph (4)(B).

- (B) Cancer of any type.
- (C) Chronic bronchitis.
- (D) Chronic obstructive pulmonary disease.
- (E) Constrictive bronchiolitis or obliterative bronchiolitis.
- (F) Emphysema

(G) Granulomatous disease.  
(H) Interstitial lung disease.  
(I) Lymphoma.  
(J) Pleuritis.  
(K) Pulmonary fibrosis.  
(L) Sarcoidosis.  
(M) Any other disease with respect to which final regulations have been prescribed under subsection (c)(3).

A veteran described in this paragraph is any veteran who—

(A) on or after August 2, 1990 served as a member of the Armed Forces in support of a military operation described in paragraph (4); and “(ii) was present for 15 or more cumulative days in a country or territory listed under subparagraph (B) of that paragraph; or

(B) was awarded any of the following: “(i) The Southwest Asia Service Medal. “(ii) The Global War on Terrorism Expeditionary Medal.

### S.4166

Ensuring Survivors Benefits during COVID-19 Act of 2020

This bill requires the Department of Veterans Affairs to get a medical opinion to determine if a service-connected disability was the principal or contributory cause of death in situations where a veteran with a service-connected disability dies from COVID-19 (i.e., coronavirus disease 2019), or complications from COVID-19, and the death certificate does not clearly identify the service-connected disability as the principal or contributory cause of death.

Action: 2020-07-02 - Read twice and referred to the Committee on Veterans' Affairs.

### S.4086

Forgotten Vietnam Veterans Act of 2020

This bill revises the definition of Vietnam era for purposes of the laws administered by the Department of Veterans Affairs. Specifically, the bill adjusts the start date of the era to November 1, 1955 (currently February 28, 1961), when relating to veterans who served in the Republic of Vietnam.

On October 17, the President signed into law S. 785, the Commander John Scott Hannon Veterans Mental Health Care Improvement Act. Public Law 116-171

This comprehensive bipartisan bill, in line with DAV Resolution No. 370, will help increase outreach and services to veterans at risk for suicide and improve VA mental health services by:

- Strengthening VA's mental health workforce to serve more veterans by offering scholarships to mental health professionals to work at Vet Centers, and placing at least one Suicide Prevention Coordinator in every VA hospital;
  - Directing the department to develop a staffing plan for increasing the number of mental health counselors and region-specific incentives needed to hire them; Improving rural veterans' access to mental health care by increasing the number of locations at which veterans can access VA telehealth services;
  - Implementing a pilot program to expand veterans access to complementary and integrative health programs through animal therapy, agriculture therapy, sports and recreation therapy, art therapy and post-traumatic growth programs;
  - Studying the health benefits of providing integrative health treatments such as yoga, meditation, acupuncture, chiropractic care;
  - Establishing a grant program that allows VA to better collaborate with community organizations already serving veterans with a goal of early identification and supportive prevention services for veterans at risk of suicide;
  - Studying the impact of living at high altitude and associated suicide risk factors for veterans and implementing a precision medicine initiative to identify and validate brain and mental health biomarkers among veterans to better identify and treat depression, anxiety, PTSD, and traumatic stress disorder.
- The bill also includes provisions, supported by DAV Resolution No. 020, to improve services to women veterans by:
- Expanding the capabilities of the VA women veterans call center, to include text messaging; and
  - Creating a centralized website that includes information about all the benefits and services available to women veterans, the name and contact information for each women's health coordinator, and specific services available for women veterans at each medical center and community-based outpatient clinic throughout a designated VISN—Veterans Integrated Service Network.

### New Florida laws in effect as of October 2020

**HB 205 - Unlawful Use of Uniforms, Medals, or Insignia** - Prohibits certain misrepresentations concerning military service when made for specific purposes.

**SB 294 - Crimes Against Veterans** - Citing this act as the "Florida Veterans Protection Act"
