### Hello My Fellow Veterans

Due to the Holiday Season, many chapters were not meeting this month. I did visit Chapter 122 – Marathon, FL, attended Chapter 1 Bingo at Lake City VA Medical Center and provided pizzas to the Substance Abuse Residential Rehabilitation Treatment Program (SARRTP) in Lake City VA Medical Center.

This is for the veterans only not the spouse unless the veteran is rated at 100 percent. Those veterans who have Caregivers approved through VA must have certification from VA authorizing them as the Veteran's Caregiver.

I hope everyone had a Happy Christmas as with all Holidays we have a Dinner and then go feed the Homeless. My wife and I do Christmas Eve with our family and spend Christmas at the Chapter.

About 32 out of our 58 Chapters attended our recent Mid-Winter Conference. We hope to have many more attend our Department Convention scheduled at the Lake Mary Marriott in June. # Some facts about donating to DAV that you can use when you are Fundraising:

Does DAV receive funds from the federal government?

No. DAV receives no money or grants from the federal government. Our service programs are sustained by contributions such as yours.

# Do DAV service programs overlap or duplicate government programs?

No. DAV programs pick up and fill the void left by government agencies. This is especially true given government budget cutbacks which have made the need greater over the past several years.

### Is my donation tax-deductible?

Yes, the DAV is a tax-exempt organization, and all contributions are tax-deductible according to IRS regulations.

# How much of my donation goes to help disabled veterans?

85¢ of every dollar spent in 2018 went to program services for disabled veterans and their families. While that figure already compares favorably with other national charities, we constantly strive to further increase efficiency and effectiveness in the use of the funds you entrust to the DAV.

### Legislative Report

Americans celebrate Vietnam Veterans Day annually on March 29 thanks to a measure signed into law by President Donald Trump in 2017.

The holiday, officially known as National Vietnam War Veterans Day, was made official by Trump through the "Vietnam War Veterans Recognition Act of 2017," and encourages Americans to display the U.S. flag in honor of Vietnam veterans.

A similar holiday was previously observed on March 29, 2012, through a proclamation signed by then-President Barack Obama. That year marked the start of a 13-year-long celebration honoring Vietnam War veterans that runs through Veterans Day 2025.

In November 2017, Trump marked Veterans Day and the commemoration of the 50th anniversary of the Vietnam War by meeting with U.S. veterans in Vietnam.

"One of my great honors is to represent the people standing right behind me -- great, great warriors and veterans of the Vietnam War," he said during a meeting with veterans at a hotel in Danang, Vietnam. "To each of you with me today, you are the heroes who fulfilled your duty to our nation. And each of you, under the most difficult conditions, did what you had to do, and you did it well."

During that meeting, Trump also pledged to continue to support efforts by the Pentagon's POW/MIA Accounting Agency (DPAA), which works worldwide to recover the remains of U.S. troops missing in combat. "Our accountability efforts in Vietnam are very, very important to all of us. We will not rest until all of the 1,253 missing veterans are returned home," he said. "Our veterans are a national treasure, and I thank them all for their service, sacrifice and patriotism."

#### News for Medal of Honor & Former POW's

With the signing of the 2020 National Defense Authorization Act, Medal of Honor recipients and prisoners of war are all entitled to burial with full honors at Arlington National Cemetery, regardless of rank.

As of Dec. 20, when Trump signed the bill into law, the service secretaries must provide burials with full military honors to enlisted recipients of the Medal of Honor or the prisoner-of-war medal who in the past were "not entitled to full military honors by the grade of that veteran."

The previous rules restricted full honors at Arlington in-ground burials to officers, warrant officers, senior noncommissioned officers and service members killed in action.

According to the <u>Department of Veterans Affairs</u>, there are at least 5,000 living former enlisted and officer POWs. The Congressional Medal of Honor Society lists 71 living MOH recipients of all ranks.

Rep. Dan Crenshaw, R-Texas, a co-sponsor of the bill and a former <u>Navy SEAL</u> lieutenant commander who lost his right eye in Afghanistan, said in a statement at the time that "Valor holds no rank."

Military retirees who paid annual Tricare Prime enrollment fees in 2018 or 2019 could soon see a refund check in the mail, thanks to a new change to how the system calculates their annual out-of-pocket maximum payment.

The annual maximum out-of-pocket payment, or "catastrophic cap," for any retiree family with a service member who joined the military before Jan. 1, 2018, is set at \$3,000. For those who joined after Jan. 1, 2018, the annual retiree cap is about \$3,600. Those users pay about \$600 per year for plan enrollment, while future retirees will pay close to \$1,000.

After a set of sweeping Tricare reforms went into effect in 2018, the annual fee paid by retirees to use Tricare Prime no longer counted toward the yearly out-of-pocket max. That meant some families were faced with an increase of about \$600 in their yearly Tricare spending.

Now, a new Tricare change, retroactive to 2018, will allow annual enrollment payment to count toward the cap once again, reducing the amount of money retirees might pay out of pocket each year, according to a Tricare policy manual update released Thursday.

That means retirees who paid an enrollment fee for Tricare Prime this year or in 2018, and then exceeded their \$3,000 catastrophic cap, could get a refund.

"For the 2018 and 2019 enrollment fees credited to the catastrophic cap, the contractor shall notify the beneficiaries by letter of the credit, how the credit was applied, and how a refund can be requested," the Tricare manual update states.

Next year, when retirees who pay their enrollment fees on a monthly basis as a pension allotment hit their out-ofpocket cap, their payments will be automatically halted, the update states.


The change will also apply to future retirees who joined active duty after Jan. 1, 2018. By law, they will pay an enrollment fee of almost \$1,000 for Tricare Select. Current retirees do not pay an enrollment fee for that plan.

#### Adjutant's Column Continued

Many Veterans, with a service connected disability rating, are entering Federal recreation lands and national parks for free with an <u>America the Beautiful-the National Parks and</u> <u>Federal Recreational Lands lifetime Access Pass</u> through an interagency partnership between the U.S. Department of the Interior, National Park Service, Forest Service, Fish and Wildlife Service, Bureau of Land Management, Army Corps of Engineers and Bureau of Reclamation. Good for entry into thousands of federally managed recreation sites across the country, the Lifetime Access Pass is another way a grateful nation says thank you for the service and sacrifices of U.S. Veterans with disabilities.

The <u>Access Pass</u> admits the pass owner and any passengers in a single, private vehicle (non-commercial) at per-vehicle entrance and day use fee areas; or, the pass owner plus three additional adults where per-person fees are charged. In addition to free entry at participating sites, the Access Pass includes discounts on some <u>expanded amenity</u> <u>fees</u> such as camping. Sites recommend that pass owners check with each site before visiting for details about Access Pass entry and discounts.

Veterans who have been medically determined to have a disability are eligible for the Lifetime Access Pass—with three options for obtaining the pass:

First, Veterans with disability documentation can order the Access Pass <u>online</u> for a \$10 processing fee which includes standard shipping. Documentation required includes:


- Proof of residency
- VA disability award letter, VA summary of benefits, or proof of SSDI income

Second, the Interagency Access Pass may be obtained through the mail. Download a paper application from <u>https://store.usgs.gov/access-pass</u>. Follow the instructions on the website and pay the document processing fee of \$10. Once the application package is received by USGS, the documentation will be verified and a pass imprinted with the pass owner's name will be mailed to the applicant.

Passes ordered online or through the mail will be delivered 3 to 4 weeks after receipt of documentation and processing payment.

A third option is for disabled Veterans to visit a <u>participating federal recreation site</u> where interagency passes are issued, present photo identification (e.g., Driver's license, State ID, birth certificate, Passport, or permanent resident card), provide documentation of permanent disability, or read and sign a Statement of Permanent Disability affidavit. That's It. The Pass is free and issued at the time of entry.

Make sure to have photo ID available when using your Lifetime Access Pass and enjoy the majestic scenery and abundant recreational opportunities our National Parks provide.



## NSO Supervisor's Column Michael Michelotti

### **Appeals Modernization Act (AMA) Overview**

- AMA features a three-option framework for claimants to choose from when dissatisfied with VA's decision on their claim (see chart below):
  - Supplemental Claim (0995) with <u>new</u> and <u>relevant</u> information will be processed in the PMC by VSR/RVSR
  - Higher Level Review (0996) with a closed record will be processed by a Decision Review Officer
  - Notice of Disagreement Board Appeal (10182 NOD)
- Additional changes found in the new law include:
  - Improved notification of all VA decisions\*
  - Effective date protections for continuously pursued claims
  - Findings favorable to a claimant are binding on VA and Board adjudicators
  - Elimination of the split jurisdiction between VBA and the Board for appeals processing

### \*<u>AMA Improved Decision Notification Requirements (8</u> Point Notification Requirement

- 1. Identification of issues adjudicated
- 2. Summary of evidence considered (and evidence not considered for HLRs)
- 3. Summary of applicable laws and regulations
- 4. A list of any favorable findings, when applicable
- 5. For denied claims, identification of elements required to grant that were not met
- 6. Identification of the next higher evaluation criteria (for compensation)
- 7. An explanation of how to obtain or access evidence used in making the decision
- 8. Summary of the applicable review options available
