A question that continues to come up on a regular basis concerns the legality of donations made by a Chapter or Department to other organizations or to individuals which do not directly or substantially benefit disabled veterans or their families. In many cases, this has involved local scholarships being awarded by Chapters.

The whole donation issue, including scholarships is more of an IRS issue than it is a Constitution & Bylaws issue. The IRS has granted the DAV their tx-exempt status based on their providing services to ill and injured veterans and their families as stated in their charter and other governing documents. Therefore, all funds raised by, donated to or collected in dues by DAV from its members are presumed by the IRS to be given to the DAV with the intent that they be used for that tax-exempt purpose.

Regulation 5 of the National Executive Committee states that income received from a Forget-Me-Not Drive shall be used solely for service to ill and injured veterans, their dependents and survivors and for no other purpose, It goes on to state that income from all other approved Department or Chapter fundraising activities shall be used to support programs and activities sponsored by DAV, its subordinate units or other entities, as long as such programs and activities provide a direct and substantial benefit to ill and injured veterans, their dependents and survivors.

The provision mentioned for other entities covers events like Homeless Veterans Stand-Downs, Caregivers of Veterans Conferences and events sponsored by Department of Veterans Affairs, other Veterans Service Organizations and other Charitable Organizations where the programs and activities are geared towards veterans and where they provide a direct and substantial benefit to ill and injured veterans, their dependents and survivors.

We all need to remember that when we donate funds to various charities from our own Chapter, that we are dealing with funds that have been provided by our donors and members to provide a better life for our ill and ijured veterans, their dependents and survivors. This is the key phrase to remember when considering making a donation and we need to ask ourselves, "(h)ow will this donation provide a **direct and substantial benefit to ill and injured veterans, their dependents and survivors".**

Clearly then, if a donation does **not directly and substantially benefit ill and injured veterans, their dependents and survivors**, it does not meet the criteria for a DAV Department or Chapter and we are not allowed to use our funds for that purpose regardless of how worthy the purpose or cause may be.

Legislative Report

Who is eligible for Beneficiary Travel from VA? What are the requirements? According to VA, you are eligible for Beneficiary Travel if you meet the following guidelines:

- Veterans with disabilities rated 30% or more service-connected—travel for care relating to any condition.
- Veterans with disabilities rated less than 30% who travel for the episode care relating to their service-connected condition(s).
- Veterans receiving VA Pension benefits and travel for care for any condition
- Veterans with annual income below the maximum applicable annual rate of pension who travel for care of any condition. Veterans must have updated income verification on file (10-10EZR) within the required income threshold.
- Veterans who travel in relation to a Compensation and Pension Examination.

Enroll in VA health care

To receive care from VA or a community provider, you must be enrolled in VA health care. You can apply online, by mail, or in person. Visit our website to learn more about eligibility criteria and required enrollment documents.

A provides health care for Veterans from providers in your local community outside of VA. Veterans may be eligible to receive care from a community provider when VA cannot provide the care needed. This care is provided on behalf of and paid for by VA. Community care is available to Veterans based on certain conditions and eligibility requirements, and in consideration of a Veteran's specific needs and circumstances. Community care must be first authorized by VA before a Veteran can receive care from a community provider.

Veterans may be eligible for care through a provider in their local community depending on their health care needs or circumstances, and if they meet specific eligibility criteria. Even if a Veteran is eligible for community care, they generally still have the option to receive care from a VA medical facility.

In most cases, **Veterans must receive approval from VA** before receiving care from a community provider to avoid being billed for the care. VA staff members generally make all eligibility determinations for community care.

1. Eligibility

VA confirms a Veteran's eligibility to receive community care.

2. Appointments

Veteran or a VA staff member schedules appointment with a provider in VA's network.

3. Getting Care

Veteran receives care from a community provider in the VA's network.

4. Billing

Community provider sends the claim to a Third Party Administrator (TPA) or VA for payment.

A Veteran's eligibility for community care depends on whether his\her individual health care needs or circumstances. Please note the following about eligibility for community care:

- Veterans must receive approval from VA prior to obtaining care from a community provider, in most circumstances.
- Veterans must either be enrolled in VA health care or be eligible for VA health care without needing to enroll to be eligible for community care.
- Eligibility for community care will continue to be dependent upon a Veteran's individual health care needs or circumstances.
- VA staff members generally make all eligibility determinations.

There are six criteria that can qualify a Veteran to receive community care. Veterans only need to meet one of these to be eligible:

- Veteran needs a service not available at a VA medical facility
- Veteran lives in a United States state or territory without a full-service VA medical facility.
- Veteran qualifies under the "Grandfather" provision relating to distance eligibility for VCP.
- VA cannot provide care within certain designated access standards.
- It is in the Veteran's best medical interest.
- A VA Service Line does not meet certain quality standards.

If there is a specific community provider a Veteran would like to see that is not in VA's network, VA may be able to add them to its network. In some cases, a VA staff member will work with the Veteran to find other options when:

- A community provider cannot be found that meets the Veteran's health care needs
- A community provider was, but is no longer part of VA's network.
- An existing community provider is no longer available

Getting Care

When a Veteran arrives for the appointment, the community provider should have the appointment, VA referral, and medical documentation on file. If a Veteran needs a follow-up appointment, the community provider should check to make sure VA has authorized additional care before scheduling the appointment.

Prescription Medication

If prescription medication is needed, the prescription should usually be sent to and filled by the nearest VA pharmacy. Veterans can receive short-term prescription medication for a 14-day or fewer supply that can be filled at a non-VA pharmacy. A prescription for more than a 14-day supply must be filled by VA.

Billing and Payments

After receiving care from a community provider, Veterans may have to pay a copayment for nonservice-connected care, just as the Veteran would if care was received at a VA medical facility. For urgent care, copayments depend on the Veteran's assigned priority group and the number of times the Veteran visits an urgent care provider in a calendar year.

Community providers cannot bill or collect a VA copayment directly from Veterans, including for urgent care. All VA copayments are billed as part of VA's billing process.



If you think you are eligible to apply for benefits related to Agent Orange Exposure you should apply now using VA Form 21-526EZ provided you have never claimed that disability before due to AO exposure.

If you were previously denied service connection for a disability claimed due to AO exposure then you must file a supplemental claim using VA form 20-0995.

Army Now Offering Recruits up to \$40,000 to Join the Infantry

FORT KNOX, Kentucky -- <u>U.S. Army</u> recruiters are offering bonuses worth up to \$40,000 to new recruits who sign up for the infantry by Sept. 30 as part of an effort to reverse a shortage of grunts for fiscal 2019.

The drastic increase in bonus amounts for recruits in 11X, the infantry military occupational specialty, went into effect in mid-May, according to U.S. Army Recruiting Command officials, who said that the service still needs to fill about 3,300 infantry training seats by Septem We saw this coming in May; we immediately went to the senior leadership and said, 'look, we need to max out the bonuses for 11Xs,'" Maj. Gen. Frank Muth, commander of Army Recruiting Command, told Military.com Tuesday.

Before May, the maximum bonus amount for infantry recruits was \$15,000 for a six-year commitment.

Last summer, the Army ran a pilot at Fort Benning, Georgia that resulted in the service extending infantry one station unit training (OSUT) from 14 weeks to 22 weeks. The extended infantry training is designed to give soldiers more time to practice key infantry skills such as land navigation, marksmanship, hand-to-hand combat, fire and maneuver and first aid training.

The bonus increase is just a small step in the Army's effort to meet its recruiting goal for the active force of 68,000 soldiers by Sept. 30. The Army launched a multi-faceted recruiting strategy last October after the service missed its 2018 recruiting goal by 6,500 soldiers.

New recruits signing up for the infantry can also get \$20,000 for a three-year enlistment, \$25,000 for a four-year enlistment and \$30,000 for a five-year enlistment, Recruiting Command officials said.

But these new bonuses won't last long, Muth said.

"You've got to ship in August and September," Muth said, explaining that infantry recruits must enter OSUT at Benning by the end of this fiscal year.

"If you ship in October, you don't get the bonus."

VA Caregiver Program

Family Caregivers provide crucial support in caring for our Nation's veterans by allowing them to stay in the homes and communities they defended, surrounded by their loved ones. Currently, the program has allowed VA to provide additional support and services to Family Caregivers to eligible veterans injured in the line of duty on or after 9/11/2001. Under the caregiver program, relatives or friends who care for eligible veterans can receive a stipend, training, access to health insurance, counseling and respite care.

Veteran Eligibility

- The veteran incurred a serious injury in LOD, on or after 9/11/2001.
- 2. Because of the qualifying serious injury, the veteran requires another person (Caregiver) to assist the veteran with the management of personal care functions required in everyday living.
- The serious injury renders the veteran in need of personal care services for a minimum of six continuous months.
- 4. It is in the best interest of the veteran to participate in the Caregiver Support Program.
- 5. The veteran will receive ongoing care from a Patient Aligned Care Team (PACT) or other VA health care team as a requirement for participation in the program.
- 6. The veteran agrees to receive ongoing care at home after VA designates a family caregiver.
- 7. Personal care services that would be provided by the Caregiver will not simultaneously be provided through another individual or entity.

Caregiver Eligibility

- 1. The Caregiver must be at least 18 years of age.
- 2. The Caregiver must be either the veteran's spouse, son, daughter, parent, step-family member or extended family member or someone who lives with the veteran

Full time.

3. Prior to approval, the Caregiver will be provided with training and must be able to demonstrate the ability to assist the veteran with personal care functions required in everyday living.

The MISSION Act expands eligibility to eligible veterans and their Caregivers from all eras. Under the law, expansion will begin when VA certifies to Congress that they have fully implemented a required IT system. The expansion will occur in two phases beginning with eligible veterans who incurred a serious injury in LOD on or before May 7, 1975, with further expansion beginning two years later.

Application Details

- The required application is VA Form 10-10CG. If the veteran is not currently enrolled in VA health care, both the VA Form 10-10 EZ for VA health care services and the application for the Caregivers Program 10-10CG will need to be completed.
- The application must be completed and signed by both the veteran and their primary caregiver.
- The application can be hand carried to a Caregiver Support Coordinator at a local VA Medical Facility for walk-in processing.
