

Yom Kippur begins at sun down on October 8. The name "Yom Kippur" means "Day of Atonement," and that pretty much explains what the holiday is. It is a day set aside to "afflict the soul," to atone for the sins of the past year. In Days of Awe, I mentioned the "books" in which G-d inscribes all of our names. On Yom Kippur, the judgment entered in these books is sealed. This day is, essentially, your last appeal, your last chance to change the judgment, to demonstrate your repentance and make amends.

Halloween is Oct 31. And is the unofficial beginning of the holiday season ending with New Year day.

Halloween began as the festival of Samhain in 1745. It was part of the ancient Celtic religion in Britain and other parts of Europe. At the end of summer, the Celts thought the barrier between our world and the world of ghosts and spirits got really thin. This meant weird creatures with strange powers could wander about on Earth.

The Celts had a big party. It was all about scaring away the ghosts and spirits. Later, with the Christian religion, the day became known as All Hallows' Eve - the day before All Saints' Day on 1 November.

Irish immigrants to the United States raised the popularity of Halloween during the 19th century.

The Departments of Defense and Veterans Affairs are gearing up for what will be the largest expansion of patrons to the military commissary system and exchanges in 65 years, making sure that shoppers will be able to get on base and find the shelves fully stocked. Starting Jan. 1, Purple Heart recipients, former prisoners of war and all serviceconnected disabled veterans, regardless of rating, as well as caregivers enrolled in the VA's Comprehensive Assistance for Family Caregivers program, will be able to shop at Defense Commissary Agency stores and military exchanges. They also will have access to revenuegenerating Morale, Recreation and Welfare amenities, such as golf courses, recreation areas, theaters, bowling alleys, campgrounds and lodging facilities that are operated by MWR. At commissaries, however, there will be an added cost for new patrons who use a credit or debit card to pay for their groceries, in addition to the 5% surcharge commissary patrons already pay.

Since most new patrons lack the credentials needed to get on military bases, installations will accept the Veteran Health Identification card, or VHID, from disabled and other eligible veterans. For caregivers, the VA plans to issue a memo to eligible shoppers in the coming months, which will be used in conjunction with any picture identification that meets REAL ID Act security requirements, such as a compliant state driver's license or passport.

Judging by the Chapter constitutions, bylaws and changes that I have received since our last Department Convention in June, it is time once again to remind everyone of the requirements for submitting these documents.

In one case they were improperly submitted directly to the National Judge Advocate, completely bypassing the Department of Florida Executive Director and the Department Judge Advocate, needless, to say they were returned unprocessed. In two other cases they were sent directly to the Department Judge Advocate, again bypassing the Department of Florida Executive Director and with only the original document submitted.

Article 10, Section 10.2, Para 4 (as revised in June of 2019) of the Department of Florida Bylaws states the following:

"Chapter constitution, bylaws and changes (including the change and the revised document incorporating the proposed change) thereto will be submitted to Department Headquarters in triplicate, signed by both the Chapter Commander and the Chapter Adjutant. The Department Executive Director will review, transmit and maintain a copy of the submissions to the Department Judge Advocate. The Department Judge Advocate will review the submissions, approve or remand submissions and forward the documents in accordance with Article 9, Section 9.1 of the National Bylaws."

Pertinent excerpts of Article 9, Section 9.1, Para 1 and Para 2 of the National Bylaws are as follows:

"Each chapter must adopt its own constitution, bylaw and regulations, provided that such constitution, bylaws and regulations do not conflict with those of the National Organization or with those of the state department with which the chapter is affiliated and provided they are approved first by the state judge advocate, then by the National Judge Advocate."

"Amendments must also be submitted to the state judge advocate and National Judge Advocate for approval."

"Each chapter shall include the following provision in its Bylaws, unless prohibited by the charitable trust laws of its particular state:

"This Chapter recognizes the National Organization known as Disabled American Veterans, incorporated by Act of Congress, and affirms its allegiance and subordination, to the National Organization, its Constitution, Bylaws and all Rules, Mandates and Regulations promulgated pursuant thereto. Upon dissolution of the Chapter, the assets remaining after the payment of its debts shall be distributed as provided in Article 6, Section 6.4, Para. 5 and 6 of the National Bylaws"

Failure to follow the provisions of the above quoted articles in your submission can result in significant delays in processing the submission including having the document remanded to you for proper resubmission.

Proposed legislation would provide TSA Pre-Check for disabled veterans

DAV strongly supports bipartisan legislation that would provide severely disabled veterans free TSA PreCheck. The Veterans Expedited TSA Screening (VETS) Safe Travel Act would help make air travel easier and less stressful for those who were eligible.

Today, TSA PreCheck is available to active duty, reserve, and National Guard service members at no cost, and the VETS Safe Travel Act would expand the program to include certain veterans who are amputees, paralyzed or blind.

"Having to navigate through airport security can be an extraordinary challenge for veterans using prosthetics or mobility devices, as many of our members have attested to over the years," said Deputy National Legislative Director Adrian Atizado. "America's disabled veterans deserve to be treated with dignity and respect."

Veterans with physical disabilities can potentially have a difficult experience getting through security lines at airports worldwide. According to Atizado, some veterans have been asked to remove prosthetics, transfer from wheelchairs or give up canes that help them safely navigate their surroundings.

"These devices are more than just equipment, they serve as extensions enabling our disabled veterans to live and function more independently," said Atizado. "TSA PreCheck allows beneficiaries to avoid the significant challenges they face by modern airport security. Because of that, DAV enthusiastically supports this bill."

DAV calls for changes to "10-year" rule for survivor's compensation

DAV is fighting for changes to the Dependency and Indemnity Compensation (DIC) benefit for veterans' eligible survivors, encouraging lawmakers to update the current "10-year" rule. The current DIC benefit arbitrarily requires the veteran to have had a totally disabling service connected condition for 10 years before their death, if their death isn't deemed service-connected by the VA.

"The financial status of surviving spouses, many of whom act as primary caregivers, can be limited for those who put their own potential earnings on hold to care for the veteran," said Assistant National Legislative Director Jeremy Villanueva. "The requirement of 10 years seems illogical given the severity of many disabilities and the impact on veterans and their families."


DAV is calling for the "10-year" rule to be reduced and updated to account for the length and severity of the veteran's disabilities.

"The DIC program would be more equitable if survivors were eligible for a partial DIC benefit based on the number of years the veteran was rated 100 percent disabled by the VA," said Villanueva.

DAV supports a graduated scale that would apply to veterans rated totally disabled for five years or more. For example, if a veteran is rated as totally disabled for five years and dies, a survivor would be eligible for 50 percent of the total DIC benefits, increasing until the 10-year threshold and the maximum DIC amount is awarded.

Legislation was introduced in both the Senate (S. 1990, the Dependency and Indemnity Compensation Improvement Act) and the House (H.R. 4106, the Surviving Spouses Income Security Act) last year during the 115th Congress; however, neither made progress before they adjourned last December. So far, no legislation has been introduced in the 116th Congress that would rectify the inequity of the "10-year" rule.

"Many survivors were caregivers who sacrificed their own careers to take care of their veteran and could potentially be left destitute," Villanueva said. "It's time we ensure they have adequate support."

New DOD Website makes travelling cheaper for military retirees, active duty

The Department of Defense has teamed up with popular travel platform Priceline to create an online vacation website just for active duty and military retirees.

American Forces Travel is a new Morale, Welfare, and Recreating program (MWR) that supports all five service branches. The website offers deals on everything from cruises to flights and hotel reservations.

While travel agents on military bases have long been a resource for military families, this website offers a one-stop shop experience. Along with singular reservations like flights, American Forces Travel also offers travel packages with the flight, hotel and rental car included. The site boasts more than a million hotel deals in more than 71,000 destinations around the world.

"American Forces Travel was developed for a simple reason. The people who support the United States of America through military service have earned access to the world's most exclusive travel deals," said Brett Keller, Priceline's CEO.

Currently, active duty, Reserve and Guard service members and sponsored family members are eligible to use this site, as well as Medal of Honor recipients, 100 percent disabled benefits and retirees. In the future, American Forces Travel plans to extend this resource to Coast Guard members, Department of Homeland Security and Department of Defense civilians.

While veterans who didn't retire aren't eligible to use the site now, DoD intends to make all who served eligible in the future.

Guests will need their last four, birthdate and last name to log in. Upon the site verifying that information, veterans and service members can unlock tons of benefits like no booking fees and 24hour flight cancellation windows. The website also offers 24/7 military travel support and details on flight delays and travel advisories. Each booking on the site generates a commission for service branch MWR programs, which support the military community year-round. This venture, the first of its kind is the only joint service owned leisure travel program.

AMTRAK Offering Military Discount

Amtrak is now offering a 10 percent discount for military veterans.

The new discount is valid for travel across Amtrak's entire national network, including the Northeast Regional from Washington, D.C. to Boston; on all state-supported trains; and on the California Zephyr, Southwest Chief, City of New Orleans, Cardinal, Auto Train, Coast Meteor, Palmetto, Empire Builder and Texas Eagle, according to a company release.

"Amtrak is grateful to our nation's military veterans for their commitment and sacrifices," Amtrak President and CEO Richard Anderson said in the release. "Traveling by train is an adventure, and we have sweetened the deal to offer this discount as a benefit to our veterans."

Amtrak's military discount is valid for coach and Acela business class seats only but is not available on weekday Acela service. It is also not valid with saver fares, non-Acela business class, first-class or sleeping accommodations and 7000-8999 Thruways. Upgrades are available upon payment of the full accommodation charges. Fares are one way and no additional discounts apply.

Did you know your spouse may be entitled to monthly benefits based on your service? Surviving spouses may be entitled to several benefits upon the death of the veteran, these include: month of death benefit, service connected death benefits, nonservice connected death benefits, burial benefits and plot allowance.

VA defines a spouse as a person whose marriage to the veteran was valid under the law of the place where the parties resided at the time of marriage, or the law of the place where the parties resided when the right to benefits accrued.

<u>Month of death benefit</u>: Where a <u>veteran</u> receiving compensation or pension dies, the <u>surviving spouse</u>, if not entitled to death compensation, dependency and indemnity compensation, or death pension for the month of death, shall be entitled to a benefit for that month in an amount equal to the amount of compensation or pension the <u>veteran</u> would have received for that month but for his or her death.

Service Connected Death Benefits: Dependency and Indemnity Compensation (DIC) is a monthly payment made to a surviving spouse because of a service connected death * <u>or</u> to a surviving spouse because the veteran was rated as totally disabled due to SC disabilities prior to his or her death. **

The death of a veteran will be considered as having been due to a service-connected disability when the evidence establishes that such disability was either the principal or a contributory cause of death.

** At the time of death, the veteran was receiving, or was entitled to receive, compensation for service-connected disability that was:

(i) Rated by VA as totally disabling for a continuous period of at least 10 years immediately preceding death;

(ii) Rated by VA as totally disabling continuously since the veteran's release from active duty and for at least 5 years immediately preceding death; or

(iii) Rated by VA as totally disabling for a continuous period of not less than one year immediately preceding death, if the veteran was a former prisoner of war.

Non-service Connected Death Benefits: A benefit payable by the Department of Veterans Affairs to a veteran's surviving spouse or child because of the veteran's nonservice-connected death.

) The veteran must have served an aggregate of 90 days or more during a period of war and who was discharged or released under conditions other than dishonorable, <u>or</u> the veteran was, at time of death, receiving or entitled to receive compensation or retired pay for a service-connected disability based on service during a period of war.
(ii) The surviving spouse meets the net worth requirements and has an annual income not in excess of the applicable maximum annual pension rate.

Burial Benefits and Plot Allowance: VA provides the following types of burial benefits.

Burial allowance based on service-connected death;
 Burial allowance based on non-service-connected death;

(3) Burial allowance for a veteran who died while hospitalized by VA;

(4) Burial plot or interment allowance; and

(5) Reimbursement for transportation of remains
