Legislative Report December 2021

Comrades,

Continuing notifications received in December from the National Commander, Andrew Marshall, will provide the members with additional resolutions for consideration. A more detailed explanation of each resolution can be found in the DAV Commanders Action Network (DAV CAN) in the Action Alerts tab.

One of every eight women will have invasive breast cancer during her lifetime. Companion legislation, H.R. 4794 and S. 2533, the Making Advances in Mammography and Medical Options (MAMMO) for Veterans Act, would improve breast health programs and services available to veterans enrolled for Department of Veterans Affairs (VA) health care. Because women veterans are a minority population within the Veterans Health Administration (VHA), they must often rely on community partners for gender-specific health services including their breast health.

The MAMMO Act would improve mammography services for veterans by requiring the VA to develop a strategic plan for breast imaging services and establishing a tele-mammography pilot program in states without VA mammography services and in locations where the provision of such services is not feasible. The bill would also require VHA to upgrade all mammography equipment to three-dimensional imaging and to study the availability of genetic testing for the breast cancer gene for veterans. DAV supports H.R. 4794 and S. 2533 in accordance with DAV Resolution No. 015, which calls for enhanced medical services, including gender-specific care, and benefits for women veterans.

Prostate cancer is the most common cancer (after skin cancer) among men—one in eight men will be diagnosed with it in their lifetime. Early identification and treatment of the disease is often the key to full recovery.

H.R. 4880 and S. 2720, the Veterans' Prostate Cancer Treatment and Research Act, are bipartisan bills that would require the Department of Veterans Affairs (VA) to develop, in collaboration with knowledgeable federal stakeholders and partners, a clinical pathway to diagnose and treat prostate cancer at each stage of the disease. Importantly, in creating these pathways, the bills would require that VA consult with veterans who have received VA care for prostate cancer in addition to multi-disciplinary cancer care providers and clinical researchers.

DAV supports the Veterans' Prostate Cancer Treatment and Research Act, in accordance with DAV Resolution No. 028, which calls on VA to provide high-quality, responsive, comprehensive health care to all enrolled veterans. Also, this legislation is in accord with DAV Resolution No. 256, which supports VA's medical research program for the purpose of helping wounded, injured and ill veterans recover and rehabilitate from health conditions related to their military ser-
