## **Legislative Report - April 2023**

Comrades,

These are the Commanders Action Notifications (6) that have been received during April through this date. A more detailed explanation of these can be found in the DAV Commanders Action Network (DAV CAN) in the Action Alerts tab.

- 1. H.R.1278/S. 592, the Driver Reimbursement Increase for Veteran Equity (DRIVE) Act to increase the mileage reimbursement rate for veterans receiving health care from the Department of Veterans Affairs. Veterans who are seeking care for service-connected conditions or veterans with service-connected conditions rated at least 30% are among veterans who are eligible for beneficiary travel pay—which may include reimbursement for mileage, tolls and additional expenses, such as meals or lodging. The DAV supports the DRIVE Act in accordance with Resolution No. 432, which calls for adopting the General Services Administration increased mileage rate for veterans' beneficiary travel.
- 2. S.344 and H.R. 1282, The Major Richard Star Act is bipartisan legislation that would authorize concurrent receipt of Department of Defense (DoD) retired pay and Department of Veterans Affairs (VA) disability compensation for those injured in a combat zone and medically retired under Chapter 61 of title 10, United States Code. Currently, 50,000 military retirees with combat-related injuries qualify for retirement pay from both the DoD for their military service and for disability compensation from the VA for the injuries they sustained. However, for medically retired veterans with less than 20 years of service, the amount of their disability compensation is deducted from their military retirement pay. The Major Richard Star Act would repeal this unfair offset, allowing combat-disabled veterans to receive both their medically retired pay and VA disability compensation benefits.
- 3. S.414/H.R. 1083, Caring for Survivors Act is bipartisan legislation that would ease the eligibility criteria for Dependency Indemnity Compensation (DIC) and increase the monthly benefit amount to match benefits provided by other federal survivor programs. Specifically, the measure would:

Expand eligibility for DIC by replacing the 10-year rule with a graduated scale of benefits that begins at five years for initial eligibility at 50% and gradually reaches the full benefit at 10 years after determination of disability, and

Increase the amount of DIC to 55% of the rate of monthly compensation received by a totally disabled veteran.

The DAV supports the Caring for Survivors Act, which is in accordance with DAV Resolution Nos. 002 and 162.

- 4. H.R. 808, the Veterans Patient Advocacy Act, would direct VA Medical Center directors to ensure there is no fewer than one patient advocate for every 13,500 enrolled veterans. Additionally, it would also address the need for highly rural veterans to have access to the services of patient advocates assigned to rural community-based outpatient clinics. The Veterans Health Administration (VHA) has designated patient advocates at each VA Medical Center (VAMC) to receive and document feedback from veterans or their representatives, including requests for information, compliments, complaints and assist with clinical appeals. DAV supports H.R. 808, in accordance with DAV Resolution No. 056, which recognizes that staffing shortages and vacancies in the VA health care system, including critical positions like patient advocates.
- 5. In accordance with DAV Resolution No. 016, DAV supports H.R. 542, the Elizabeth Dole Home Care Act, legislation that would enhance the VA's program of long-term services and supports, and increase timely access to both institutional and noninstitutional long-term services to meet increasing demand. The VA must focus on addressing staffing and infrastructure gaps in order to maintain excellence in skilled nursing care. The VA also needs to expand access nationwide to innovative and cost-effective home- and community-based services, such as the veteran-directed care program and medical foster home care.
- 6. S. 326—the Veterans Programs Improvement Act of 2023 was considered in the Senate on Wednesday. This legislation includes provisions from five bills unanimously approved by the Senate Veterans' Affairs Committee (SVAC) in February. All of these bills are in alignment with at least one DAV resolution and includes the following bills:
  - S. 106, the Commitment to Veteran Support and Outreach Act (Resolution Nos. 014 and 059)
  - S. 141, the Elizabeth Dole Home Care Act (Resolution No. 427)
  - S. 185, the Native American Direct Loan Improvement Act of 2023 (Resolution No. 251)
  - S. 216, the RESPECT Act of 2023 (Resolution Nos. 059, 082 and 427)
  - S. 326, the VA Medicinal Cannabis Research Act of 2023 (Resolution No. 128)

This legislative package will help improve outreach and assistance to veterans and their families to ensure they are informed about veterans benefits and services; expand long-term care options for aging veterans and improve services for veterans and caregivers in VA's comprehensive caregiver program; offer better home loan options to Native American veterans and require the VA to conduct a study on the effects of cannabis on veterans with chronic pain or post-traumatic stress disorder. DAV supports this legislation in accordance with the resolutions listed above.
