Legislative Report October

Dear Comrades,

Once again I would like to start this report with an appeal for ALL members to <u>sign up for the CAN</u> Action Alerts and when you get an alert click that "Take Action" button. I can assure you as a

To proceed, sign into <u>https://dav.quorum.us/home/</u> and sign up for notifications. Once you do this you will receive email notifications with items that need our attention. This will result with you receiving alert emails. Once you receive the emails it is important that you click the act button and hit to submit a personal letter written to your representative.

These are the Commanders Action Notifications (4) that have been received since the July/ Aug report through this date. A more detailed explanation of these can be found in the DAV CAN site mentioned above.

H.R. 4424, the Vietnam Veterans Liver Fluke Cancer Study Act,

This legislation directs the Secretary of Veterans Affairs to conduct an epidemiological study on the prevalence of cholangiocarcinoma in veterans of the Vietnam era. Bile duct cancer (cholangiocarcinoma) is a cancer of the biliary duct system, which includes the gallbladder, bile ducts, and certain cells inside the liver. One risk factor for bile duct cancer is past infection with tiny parasitic worms called liver flukes, which are found in the fresh waters of Southeast Asia. Veterans who ate raw or undercooked freshwater fish during their service in Southeast Asia, such as Vietnam veterans, might have been infected.

H.R. 3489 The Restore Veterans' Compensation Act of 2023

This act would afford justice for ill and injured veterans by eliminating the unfair practice of VA recouping separation payments, which are based on their military service, and differ from Department of Veterans Affairs (VA) disability compensation. VA disability compensation can often be the difference between making ends meet and homelessness for many of our nation's disabled veterans, which is why the practice of withholding a veteran's VA disability compensation due to a non-related military separation benefit must end.

H.R. 4061-to Establish an Exposure Registry and Studies on the Red Hill Incident

The Red Hill Underground Fuel Storage Facility was originally completed by the Navy in 1943. It includes 20 underground fuel storage tanks for a total storage capacity of approximately 250 million gallons. The fuel stored at the Red Hill facility is used by ships and aircraft based at Joint Base Pearl Harbor–Hickam.

On May 6, 2021, 20,000 gallons of fuel leaked from a storage tank at the Red Hill facility. The Navy's water well nearest to the Red Hill facility was found to be heavily contaminated with diesel and petroleum hydrocarbons associated with gasoline.

H.R. 4150/S. 1954, the Improving Whole Health for Veterans with Chronic Conditions Act

The Improving Whole Health for Veterans with Chronic Conditions Act (H.R. 4150/S. 1954) would authorize the Department of Veterans Affairs (VA) to provide dental care services to enrolled veterans diagnosed with diabetes and heart disease.

H.R. 2818, the Autonomy for Disabled Veterans Act

H.R. 2818, the Autonomy for Disabled Veterans Act, would increase the amount of funding available to disabled veterans for improvements and structural alterations provided to them by the VA for home improvements related to their disability. Currently, veterans who need and receive Home Improvement and Structural Alterations (HISA) grants because of a service-connected disability receive up to \$6,800 and those who are rated 50% service connected or greater may receive the same amount even if a modification is needed because of a nonservice-connected disability. Veterans who are not service connected but are enrolled in the Department of Veterans Affairs (VA) health care system can receive up to \$2,000 for needed home modification.
