### Prince George's County Department of Social Services, Temporary Cash Assistance

**AGENCY: PRINCE GEORGE'S COUNTY DEPARTMENT OF SOCIAL SERVICES**

TEMPORARY CASH ASSISTANCE: Helps families become independent of welfare support through work, personal responsibility, and community involvement. FIP has a 5-year lifetime limit for benefits.

Provides cash assistance to needy families with dependent children when available resources do not fully address the family's needs and while preparing program participants for independence through work. To be eligible, a family must cooperate with child support, participate in work activities, comply with substance abuse provisions, and meet financial and technical eligibility requirements. Clients are required to participate in work activities for a minimum of 40 hours per week in exchange for temporary cash assistance.

NOTE REGARDING SANCTIONS: Non-compliance with program requirements can result in loss of entire cash benefit. Cash can be restored upon compliance. The family does retain Food Stamps and Medical Assistance during this time.
