 - December 16, 2019 December 26, 2019 Hotel was paid for by our Chapter. Due to the amount being under \$1,000 authorization was given by the Commander and Adjutant. MACV was working with the Veteran to find housing. Chapter 2 and Uptown VFW were also approached for additional funding but the issue was resolved.
