Commander's Column

Fellow members:

We as a sociality continue to struggle with the continuing effects of the COVID-19 pandemic. DAV Chapter #1 is moving toward a more normal operation, but still faces limitations. The safety of our members at meetings and engagements is our most important consideration!

Nomination for Chapter Leadership will be open on our Feb 1st meeting, continue at Mar. 1st meeting with the Election being on April 5, 2022. It is not too early to think about our spring elections. Being on the board can enrich your understanding of the chapter's operations and allows input on the direction of the chapter. The executive board is the vehicle where proposals for spending are discussed and approved before being brought to the General Membership meeting for a vote.

At our Feb. 1st meeting, we have a guest speaker, Trent Dilks, who is the DAV Department of Minnesota Legislative Director. The DAV MN is working hard to form a comprehensive legislative agenda. Here is a highlight of the top three priorities:

Amend the Property Tax Value Exclusion to ensure that surviving spouses are able to utilize the benefits intended.

Increase access to the outdoors through reducing or no-cost hunting, fishing and trapping for Minnesota disabled Veterans

Increase eligibility to the property tax value exclusion to all Veterans 50% and greater, permanent service connected. Also, we seek to make the percentage of disability the percentage of the \$300,000 the Veteran receives in exclusion. Examples 50% Service Connected gets \$150,000, 60% gets \$180,000, 70% gets \$210,000, etc.. This would increase the number of eligible Veterans in Minnesota by roughly 10,000 (a smaller amount of those are homeowners) and increase the level of exclusion for everyone below the current \$300,000 received by the 100% P&T disability, while respecting the fact that the most current available data does show the median home value in Minnesota, as a whole, is below \$200,000.

Attend our Feb. 1st meeting to ask Trent questions regarding these priority in person.

Adjutant's Column

Dear Members:

For 2022 Veterans disability compensation rates have increased by 6% to match Social Security benefits. To see what your new adjustment is please visit: <https://www.va.gov/disability/compensation-rates/veteran-rates/>

I also want to mention there has been an extension to the presumptive period for qualifying chronic disabilities rated 10% or more from undiagnosed illnesses in Persian Gulf War Veterans to December 31, 2026. If this change was not implemented, those whose conditions occurred after December 31, 2021 would have been at a greater disadvantage to those who have experienced conditions at an earlier date.

The VA has presumed certain medically unexplained illnesses are related to Persian Gulf War service. The following are some of the illnesses: chronic fatigue syndrome, fibromyalgia, functional gastrointestinal disorders. The following are also included as undiagnosed illnesses with symptoms that may include, but are not limited to abnormal weight loss, cardiovascular disease, muscle and joint pain, headache, menstrual disorders, neurological and psychological problems, skin conditions, respiratory disorders and sleep disturbances. Persian Gulf War Veterans who are experiencing any of the symptoms listed and other unexplained medical issues are encouraged to file a compensation claim.

In addition to the above, the VA has been working over the last six months and has begun processing service-connected disability claims for six new presumptive conditions related to environmental exposures during military service.

In May 2021, VA started implementing provisions of the William M. Thornberry National Defense Authorization Act for Fiscal Year 2021 (NDAA), adding bladder cancer, hypothyroidism and Parkinsonism to the list of medical conditions presumptively associated with exposure to Agent Orange. A few months later VA added asthma, rhinitis and sinusitis (to include rhinosinusitis) on a presumptive basis based on particulate matter exposures during military service in Southwest Asia and certain other areas.

Effective Oct of 2020 we are required to report all donations from estates to National Headquarters to ensure the "intent" of the donator is followed.

Are you over 70 ½ and required to complete an IRA Mandatory Minimum Distribution?

By doing a Qualified Charitable Distribution directly for your IRA to DAV Chapter #1, this money does not count as income on your tax return. Speak to your financial advisor or tax professional for details specific to your situation.

Any Veteran who was previously denied service-connection for any of these six conditions but had symptoms manifest within 10 years of military service would need to file a supplemental claim. Be sure to use VA Form 20-0995, Decision Review Request: Supplemental Claim when filing. The claim form should include the name of the condition and specify that the condition is being claimed due to in-service exposure to environmental hazards.

For filing a claim, please contact our local MN DAV NSO office at (612) 970-5665 to schedule an appointment.
