There are many ways we all can contribute to the success of our Chapter, whether it be participating on the Executive Board, attending a Membership meeting or financially.

We always welcome a personal check sent to our PO BOX or cash placed in our Forget Me Not buckets. I would like to let you know of two other means to financially donate, perhaps with a tax advantage.

The IRA Charitable Rollover: If you are aged 72 or older, you are eligible to make a **Qualified Charitable Distribution (QCD)**. This donation comes directly from your IRA to DAV Chapter #1, MPLS. It counts towards your required minimum distribution, but since it does not pass through your hands, it is not taxed as income. Inform the custodian of your IRA that you would like to make a QCD to DAV Chapter #1, Mpls. Each IRA has different forms, requirements timelines. Complete the requested form and have them contract our office (please leave a message) for our banking information.

The Donation of Stock: DAV Chapter #1, Mpls has recently setup a stock brokage account to allow us to handle donations for stock.

Adjutant's Column Cont.

There is a significant tax advantage of donating stock directly to a charity. If you donate the stock directly to a charity, there's no capital gains tax to pay. Plus, you are still eligible to deduct the full fair-market value of the asset you donated from your income taxes, up to the overall amount allowed by the IRS. Neither the donor or DAV Chapter#1, Mpls pays tax on this donation. We have an instruction sheet available (Edward Jones is our brokage agent) with full details of our brokage account numbers and bank routing numbers to handle this transaction correctly. Please contact the office for a copy of the Edward Jones Instruction Sheet. As always, please consult with your TAX Professional for detailed advice specific to you.
