Mankato Veterans Clinic Community Based Outreach Clinic (CBOC)

We have some somber news and some interesting news for the 1st quarter of 2022. Three Veterans who have been receiving care at Mankato CBOC committed suicide, which had effects of the Russian Evasion of Ukraine. If you know of anyone that needs help, Mankato CBOC has Social / Mental Experience Staff for assistance. Contact Clinic and set up appt, they are staffed 5 days a week and for other times there is a HOT LINE number to call. (Entire staff are devastated they really care for Veterans, so when I visited, I could feel their emotions.) Mankato DAV Chapter 10 provided monies to upgrade wireless headsets plus additional purchase of 8 more for Personnel front lobby and for in-call Nurses.

Dr Richard Hastings, is new Medical Director, he replaced, who we have known as Dr. K. Additionally new PA was added to Medical Staff. Clinic at this writing, is fully staffed.

Face masks are required when reaching the CBOC as well as all Staff Members.

Work has begun, and is in-process, at future location of Mankato VA Clinic. Mpls VA personnel have been onsite preparing the move, effective January 1 2023. New VA Clinic will be located in the former Madison Ave Shopping Mall, next to JoAnn's. All Medical Equipment will be furnished by Mpls VA.

Mpls VA, will staff the clinic as a VA Clinic. Additional services will be added at that time on a rotating basis: Podiatry, Audiology, Dermatology, Ophthalmology ... to what extent, is not known at this time. Current services will be continuing as before: Pharmacy, Dietary, Radiology, Blood Draw, Social/Mental and Primary Care. We are Veterans, We Care for our fellow Veterans, we all can help Veterans in many ways, do your best in Veterans helping Veterans.


