Historian

October 1, 1979 – After 70 years of American Control, the Panama Canal Zone was formally handed over to Panama.

October 3, 1863 – President Abraham Lincoln issued a Proclamation designating the last Thursday in November as Thanksgiving Day.

October 3, 1990 – After 45 years of Cold War division, East and West Germany were reunited as the Federal Republic of Germany.

October 5, q986 – Former U. S. Marine Eugene Hasenfus was captured by Nicaraguan Sandinistas after a place carrying arms for the Nicaraguan rebels (Contras) was shot down over Nicaragua. This marked the beginning of the "Iran-Contra" controversy resulting in Congressional hearings and a major scandal for the Regan White House after it was revealed that money from the sale of arms to Iran was used to fund covert operations in Nicaragua.

October 8, 1918 – During World War I, in the Argonne Forest in France, U.S. Sergeant Alvin C. York singlehandedly took out a German machine gun battalion killing over a dozen and capturing 132. He was later awarded the Medal of Honor and the French Croix de Guerre.

October 13, 1775 – The United States Navy was born after the Second Continental Congress authorized the acquisition of a fleet of ships.

October 14, 1947 – U.S. Air Force Captain Chuck Yeager became the first man to break the sound barrier, flying in a rocket powered research aircraft.

October 17-25, 1944 – The Battle of Leyte Gulf, the largest naval battle in history, took place off the Philippine Islands, during World War II in the Pacific. The battle involved 216 U.S. warships and 64 Japanese ships and resulted in the destruction of the Japanese Battleship *Musashi*, one of the largest ever built.

October 23, 1983 – Terrorists drove a truck loaded with TNT into the U.S and French headquarters in Beirut, Lebanon, exploding it and killing 241 U.S. Marines and 58 French paratroopers.

October 28, 1886 – The Statue of Liberty was dedicated on Bedloe's Island in New York Harbor. The statue was a gift from the people of France to commemorate the French-American alliance during the American Revolutionary War. Designed by Frederic Auguste Bartholdi, the entire structure stands 300 feet (92.9 meters) tall. The pedestal contains the words: "Give me you tired, your poor, your huddled masses yearning to breathe free, the wretched refuse of your teeming shore. Send there, the homeless, tempest-tost to me, I lift mu lamp beside the golden door!"

John Adams (1735-1826, the 2nd President, was born in Braintree, Massachusetts.

It seems like a broken record, but we are still short of the funds needed to buy the next round of vans. Please consider doing some fund-raising specifically for the Van fund. When you start planning your event, let Brigitte know as she may be able to get a van parked for display at your event so people can see what they are supporting. You may also have some local van riders who would be willing to come out and tell their stories to potential donors so the community can see how important this service is.

Remember, all fund-raising must be coordinated thru the Department IN ADVANCE.

Also, don't forget the F.E.M.A. fund – Future Emergency Management Account fund. Contributions to this fund are collected during Department Convention and Mid-Year conference.

All Chapters should have completed and submitted their Annual Financial Reports.

-Chapters with gross income of \$10,000 or more, excluding per capita dues received from National Headquarters should have sent the report to both National Headquarters and the Department Adjutant.

- -Chapters with gross income below \$10,000, excluding per capita dues received from National Headquarters do not have to send a report to National Headquarters, but are still required to complete the report and send a copy to the Department Adjutant.
- -Chapters with gross income exceeding \$300,000, excluding per capita dues received from National Headquarters require a review by a certified public accountant (CPA). The complete CPA review report to include the basic supporting backup documentation: Statement of Revenues, Expenditures, Assets and Statement of Cash Flows; the actual review must be accompanied filed with the properly completed Annual Financial Report form and all required supporting documentation. The report should have been sent to National Headquarters and a copy to the Department Adjutant.
- -Chapters who have not yet mailed their reports to the Department Adjutant can bring them to the Mid-Year Conference and give them to Adjutant Young in person

Financial Report Forms are no longer sent automatically from National, and I cannot obtain more than 2 copies of the form. You should prepare NOW for next year and request an Annual Financial Report Kit from National. Your Commander, Adjutant or Treasure and request them from the members area of DAV.org.

Your next big requirement is to complete your IRS 990n form on-line by November 30th. If you need help, bring your Chapter's financial information to the Mid-Year Conference and I will help you get the report filed.

The best way to submit your LVAP reports is by sending them via e-mail to <u>OregonLVAP@gmail.com</u> e-mail. If you mail them, please mail them directly to the LVAP coordinator Wanda Janus, 37615 SE Gordon Creek Rd, Corbett, OR 97019. Send them to arrive BEFORE the 3rd of the following month. Reports are closed by National on the 4th, so if I don't get them before that, our numbers will not be accepted. DO NOT SEND THEM TO THE DEPARTMENT COMMANDER OR ADJUTANT.

I strongly encourage you to send your LVAP hours via e-mail to: <u>OregonLVAP@gmail.com</u>. Be sure to include the following in each report:

- Your First and Last name
- Your DOB
- The Type of hours you are reporting (CSO/DSO, Fundraising, Outreach or Veteran Assistance)
- The number of hours for each type (if more than one)

If you send an e-mail for each day you earn LVAP hours, please also include the date you worked these hours. If you include hours for more than 1 day, please list all the dates covered by your report.

You can also report once each month, on the 1st of the month, all hours for the previous month by completing the attached LVAP forms and e-mailing to the <u>OregonLVAP@gmail.com</u>. Be sure to give (or e-mail) a copy to your Chapter LVAP coordinator and make sure they know you have already submitted them to <u>OregonLVAP@gmail.com</u> (so we don't double-report).

I will record hours in the National database on the 3rd of each month for the prior month. The system does not allow for edits after the report is submitted, so be sure to get your hours reported to me before that date.

Remember, before reporting your hours, you must be registered in the LVAP system. Complete the registration form only ONCE. You do not have to use your Last-4, but until National gets DAV-360 fully functional, it will help me if you do. With DAV-360, you will be required to provide a unique e-mail address (replaces last-4). If you don't have one, get your Chapter to set up a unique e-mail for you. We have asked to get this requirement changed because so many of our members do not have e-mail. But until that time, we will have to find a work-around.

The November ballot will also have on it measure #96 which will be a straight forward "YES" or "NO" vote. If you vote "YES" Veterans will receive 1.5% of the undesignated funds of the lottery. If you vote "NO" they will not. Spread the word about Measure #96 so the public can be informed.

If it does pass, The State House of Representatives "Ways & Means" Committee will determine how those funds will be disbursed.

There are different ways to stay informed on what is going on in Salem, the news media on TV and radio, & newspapers. The Oregon Department of Veteran Affairs has a website www.oregon.gov/odva. You can sign up for "Veteran Benefits" Magazine, "Vets News" newspaper, and learn about legislation in the current legislative session. The "Long" Session during the odd year sets budgets for the next two years and will have other legislation which could affect Veterans and their families.

- 2. Record yourself doing the push-ups and if possible post the video on social media
- 3. Nominate another person each day to take up the challenge
- 4. Most importantly, let every Veteran out there know that we are there for them when they feel alone.

I know that a lot of us in DAV are not able to do 22 push-ups in 22 days, but there are many ways to participate: Do a few at a time, do upper body push-ups or any other way you might think of. The bottom line is to make people aware that too many Veterans are taking their own lives every day and we need to do something about it.
