We are advancing in age and as we do there are important things we should gather to assist our loved ones at the time we pass on. I get phone calls where the caller says, "My husband passed away and he was a veteran. I need help getting benifits for his funeral."

Here are some items to do.now

- Get a copy of your DD214 (discharge papers) and have them where they can be found.
- If possible pre-arrange funeral details with your church and local funeral director.
- Gather important documents and make copies and store the original and any copies in a safe place
- Execute a last will and testament. ...
- Complete a living will or advance directive. ...
- Put in place a power of attorney. ...
- Consider a living trust. ...
- Update your beneficiaries. ...
