VA OK's 8 Camp Lejeune Related Presumptive Diseases

VA has determined that 8 medical conditions, (kidney cancer, liver cancer, non-Hodgkin lymphoma, leukemia, multiple myeloma, scleroderma, Parkinson's disease, and aplastic anemia or other myelodysplastic syndromes) provide presumptive eligibility for disability compensation. Presumptive means that once you satisfy the length of service at Camp Lejeune requirement of the final rule no other evidence is needed. Although veterans, family members or employees exposed between Aug. 1, 1953 and Dec. 31, 1987 are encouraged to immediately file claims, the effective date of any awarded compensation will be the date the final rule is published.
