

Q. What is a SpeciallyAdapted Housing (SAH) Grant **A**. The SAH Grant is designed to help provide a barrier-free living environment that supports a level of independence the claimant would not otherwise enjoy, such as a wheelchair accessible home. Check for details --- Service Officer - 267 254-9097

Q. What is a Special Home Adaptation (SHA) Grant

A. The SHA Grant helps modify an existing home to meet adaptive needs, such as assistance with mobility throughout the home. Veterans and servicemembers with specific service-connected disabilities may qualify. A temporary grant may be available to qualified applicants who/are temporarily living in a home owned by a family member. Details -- VA - 800 827-1000 --- (Naomi) -- 267 254-9097

Elder Care Benefits for Veterans

Many veterans and/or their families are not aware of the elder care benefits available through veterans health care, state veterans homes, home renovation grants (HISA Grants) or 2 disability income programs called Compensation and Pension. One program, called 'Veterans Pension" or commonly known as 'Veterans Aid and Attendance Benefit', can be used to pay for 'assisted living' for the veteran or the veteran's spouse. It can also be used for nursing home care for the veteran or his spouse. For detailed info contact Leonard Johnson, 267-254-9097.
