What is IU?

Individual Unemployability or IU is the basis on which the Department of Veterans Affairs (VA) pays service-connected disability compensation at the rate payable for a 100-percent evaluation to qualified veterans with combined evaluations that are less than 100 percent. To qualify veteran must meet minimum combined evaluation criteria and, in the judgment of the rating official(s), are unemployable due solely to their service-connected condition(s). Elder Care Benefits for Veterans

Many veterans and/or their families are not aware of the elder care benefits available through veterans health care, state veterans homes, home renovation grants (HISA Grants) or 2 disability income programs called Compensation and Pension. One program, called 'Veterans Pension' or commonly known as 'Veterans Aid and Attendance Benefit', can provide up to \$1,949 a month to those who qualify. This program can be used to pay for 'assisted living' for the veteran or the veteran's spouse. It can also be used for nursing home care for the veteran or his spouse. Naomi Q & A

Q. Can a Veteran receive VA benefits while in prison?

A. Yes, certain benefits can be paid to veterans incarcerated in a Federal, state or local penal institution.

Q. What about VA Disability Compensation?

A. Beginning with the 61st day of your imprisonment for a felony, if your prior rate payment was greater than 10%, your new payment amount will be at the 10% rate. If your prior rate was 10%, your new rate will be half the 10% rate. There is no reduction for a misdemeanor.

Q. What about VA Disability Pension?

A. Your Pension will be discontinued, effective the 61st day of imprisonment following conviction of a felony or misdemeanor.

Q. Can Dependents receive any of the money withheld?

A. All or part of withheld benefits can be apportioned to your dependent spouse, children or dependent parents based on individual need. Application should be made to nearest VA regional office or Veterans Service Organization (VSO) {DAV, VFW, VVA, etc.}
