#### **VA's Modernization of the Claims Process Continues**

Early this year, the Veterans Benefits Administration (VBA) began extracting hundreds of thousands of inactive-claim records from regional offices east of the Mississippi for digital conversion. Inactive-claim records are claim files that have been settled and have remained inactive for a number of years. The initiative will help reduce processing time for thousands of new claims associated with inactive records.

In the past, VBA only digitized inactive-claim records when Veterans or their family members filed new disability or Dependency Indemnity Compensation claims. The business process added days to the claims' adjudication process as files still needed to be boxed, shipped and digitized before review of the new claim could even begin.

#### Senators Warner and Kaine Introduce Legislation to Overhaul Broken VA Appeals Process

U.S. Senators Mark R. Warner and Tim Kaine joined a group of fourteen Senators in introducing legislation to overhaul the Department of Veterans Affairs' broken appeals process. The process has not been updated since 1933, and more than 450,000 appeals are currently pending. Because of redundancies and inefficiencies in the current process, most veterans wait years for a decision on their appeals. By replacing the current process, the Department of Veterans Affairs Appeals Modernization Act would expedite appeals before the Board of Veterans Appeals and give veterans clear options after receiving an initial decision.

#### Hearing on VA Recruitment and Retention Authorities:

On Wednesday, the House Veterans Affairs Subcommittee on Health held a hearing to discuss ways to improve VA's ability to recruit and retain high quality health care professionals. The members of the subcommittee explored ways to expedite the hiring process to ensure candidates aren't required to wait months to be hired by VA. VFW National Legislative Service Director Carlos Fuentes submitted testimony urging Congress to give VA direct hiring authority for frontline staff, who currently wait up to six months for an entry level job. VA testified on its challenges with human resources staff and agreed that having more direct hire authority for health care staff would improve its ability to deliver timely and high quality care to veterans. **Read the testimony** 

#### VA Mental Health Care for Vets with OTH Discharges:

During a hearing before the House Committee on Veterans' Affairs on Tuesday, Secretary of Veterans Affairs David J. Shulkin announced that VA will no longer turn away veterans seeking urgent mental health care simply because they received other-than-honorable discharges. VA plans to implement the new rule later this year. <u>More information on this initiative.</u>

#### **Online Listing for all VA Cemeteries**

VA announced this week that there will be an online listing of burial times for all VA cemeteries. The move, which will cover the 168 facilities operated by VA directly, will allow those who wish to attend the funerals a more centralized location for information related to the funeral. Attendees will be able to search by either the location of the funeral or by the name of the veteran being buried, and updates will be provided hourly. To visit the website, click here.
