

I would like to call your attention to the following change in the Department of Texas Bylaws. These assessments need to be mailed to Department Headquarters as soon as possible. A chapter that has not paid their assessment will not be cleared to vote at the Department Convention.

**ARTICLE I - DEPARTMENT CONVENTION** \*SECTION 1.

\* Para (a). Each chapter shall be assessed the following to be deposited in the **Department Convention Fund:** 

> \$5.00 - 100 members or less \$10.00 - 101 to 1,000 members \$15.00 - 1,001 to 3,000 members \$20.00 - 3,001 members or more

For example, if your chapter has 650 members, it will owe \$10.00.



#### from the Women Veteran Coordinator

#### More Women Veterans Firsts:

Lt Edith Greenwood was awarded The Soldiers Medal in 1943 for heroism during a fire at a military hospital in Yuma Arizona the first woman to receive this award.

llogg The first woman to receive The Air Medal was Lt Elsie S. Ott awarded for her actions in |@va 1943 as an air evac nurse. As the flight nurse on the first intercontinental air .gov evacuation flight, 2nd Lt. Elsie S. Ott demonstrated the potential of air evacuation in January 1943. An Army nurse who had never flown in an airplane and had no air

evacuation training, she successfully oversaw the movement of five seriously ill patients from India to Washington, D.C. This six-day trip would have normally taken three months by ship and ground transportation. For her actions on this historic flight, Ott received the first Air Medal presented to a woman, and she also received formal flight nurse training.

Barbara Olive Barnwell was the first woman awarded the Navy-Marine Corps Medal for heroism in 1953. Barbara Barnwell, a SSGT from Pittsburgh Pennsylvania and a member of the Marine Reserve, saved a soldier from drowning in 1952.

Colonel Oveta Culp Hobby, the first Director of the WAC, was the first woman to receive The U.S. Army Distinguished Service Medal in 1945. Source: userpages.aug.com/captbarb/firsts.html

#### Does VA provide maternity benefits?

VA provides maternity benefits to eligible women Veterans. Public Law 111-163 authorizes VA to furnish health care services, for not more than 7 days, to a newborn child of a women Veteran who delivered the child in a VA facility or in another facility pursuant to a VA contract for such care.

Children born to women Veterans who served in Vietnam may also be eligible for monthly monetary benefits, medical care, and vocational training if they have certain birth defects linked to their mother's service. Contact the nearest VA regional office on the nationwide toll-free number, 1-800-827-1000, information eligibility for and requirements, or visit VA's home page at www.va.gov.

How can I receive gender-specific services, including Pap smears, mammography, prenatal and childcare?

Apply for VA health care enrollment by completing VA Form 10-10EZ which may be obtained by visiting, calling, or writing any VA health care facility or Veterans' benefits office. You can also call toll-free 1-877-222 VETS (1-877-222-8387) or access the form on the Internet at www.va.gov. The provision of health care to non-Veteran children is limited to those instances where specific authority is given to VA by law. Contact your local VA health care facility and ask to speak with the Women Veterans Program Manager (white pages of the telephone directory under U.S. Government, Department of Veterans Affairs).
