One of our goals is to help our veterans fill out their disability claims. As such, veterans should file disability claims with VA officials promptly through one of our service representatives. All this is because if a disease is recognized as presumptive for service connection their benefits may be retroactive to the date of filing their disability claims. For information, the VA maintains website а (www.vba.va.gov/bin/21/rates/) of benefits tables. Another key goal in the DAV organization is membership for our chapters; there are many disabled veterans that are not DAV members. There are several ways we can seek-out eligible disabled veterans and one way is short of conducting a membership drive is to have an invite open house within one's meeting place. Also remember that many disabled veterans do go to the VA hospitals and/or clinics for treatment, so, it all depends on how you may be attracting our disabled veterans to join a

chapter of their choice within the perspective living area or a chapter they may want to attend instead. As we all seek-out disabled veterans, there is still a lot of Iraq and Afghanistan disabled veterans who are DAV members. We need to recruit our younger disabled veterans to be part of our chapter membership and fill key leadership roles as Vietnam veterans filled key leadership positions held by WWII and Korean disabled veterans before us.

A reminder to all chapters to complete your delegate and alternate list for the upcoming convention in Austin (June 3-5, 2011). Again, as previously mentioned in my last article, I encourage all chapter commanders that may not be able to attend or have a delegate member at the Department Convention to please provide me with any issues I may bring up at the convention on your behalf. While I may not be able to vote for you, I can still bring up issues or concerns a chapter may want brought up at the convention for discussion.

As District V Commander, I have attended and participated in the Pilgrimage to the Alamo, Fiesta Flambeau Parade and All Veterans Memorial Service during the Fiesta San Antonio which was held April 7-17, 2011. I have also participated in a JROTC Awards Ceremony held at Thomas A Edison High School.

BPT / LEGISLATIVE REPORT

Greetings Comrades.

We are in the process of seeing an attempt to erode Veterans Benefits in the name of a Balanced

Budget. No, I am not an alarmist. Think of the following – No New Taxes, the need to reduce entitlements (Medicare, Social Security, and Veterans Benefits) to achieve a Balanced Budget as Promised in Political Ads and Speeches. No you say – they tell us "we thank you for your service" and "we love our Veterans". Talk is cheap, you can't take it to the bank. Remember – Entitlements include Veterans Benefits.

A first shot at Veterans is in HB 1 from the House Veterans' Committee – Rep. Culbertson Chairman. This includes elimination of HUD Housing Vouchers for Homeless and Low Income Veterans. We need to advise ALL of our Texas Representatives that We Will Not Abandon Our Comrades. Since it is "hidden" in HUD Funding I guess they figure we will not notice.

You may ask: How will they get at Veterans Benefits?" Easy – it has already started. Step 1 – Delay the process of Awarding Benefits, slow discourages the Disabled Veteran - as Representative Culbertson stated "if improvements in the processing system require additional funds it won't happen." Step 2 - Deny cost of living raises. Step 3 - Create barriers to veterans access to VA Health Care. Step 4 -Delay the Implementation/Regulation Process for new categories of disabilities, many Parkinson's Veterans have been waiting over 12 months to receive awards - these are severely disabled veterans. You can probably see some other things that keep veterans from receiving the benefits promised and earned - "We thank you for your Service" is cheap.

State of Texas – ALL Field staff of the Texas Veterans Land Board are laid Off as of 6/30/2011 – learn Facebook, TWEET or TWITTER – still happening, They have their notices. Texas Veterans Commission will lose 20 of the 100 Veterans Staff assigned to help veterans File claims – this hits disabled veterans hard because the claims process is going to become slower and more complicated.

If you thought that the funds disabled veterans receive is considered an asset to Texas you will be disappointed – Susan Combs, the State Comptroller, in a written opinion states: there is No significant impact on State Revenues from benefits paid to disabled veterans. When you consider that there is over \$ 1.5 Billion paid annually to Texas Disabled Veterans with at least \$ 80 million of that collected in Sales Tax it appears that Ms. Combs does not care about disabled veterans and she cannot count \$ well enough to do the Comptroller Job.

If you care about your veteran comrades write your Congressional Representative (or FaceBook, Tweet and Twitter them)If you care about the future of Veterans Benefit Programs RECRUIT new members – numbers count

WE are all in the same boat – START BAILING – Speak up at local meetings, Speak to local Congressional Staff. Do not accept "I Love and Respect you" as acceptable payback for your sacrifice.

Remember – If we do NOT ACT NOW we will Look at OUR Current Veteran Benefits as "the good old days".
