

money for your chapter and to recruit new members. A free meal is not bad either.

A couple of items of good news. On the state level we have authorization to include the word Veteran on our Drivers Licenses. This will be useful for ID at those businesses that provide a veterans' discount. At the Federal level there has been enough movement in the Consumer Price Index to create a rise in the Social Security payments/cost of living. Since Veterans Benefit increases were tied to Social Security, by Law, last year we will see a Cost of Living Increase (Unless Congress specifically cuts it as a "Deficit Reduction Item"). Some hope for us.

Please stay in touch with your US Representatives and Senators. I have the opportunity to read many of the letters that are sent to Washington, DC and the responses. The response that always "frosts my chops" is: the " benefits we have provided to Veterans".

The particular award I am talking about is in the VAVS Program known as the "Jesse Brown Memorial Youth Scholarship Award." In order to qualify for nomination, the

candidate must be 21 or under, and must have a minimum of 100 hours in the previous calendar year. All volunteer hours must be credited to the DAV. Hours accumulated under the Local Veterans Assistance Program (LVAP) are also eligible for consideration.

One nomination from each VA facility within the state may be accepted. In addition to Department Commanders and VAVS Program Managers, the student may also complete a self-nomination form. Nominations may also be received from DAV Chapters, DAVA Units, and all DAV and DAVA Representatives and Deputy Reps.

Detailed information concerning the award itself, volunteer opportunities, volunteer benefits, and eligibility as well as nomination forms can be found on the National DAV website---**www.dav.org** under Voluntary Services.

There are many youth volunteers across the state that are very deserving of this award recognizing them for their patriotism in being dedicated to helping our disabled veterans. Please give them a chance.

#### Items of Interest

On Tuesday, November 8th, 2012, a Constitutional Amendment election will be held. One proposition directly affects the Texas veteran community: Propositions 1. Full details follow.

Please distribute this message to your individual members, encourage them to get registered to vote, and to vote for the passage of Proposition

#### General Information

In the 2011 Regular Session, the 82nd Texas Legislature passed 10 joint resolutions proposing amendments to the state

constitution, and these proposed amendments will be offered for approval by the voters of Texas on the November 8, 2011, election ballot.

★ACROSS THE STATE

Texas Constitution provides The that the legislature, by a two-thirds vote of all members of each house, may propose amendments revising the constitution and that proposed amendments must then be submitted for approval to the qualified voters of the state. A proposed amendment becomes a part of the constitution if a majority of the votes cast in an election on the proposition are cast in its favor. An amendment approved by voters is effective on the date of the official canvass of returns showing adoption. The date of canvass, by law, is not earlier than the 15th or later than the 30th day after election day. An amendment may provide for a later effective date.

From the adoption of the current Texas Constitution in 1876 through November 2009, the legislature has proposed 646 amendments to the constitution, of which 643 have gone before Texas voters. Of the amendments on the ballot, 467 have been approved by the electorate and 176 have been defeated. The other three amendments were never placed on the ballot, for reasons that are historically obscure. See the online publication Amendments to the Texas Constitution Since 1876 for more information.

The Analyses of Proposed Constitutional Amendments contains, for each proposed amendment that will appear on the November 8, 2011, ballot, the ballot language, an analysis, and the text of the joint resolution proposing the amendment. The analysis includes background information and a summary of comments made during the legislative process about the proposed constitutional amendment by supporters and by opponents.

# Allowing surviving spouse of disabled veteran to receive homestead tax exemption

SJR 14 Van de Putte (C. Anderson) Background

Texas Constitution, Art. 8, sec. 1(b) requires that all real and tangible personal property be taxed in proportion to its value unless exempted as authorized by the Constitution. Art. 8, sec. 1-b(i), added in 2007, authorizes the Legislature to exempt from property taxes all or part of the value of the residence homestead of a veteran certified as having a service-related disability of 100 percent or as totally disabled. Tax Code, sec. 11.131 fully exempts the value of the residence homesteads of 100 percent or totally disabled veterans from property taxes.

Veterans are considered 100 percent disabled based on the extent of their physical disability. Total disability is based on employment capability. A veteran may qualify for the tax exemption under either disability category, as defined by the federal Veterans Administration.

#### Digest

Proposition 1 would authorize the Legislature to allow the surviving spouse of a 100 percent or totally disabled veteran to receive a property tax exemption for a residence homestead if the disabled veteran qualified for the exemption when the veteran died. The exemption would be the same portion of the market value of the same property to which the disabled veteran's exemption applied. A homestead would qualify if:

• the property was the residence homestead of the surviving spouse when the disabled veteran died;

• the property remained the residence homestead of the surviving spouse; and

• the surviving spouse had not remarried since the disabled veteran died.

Proposition 1 also would authorize the Legislature to allow the exemption to follow the surviving spouse to a new homestead if the surviving spouse had not remarried after the death of the disabled veteran. The exemption would be limited to the dollar amount of the exemption for the previous qualifying homestead as of the last year in which the surviving spouse had received the exemption.

The change would apply starting with the tax year beginning January 1, 2012, and would apply only to tax years after that date.

The ballot proposal reads: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a 100 percent or totally disabled veteran."
