#### **DAV COMMANDER**

I have just returned from the State Commanders & Adjutants Association Orientation in Cold Spring, Kentucky. I was privileged to meet the faces to all the names I already knew. This was a great informative meeting which gives me greater insight to the mission of the organization.

We, as the DAV, have one single purpose in mind. We have come together for the purpose of building better lives for all of our nation's disabled veterans and their families. Our chapters, working with the veterans on a first-hand basis are going to work providing assistance to those in need of our help.

The DAV is here to carry the message to all veterans regardless of their time of service to let them know there is someone who cares and is here to help you. Then we begin to extend the DAV's mission of hope to all of the area cities and towns around our chapter location.

When I came home from Vietnam in 1972, there was no one to greet me. Here I was, released by the military with a service connected life threatening injury and no one to assist me. I did not know where to turn. I had an appointment at the Dallas VA Medical Center, where I met the National and Department Service Officers of the DAV. They went to work immediately to make certain I received every single benefit I was entitled to because of my service connected injuries. I was so glad that someone was willing to fight for me that I asked how to become a member. The rest of my story is history.

The service this organization provides is needed even more today than it was when this great service oriented fraternity began. Our Iraqi, Afghanistan, War on Terror veterans needs us just as much as we need them. We must always remember that first and foremost we are committed to fulfilling the mission of building better lives for America's disabled veterans and their families. We have and will continue in this

mission through service, quality, integrity and leadership in representing and advocating our support now and in the future.

The Disabled American Veterans maintain the highest ethical standards as a charitable organization through which our society can express it's gratitude to the men and women who will, for the rest of their lives, pay the price of our nation's freedom. Since it's founding in 1920, we have been dedicated to this purpose.

We are living in unique times. Our lives are changing daily. Our soldiers are coming home with injuries which require someone who can understand their needs. In one instance a returning Iraqi veteran was failing in her classes in college. She had been an "A" honor student prior to joining the Army and going to Iraqi as a squad leader in an infantry unit. Why was Upon being observed by a Disabled she failing? American Veteran Service Officer he noticed she spent every minute of the class looking around her, not paying attention to the instructor. As the Service Officer spoke with her it was determined that she led patrols through the streets in the city of Kabul. She did not know what was at the next hallway, which was looking in the window, who was coming in the door. She was always on alert.

After speaking with her instructor she was moved to the very back of the room. She had only one place to look now, in front of her. It took a veteran who understood her needs to help her turn the corner on becoming a successful civilian and a viable part of society again. The injuries to our soldiers are not always noticeable. Their injuries may be immediately known because of the missing limb. But can you see the needs of a veteran who spent years in captivity as a POW just by looking at them? No, you can't and you cannot treat him with the same medications and therapy you would treat the veteran with the missing limb.

#### **BPT / LEGISLATIVE REPORT**

It is time to start packing for the National Convention in New Orleans. It should prove both interesting and informative. The Big Issue - Hopefully Resolved - is the: Debt Ceiling and the "Negotiations" about Raising It. Our "DOG is in that Fight". If the issue is not resolve there will be NO disability checks from the VA and NO checks from Social Security. If that does not get you to contact your local congressional offices (Senate and House) your budget looks better than mine. If you do not need the check think of all your Disabled Comrades who do. We have older Veterans who "get by" on Pension checks of \$ 985 a month. Please, call your LOCAL congressional office and advise them that not seeing a deposit in your account on September 1, 2011 would annoy you enough to remember their name on November 12, 2012.

Do not accept "cop outs". They will tell you about "difficult" negotiations. Respond about "difficult payments for housing, utilities and food".

The next new tactic is "Costing Out" proposals to enhance the benefits we receive. This will affect such things as COLA and expansion of veterans disability entitlement. We will, soon, be asked to support cuts in future benefits for the returning veterans as a trade off for not having our benefits cut. If you think I'm kidding then you have missed the "Behind the Scenes in DC" segment of how "The Politics Turn". This is a very popular afternoon soap in DC. It always ends with "Don't you just Love our Military and our Veterans?"

There is a name you may not remember, Chou. He was head of Human Resources for the Department of Defense under President Bush. He proposed cutting veterans' benefits and transferring the savings over to the Pentagon budget. He is now a "highly respected consultant to the "cut the budget" factions. He is now saying that we cannot afford our military with the kind of pay and benefits we are paying. His proposal is to cut personnel, pay, health benefits and retirement for the career military as a way of "Cheating" the defenders of our country. I do not think he has forgotten the veterans, I believe he realizes that if he can get his "reduction" of active duty benefits accepted for negotiations he can then offer the veterans as an alternative sacrifice.

If you care about your veteran comrades write your congressional representative (or Face Book, Tweet and Twitter them) or, better yet, stop by their local office and let them know you care about their position on the issue of veterans benefits.

If you care about the future of veterans benefit programs RECRUIT new members – numbers count We are all in the same boat – START BAILING – speak up at local meetings, speak to local congressional staff. Do not accept "I love and respect you" as acceptable payback for your sacrifice. Remember – if we do NOT ACT NOW we will look at OUR current veteran benefits as "the good old days".

# **WOMEN VETERAN COORDINATOR**

Margaret Cochran Corbin

"The First American Woman to Take A Soldier's Part in the War for Liberty"

Women have served, with honor, in the United States Armed Forces since the Revolutionary War when Margaret Corbin fought at Fort Washington. Margaret's husband, John, joined the Continental Army at the start of the Revolutionary War and she accompanied her husband, as many women did. On November 16, 1776 the Corbin's were stationed in Fort Washington, NY, when the fort was attacked by Hessian and British troops. John Corbin was assisting a gunner, who was manning cannon, and took over when the gunner was killed. thereafter, John was killed, and Margaret, who was assisting him, was loading and firing the cannon by She drew attention from the British and Hessian armies due to her aim and accuracy. At the end of the battle, Margaret was found severely wounded. She had injuries from 3 musket balls and grapeshot, which had damaged her left arm, chest and jaw. After treatment, she was paroled and in 1779 Congress awarded her a disability pension due to her distinguished bravery. She was included on the regimental muster lists until the end of the war in 1783 and is the only woman interred with other soldiers behind the Old Cadet Chapel at West Point. American woman to take a soldier's part in the War for Liberty."
