#### **DAV Hails Vet Jobs Initiatives:**

The Disabled American Veterans was at the White House today when President Obama announced a trio of new initiatives to increase hiring of veterans, improve resources for them to translate their military skills for the civilian workforce and provide them with new tools to aid their search for jobs.

Washington Headquarters Executive Director Barry Jesinoski stated, "As of October, over 850,000 veterans were unemployed. For post 9/11 veterans, the unemployment rate is 12.1 percent, compared to 9 percent for the entire country. That is simply unacceptable."

The Disabled American Veterans welcomes any and all efforts to boost employment opportunities for veterans," Jesinoski said. "These new initiatives can make a real difference in the lives of jobless veterans and their families."

#### **New Tool Helps Veterans Connect to Resources:**

Veterans and their families now have another tool to help them find information and the support they need to help them meet life's challenges. In addition to connecting users to resources for issues affecting their health, well-being and everyday lives, the site features inspiring true stories from other veterans who faced life events, experiences, physical ailments or psychological symptoms and found ways to overcome their challenges.

#### **New Website for VHA Health Benefits Information**

Veterans and their families have a new resource for information about VA health care. The Veterans Health Administration's Health Eligibility Center at <a href="www.va.gov/healthbenefits">www.va.gov/healthbenefits</a> is an online portal for veterans, family members and care givers to learn about eligibility, enrollment options and benefits offered by VHA. It also provides detailed information about how to apply for VHA health services, cost of care, accessing VA health care and VA's Medical Benefits Package.

**WASHINGTON** – The Department of Veterans Affairs (VA) has embarked on a major initiative to reach out to women Veterans in order to solicit their input on ways to enhance the health care services VA provides to women Veterans.

"We are taking a proactive approach to enhancing VA health care for women Veterans," said Secretary of Veterans Affairs Eric K. Shinseki. "We are seeking the input of women Veterans so that VA can continue to provide high quality health care to the growing numbers of women Veterans."

Representatives at VA's Health Resource Center (HRC) are placing calls to women Veterans nationwide, asking them to share their experiences with VA and suggest potential enhancements that will further VA's mission to provide the best care anywhere.

Women Veterans are one of the fastest growing segments of the Veteran population. Of the 22.7 million living Veterans, more than 1.8 million are women. They comprise nearly 8 percent of the total Veteran population and 6 percent of all Veterans who use VA health care services.

# Great News!!!!! The Eligibility Amendment Has Been Ratified

What does this mean? A new day has dawned for the DAV Auxiliary! *Effective immediately*, this amendment not only expands DAV Auxiliary eligibility requirements, it opens the door to a new horizon for our organizations (DAV and DAV Auxiliary).

What effect will this have on my Auxiliary unit? This change will cultivate membership growth and allow those new members to help with the mission of service to disabled veterans and their families. Our leaders are committed to the long-term stability and growth of our organizations and with new enthusiastic members we will be able to accomplish a great deal more.

Who is eligible for membership in the DAV Auxiliary? The good news is the DAV Auxiliary can now welcome those who were not eligible under the previous structure. Eligibility has been expanded to include:

- Family and extended family members of any person who is or was eligible for membership in the DAV.
- Family and extended family members of any person injured and may still be in active service in the armed forces of the United States of America and eligible for membership in the Disabled American Veterans.
- Family and extended family members of any person who has served in the armed forces of the United States of America and has not been dishonorably discharged or separated from such service.
- Family and extended family members of any person who served with the armed forces
  of any nation associated with the United States of America as an ally, who was
  honorably discharged, and became an American citizen.
- Family and extended family of Auxiliary members who are not otherwise eligible for membership are eligible for membership in the Disabled American Veterans Auxiliary.

**What is considered extended family?** Some examples of extended family are, but not limited to: step-children, step-grandchildren, step-siblings, step-parents, step-grandparents, uncles and aunts, great uncles and aunts, nieces, nephews, cousins, sons and daughters in law, fathers and mothers in law, brothers and sisters in law.

Are you aware of the Bexar County Veterans Treatment Court? The VTC is held at the County Court at Law #6, on the 2nd Floor (North end) of the Cadena-Reeves Justice Center, at 300 Dolorosa Street, San Antonio, Texas 78205. The Honorable Judge Wayne Christian is the presiding judge. Court generally starts at 3:00 p. m. We suggest being there at about 2:55 PM to ensure that the court can be conducted with minimum disruption. You are welcome to attend and observe the court proceedings. We encourage you to invite other veterans as well. With new participants being accepted to the VTC at the last docket in December, the total number of participants will surpass 50. Participants in Phase 3 of the program are normally excused from attending the second docket of the month.
