
Ten years later: Remembering 9 /11



December 7, 1941, a date before the time of my birth. My parents and grandparent talked about that day. Their stories and vivid memories, of where they were when the news came and the impact of the events upon their lives, filled my childhood and adolescent years. In our reflections are the silhouettes of our fellow veterans who paid the ultimate sacrifice that we continue to remain united in purpose and free.

### **DAVA NEWS, Chapter 128**

#### First Place Community Service Award

Chapter 128, DAVA members engage in three areas of service throughout the year. Services were provided to a variety of members of the military community under the three categories of: Family Service; General Service to the Community; and Special Projects and Programs. At least one unit member had to have performed services in at least one category in order that the Unit be considered for the award. One or more members provided service in the **Family Services** area. Types of services include:

- Nursing home and hospital visitations
- Transportation assistance for senior citizens
- Professional and Trade Services
  - Donation of hair styling service
  - Participation in 44 hours of Citizen Police Academy Training
  - Service on Citizen Advisory Action Board reviewing cases investigated by the San Antonio Police
  - Membership in the Edwards Ministerial Association which provides scholarships to students
  - Presentation as speaker at the San Antonio Adult Probation on "Women in the Workplace"
  - Served as Moderator of Job Fair Seminar for Federal Job Opportunities
  - Volunteer at "Soldiers Angels" opening over 2000 envelopes from citizens to be forwarded to active duty military.

Similar types of activities are included under the category **General Services to the Community**. Activities in which some or all members of the Unit participated are:

- Church and church related activities and religious events
- Volunteer service at the Fisher House, Lackland Air Force Base TX
- Clothing donations to the Haven of Hope homeless shelter
- Preparation of meals for the elderly and families needing assistance
- Sponsored a program by the Army Liaison Specialist, Ft. Sam Houston, "How You Can Assist Families of Wounded Warriors
- Recreation and Entertainment:
  - Assistance at the Chapter Annual Thanksgiving Banquet
  - Assistance with putting up decorations at Audie Murphy VAMC.


The final area of activities considered for the award is titled Special Projects and Programs. Under this program area individual unit members gave and /or provided the following gifts and services:

- Financial support to organizations such as Purple Heart, Salvation Army, Special Olympics, March of Dimes, Komen Cancer Fund, Feed the Children, St Jude Children's Hospital, Other Veteran Organization and individual student scholarship support
- Prepared an essay of 25 pages presented to First Lady Michelle Obama focused on life as a military spouse, the rewards received and challenges encountered, with a written acknowledgement from Mrs. Obama
- Distribution of welcome packages to family members of military members recuperating at Brook Army Medical Center (BAMC) now San Antonio Military Medical Center (SAMMC)
- In addition to individual acts the unit provided cash donations to
  - Fisher House
  - Haven For Hope
  - Audie Murphy VAVS Program
  - Audie Murphy Christmas Fund.

Members of Roy B. Hodges Chapter 128 DAVA contributed many hours in service to the community through personal commitment. These acts were not done for recognition but through caring and compassion, which is foremost in the activities and daily lives of these members. Their efforts earned them the First Place for Community Service Award accepted on behalf of the membership by Commander G. Smart at the Department Convention held in Austin, TX June 2-5, 2011.
