#### **Other News**

Yesterday, 21 April, 2009 at 2PM, Chapter 61 representatives and City Staff sat down to preview the Lease agreement for the Vaughan Street Firehouse. As you may have heard the Fire House was approved for our use by the City of Seguin 2 weeks ago.

At the meeting, I, Senior Vice Commander Tomas Castellon, Chaplain Jesse Ayala, Treasurer Bill Owen, and Immediate Past Senior Vice Commander Phil Sierer represented the Chapter. Representing the City was Assistant City Manager Rick Cortez and City Councilman Tomas Castellon (wearing two hats).

We went over the 4 page lease agreement line by line. While there are a number of small details that are pretty standard with any lease, in this memo I will discuss the 3 major topics we considered sticking points.

1. The lease is a 10 year lease with an option to extend at the end of that lease. The lease is for \$1 a year. Originally, there was a 180 day termination clause, but we asked that be changed to a 1 year (365 day) termination clause that can be executed by either party. We felt this gave us some of the protections that we were looking for to protect our investment in making the place fit for occupancy. The Asst. City Manager assured us that all possible uses of the building had been considered before deciding to lease the building to Chapter 61 and that they saw no reason why they would consider asking us to vacate.

- However, he could not speak to what a new administration might decide (understandable).
- 2. Chapter 61 will have to obtain a Letter of Occupancy (LO) from the The Fire House City. abandoned for about 6 years and use discontinued because new Houses were built to meet current standards and codes. We will have to bring this building to code in order to obtain the LO. This means that we will have to bring the building up to ADA standards, upgrade electrics, maintain the interior and exterior, put approved signage Approved) to identify our presence, and bring the building up to fire prevention standards. Most all these items can be conducted with sweat equity (that means we're going to have to do some work). The Chapter is going to have to pull together to make this happen. If you have a skill, we will need it. If you are unable to work, maybe you can donate materials like a door, exit sign, fire extinguisher, plain money, etc.
- 3. The Chapter must maintain a \$1 million dollar insurance policy to cover liability and property. This is standard and non-negotiable due to similar leases throughout the City. This is probably the major sticking point as I don't know what a \$1M policy will cost, but we're looking into the issue.

Those are the 3 main points of interest to this lease. We are pretty excited about this and see it as a great opportunity to expand our services and have a greater ability to raise funds. This will give us a significant location from which to operate adding parking, separate interview rooms for Claim

Service Work, give the DAVA a home of there own and provide a large meeting area.

We will have until July 1<sup>st</sup> to get the building ready for occupancy, which is when the lease will be signed. I hope I can count on the members to step up and help out with this move; we are going to need it. We can make this a home to be proud of if we work together.
