He became increasingly irresponsible as a father and as a husband, so his wife took their sons back home to Oregon until he faced his life head-on

Told by his coach that his eight-year career was over until he straightened out his life, Blake found himself alone in a dark, seedy hotel room. Tired and angry, he hit bottom. At that point, he remembered the Lord. Falling to his knees, he yielded his life – including the awful weight of his failures

and sins – to the Great Physician, with no strings attached.

Within minutes, his healing had begun. Blake still faced months of counseling and rehabilitation, but an inner work had started that culminated in complete restoration of his family and his life.
