#### **Editor's Note**

Well – the Chapter and Unit have had a very busy last couple of months. I apologize for missing last month's edition due to the amount of busy-ness we've had around the Chapter House.

The biggest thing going on of course has been the developments surrounding a grant that was provided to the Chapter by Blue Bonnet Trails Community Services (BBT), LLC. Looking for worthy organizations to invest in, BBT was directed to our Chapter as a worthy beneficiary of a substantial grant. Leo DeLa Garza and Jarod Meyers of BBT visited our location, observed the work we are doing and liked what they saw. Their intent was to expand what we are already doing by taking on a new program, Bring Everyone Into The Zone (BEITZ), part of a Veteran Drop-in Center. The proposal was that they would upgrade our facility for an agreement to operate at a higher degree of involvement and open for longer hours. This would include a week long training class in Peer-To-Peer course facilitation. We agreed, and were able to get 27 volunteers to start up the new program. This was the largest single group they had ever trained and represented a significant boost in the network they were trying to establish. Bravo Zulu (Well Done) to the volunteers that undertook this intense week of training.

Training finished, and upgrade to the building is mostly finished as the grant was fully spent. The visible effects of this partnership are represented by the brand new parking lot, air conditioning to our large meeting area, new lighting, electric upgrades, new computers, phone systems and more.

What remains now is to get the program running with volunteers to staff and fund this new venture. Comrades Gary Elley and Terri Herrle are Chair/Co-Chair for this new program which includes volunteers not only from Chapter and Unit 61, but the Geronimo VFW and Seguin American Legion as well. Truly, an example of veterans helping veterans.

Your officers and members have worked tirelessly over the last 2 months to make this sweeping change. I am very proud to be a member of this Chapter and a comrade to all those who work in helping our veterans.

In other news, the Honor Guard continues to serve the community and representing the Chapter with distinction. If anyone is interested in being a member, contact Past Commander Juan DeLeon.

Chapter Service Officers are also busy taking care of our community veterans with their claims and other issues. If you are interested in becoming a Chapter Service Officer see Past Dept Cdr Doug Herrle or Commader Phil.
