State Cemetery opened in Corpus Christi on Dec 7^{th} 2011.

JR Garza involved in program to honor veterans in Vietnam killed in action. Reaching out to the public to get names and pictures of persons that died. Next year is the 50th anniversary of Vietnam War and it will be the closing time for the project., an educational center built underneath the Vietnam Wall. Need to get this information before May. The Virtual Wall has many names already information. There are 93 veterans we are still searching information and have no information and asking community to help assist in finding this information. It is nationwide, but we are doing it locally. Peter Holt donated a million dollars himself to the program.

Go with a checklist so they know what to take care of when you go.

Early voting and make sure to vote for Proposition #1 deals with handing down the tax exemption from the disabled veteran.
