One of these collaborations is with *Fire & Iron*, a local organization of firefighters who have adopted our Chapter to support through proceeds from their annual fundraiser. The 3^{rd} annual *Fire & Iron Motorcycle Rally* will be this **Saturday, May 25th at Double G's** here in Seguin. The rally will begin at 10 AM and is expected to last until about 4 PM. If you want to participate in the rally but don't have a motorcycle, you are welcome to participate in your car or truck. This event has something for everyone - food & beverages, a DJ providing music and a raffle for 3 firearms. Raffle tickets are \$20 each and can be purchased at the event. 

A motion by Marlin Howze, 2nd by Frank Rosario and carrying resulted in adjutant casting one blank ballot for a non contested election of the Executive Board. District Senior Vice-Commander Marlin Howze acted as Officer giving the oath of office to newly elected officers. Sworn in were Phil Sierer for Commander, Gary Elley for S. Vice Cdr, James Dickerson for J. Vice Cdr, JJ Chapa for Treasurer, and Richard Cusson for Chaplain. Comrades Howze and Garcia will continue as Adjutant and SAA respectively.
