<u>Hospital Committee:</u> New committee is established to report on matters concerning the Veteran's Hospital in Payson. Committee to be composed of: Chairman John Eakins, Vice Chairman Art Richardson, Recorder Andrew Wilson. Eakins notes that we continue to be well-invested in the facility and that the members of this Committee are also sitting on the Hospital Advisory Board with Eakins now serving as its Chairman.

Chairman Eakins reports on the Santa Zone Project there, now in its third year and continuing to be a successful and much appreciated activity. Eakins reports that the Hospital receives tremendous support from the Payson community and government. The

June 25th car show put on by Avalon, the service contractor for the Hospital was a notable success, raising \$3500 to be donated to support the Santa Zone Project.

The Santa Zone event this year is scheduled for Friday December 2nd with set-up being done the night before. Anyone wishing to help with set-up is encouraged to attend. Donations to the project should be made the week prior. Much of the cash donations collected are used to defray the costs of shipping gifts to recipients. The Junior High School's Honor Society volunteers their time for gift wrapping. Neil Hargrave reminds to include hours donated to the Santa Zone effort in individual reports. Randy Edwards offers that the County VSO Council meets every third Thursday and we should come and outline the project to them since Edwards notes they are looking for things to get involved in and they could offer their help in making deliveries.

Eakins reminds that the Halloween Trick-or-treat, where children visit the resident's rooms will need the candy donations by the 29th. Please nominate a veteran to be inducted to the Wall of Honor at the hospital. See Eakins or Richardson for more details. The facility will be rededicated on December 7th, Pearl Harbor Day in honor of Marvin Minion, USN who won the Medal of Honor that day aboard the USS West Virginia.

12. Unfinished business

Golden Corral fundraiser starts tomorrow at 1100hrs. The schedule will be 14 to 24 October followed by a ten-day break then return to continue the fundraiser on 4 November and ending on 19 November. Military Appreciation Day will be Monday, the 14th. The break period is intended to prevent patrons from growing aggravated at multiple encounters with our crew and to give members who spend a lot of time at the restaurant a chance to catch up with their lives. This approach is supported by Ryan Codner, the Manager. Commander Bennett will visit local businesses to solicit support with donations of items to include in the prize drawing as well as cash donations.
