5. Treasurer's report

Distress Committee Fund stands at \$500 with none expended since last report. Treasury balance is \$16,130.66

12. Unfinished business

Remember to attend the Veterans Car Cruise June 25th from 9 to 4 at the Payson Veteran's Hospital. We are sponsoring a table so volunteers are needed to help out. All proceeds from sale of wooden cars and hand flags will go to support the Santa Zone Project.

Flag Day next Tuesday. Color Guard will conduct a Flag Retirement at the Payson Veteran's Hospital which will also feature an extensive collection of WWII memorabilia on display. The American Legion will put on another for the City of Provo with the Boy and Girl Scouts at 1800hrs in the Macey's parking lot on State Street and Bulldog Ave. We will have a table at that event as well.

Our big flag retirement, to which we contribute the annual accumulation of flags from our collection boxes (about 2,000), will be July $19^{\rm th}$ at $18:00 \rm hrs$ at the Spanish Fork Rodeo Arena as part of the Fiesta Days celebration. Scouts in uniform, with or without their Troop/Den will be invited to participate. We will be publicly mentioned at the event so it is important that we have as many members there as possible with their families.

National Wheelchair Games coming to Salt Lake City June 26 through July 2nd. Department is looking for volunteers to operate the Hospitality Suite at the Holiday Inn Express. 13. New business

Vietnam Memorial Wall replica will be on display at the Provo Elks Lodge on University Avenue (East Bay) 15 – 19 September. The Elks have asked us to provide volunteers to assist with security.

The Freedom Festival officials have asked us to provide security volunteers again this year but this time they would like to assign us to watch the vendor's property and supplies overnight. Anyone not wishing to volunteer for this detail is asked to ride in the military vehicle convoy portion of the Grand Parade but preference is given to those wearing uniforms or VSO caps/insignia.

Three resident veterans of the Payson Hospital went on the last Honor Flight. Jeff Hansen, Hospital Administrator paid for one sponsor and Avalon, the hospital's parent provider sponsored the other two. Commander Eakins would like for us to consider and discuss providing and sponsoring a member to go on an upcoming flight.

Adjutant and Commander detail a request from Randy Edwards, Chairman of the County VSO Council for all major VSOs to contribute about \$500 to purchase a Daily Herald online banner that will be up for four to five months and will feature interviews with local vets who will tell their stories of their military experiences. The banner will include links to the sites sponsored by the VSOs. The same request was made last year but did not come to us as a request for funding. The DAV link was included on that banner but clicking on it directed the viewer to another site which happened to be the site of the person constructing the site. The Herald staff will be responsible for that this year. The Adjutant says that we have several members whose stories would be very interesting and the interview will offer an opportunity to mention our mission and our presence in the community. Motion to postpone further discussion to next meeting because of time restraints due to the need to hold Chapter election tonight.

Commander calls thrice for nominations for Treasurer. Neil Hargrave is nominated and declines. Sam Davenport is nominated and declines. Jessica Chaney is nominated and accepts. There being no further nominations for Treasurer, Jessica Chaney is elected by acclamation.

Commander-elect Bennett reviews recommendations received for duty appointments and asks that all those in appointed positions remain after his installation. All accept. Commander-elect Bennett asks that membership candidate Jake Boozenny accept appointment to Officer of the Day when his membership is approved. Mr. Boozenny will accept the appointment.
