LEGISLATIVE NEWS

The House and Senate recessed on Apr 14th and will return on May 2nd, the following new bills have been introduced in the House and Senate:

H.R. 804 - Operation New Dawn Veterans Benefits: A bill that will guarantee military members who serve in Operation New Dawn in Iraq will be entitled to the same health-related benefits as those who were part of Operation Iraqi Freedom. If passed, the bill would amend title 38, United States Code, to clarify the eligibility of certain veterans who serve in support of Operation New Dawn for hospital care, medical services, and nursing home care provided by the Department of Veterans Affairs. This is identical to the bill introduced in September

2010during the last Congress. It would provide New Dawn veterans with the same veterans' hospital care, home nursing access and medical services through the Department of Veterans Affairs as veterans of Operation Iraqi Freedom. There is a concern that language of the law currently providing benefits to Operation Iraqi Freedom veterans may inadvertently deny the benefits to those who serve in the current operation.

H.R. 805 - Injured and Amputee Veterans Bill of Rights: This legislation would require the VA to display an Injured and Amputee Veterans Bill of Rights in all prosthetic and orthotic clinics of the VA. This bill was introduced in the last Congress, but not passed. It would instruct the VA to inform veterans and educate employees at each VA prosthetics and orthotics clinic of the Inured and Amputee Veterans Bill of Rights. It also requires VA to conduct outreach to veterans. The legislation was referred to the House Veterans' Affairs Subcommittee on Health and currently has 3 cosponsors.

H.R. 1407 - Veterans' Compensation Costof-Living Adjustment Act of 2011. To increase, effective as of December 1, 2011 the rates of compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for the survivors of certain disabled veterans, was introduced in the House on April 6, 2011 and referred to the House Committee on Veterans' Affairs.

H.R. 1481 - Veterans Appeals Improvement Act of 2011. To amend title 38, US Code, to improve the appeals process of the VA and to establish a commission to study judicial review of the determination of veterans' benefits. If passed this bill would waiver VA Regional Office jurisdiction over incorporation of supplemental evidence into previously submitted a veteran claims for which a substantive appeal has been filed, such evidence shall be submitted to the Board of Veteran's Appeals directly unless the veteran requests that the evidence be reviewed by the Regional Office before being submitted to the Board. This change shall be apply with respect to evidence submitted on or after the date that is 90 days after the date of the enactment of this Act. It also would create a Veterans Judicial

Review Commission to evaluate the administrative and judicial appellate review processes of veterans' and survivors' benefits and to make specific recommendations and other solutions to improve the accuracy, fairness, transparency, predictability, timeliness, and finality of such appellate review processes, including a recommendation as to whether the Court of Veterans Claims should have the authority to hears class action or associational standing cases. This bill was introduced in the House on April 12, 2011 and referred to the House Committee on Veterans' Affairs.

- S. 696 If passed this bill would treat Vet Centers as VA facilities for purposes of authorized payments or allowances for beneficiary travel to or from a VA facility in connection with medical care, which is currently 41.5 cents per mile. Vet Centers typically provide mental health and readjustment counseling services for veterans, was introduced on March 31, 2011 and referred to the Senate Veterans' Affairs Committee.
- S. 780 Veterans Pensions Protection Act of 2011. Amends title 38 US Code, to exempt reimbursements of expenses related to accident, theft, loss, or casualty loss from determinations of annual income limits with respect to VA pensions for veterans and surviving spouses and children of veterans, was introduced in the Senate on April 8, 2011 and referred to the Senate Veterans' Affairs Committee.
- S. 815 A bill to guarantee that military funerals are conducted with dignity and respect was introduced in the Senate on April 13, 2011 and referred to the Veterans' Affairs Committee with 13 cosponsors. The text of this bill is not yet available.
