If an expectant mother relocates during her pregnancy, TRICARE guarantees her continuity of care. Prior to the move, beneficiaries should discuss their upcoming move with their provider and request copies of their medical records. If the active duty

sponsor moves to a new duty location covered by TRICARE Prime Remote. TRICARE covers necessary prenatal care from the first obstetric visit through six weeks after childbirth, visit TRICARE.mil/moving.

Alcohol abuse can lead to the development of chronic problems, both medical and social. Treatment at TRICARE.mil/livewell.

Gardening, camping, hiking, and playing outdoors when enjoying these activities, don't forget to take steps to prevent tick bites! Permethrin can be used to treat boots, clothing and camping gear and remain protective through several washings. Visit tricare.mil/Emergency
