94th Annual Convention June 19-21, 2015 Doubletree by Hilton Leominster, MA

#### I. Opening Session Friday, June 19, 2015

Sr. Vice Commander Helen Bennett called the convention to order at 1:06 p.m. and conducted the appropriate opening ceremony.

As of this date The Department of Massachusetts has 58 chapters, 56 Active chapters with 1 chapters in Trusteeship and one at-large.

I would to thank **ALL** Chapters for submitting their Officer Reports. The following Chapter still needs to submit their DEC designee: 41. Districts 2 & 7 as of this date have not submitted officer or DEC designee forms.

I have a spread sheet with each chapters and units EIN number listed with National, last file date and if reinstatement letter is on file if appropriate.

Chapters 27, 29, 35, 85, 110 are to be filing 990 long forms along with the IRS. All <u>bar/lounges</u> are to be filing the 990 long or 990ez form even if your total income is less than \$50,000, it is an IRS requirement. Upon completion of your 990 a copy is to be submitted to the department.

All other chapters file a 990n. A copy of the email you received from the IRS stating your 990 has been <u>accepted</u> must be submitted to the department, if you have not already done so just forward the email received from the IRS to Department Headquarters care of <u>tmate@davma.org</u>, <u>dstack@davma.org</u> or myself. The following 4 chapters still need to file their 990n –for last year – 2013-2014 fiscal year: 55, 72, 76, 82 **YOU ARE LATE**. This needs to be completed **NOW**. See me at the end of the DEC meeting if you need assistance in completing this task.

32 Chapters have filed their 990n for 2014-2015 fiscal year -excellent job -we have 19 chapters that need to file their 990n, see me if you have any questions.

I have visited several chapters to assist them with their finance reports, prior to submission. We have started receiving financial reports at the office and we have begun the review process. Please remember to submit all supporting documentation, bank statements that includes checking, savings, cd, money markets, minutes and sign in sheets and completed schedules. If you have any questions or concerns please email me at <a href="mailto:dolson@davma.org">dolson@davma.org</a>. Make sure you have all required signatures and all those signing actually review the document, give them a calculator to help them double and triple check your math, its usually something small that trips you up – reminder your chapter receives 2 per-capa disbursements, a large one in July and a small one (under \$50) in January, don't forget the January one.

The process of updating Chapter By-Laws is on-going. Your by-law committee should be a standing committee in your chapter. Please review the department and national by-laws as well with your chapter. If you have any questions or concerns relating to these documents please contact a member of the Constitution and By-Law Committee they stand ready to assist at your call.

It was my privilege to attend the National Convention in Denver, the seminars where informative and insightful. I had no problem putting in my 10,000 steps each day. My son Jeffrey came with me and was a page for the Auxiliary, he's still not sure what he was supposed to do. Over all it was a great week. I recommend attending if you have the opportunity.

Upon returning from the convention it was right into preparing for the Annual Salem Park Picnic for the Chelsea Soldiers Home and Bedford VA. What a great turn out, beautiful weather and it was excellent to see so many veterans out enjoying the day. Thank you District 3 and District 4.
