Operation "Keep the Promise" intends to make advanced appropriations for all VA accounts, including its mandatory disability payments to Veterans, our highest legislative priority in this upcoming fiscal year.

Passage of "Putting Veterans Funding First Act" would enable the VA to plan for

key investments in information technology, claims processing, construction projects, computers and IT systems.

We do not need another Government shutdown, with critical services for Veterans that can be delayed, disrupted, and in some cases suspended; creating hardship on Veterans and needless worry for America's injured Veterans and their families.

You can help by joining DAV CAN (Commanders Action Network) go to www.dav. org and put in your DAV membership number and click on help DAV, then click on take action and submit. Also, see that your Congressional representative does the responsible thing by fully funding the VA with no political gimmicks and stop using Veterans as political pawns.

Do not forget to get your Veterans Identification card updated to the more secure Veteran Health Identification card. The new VA Acting Secretary Sloan Gibson has replaced Veteran Erick K. Shinseki and started with the imbalance between VA health care availability and Veterans demand.

Harold also had the privilege to meet Dana back in the 1990's when Dana parachuted at the DAV National Convention. Harold's grandson attended his first DAV convention and was able to see his grandfather accept the coin with much pride and happiness.



#### National POW/MIA day is September 19, 2014

The United States' National POW/MIA Recognition Day is observed across the nation on the third Friday of September each year. Many Americans take the time to remember those who were prisoners of war (POW) and those who are missing in action (MIA), as well as their families.

Many Americans across the United States pause to remember the sacrifices and service of those who were prisoners of war (POW), as well as those who



are missing in action (MIA), and their families. All military installations fly the National League of Families' POW/MIA flag, which symbolizes the nation's remembrance of those who were imprisoned while serving in conflicts and those who remain missing.

The POW/MIA Flag is the only flag other than the United States of America flag that is allowed to fly at the Capitol Rotunda in Washington.

There will be a 24 hour vigil at Oakland Hills Memorial Cemetery beginning September 21, 2014 at 6:30 p.m. through 5:00 p.m. September 22, 2014.

Oakland Hills is located at 43300 W. 12 Mile Road, Novi, Michigan 48377.

Currently there are 41 Vietnam POW/MIA service members from Michigan that are still missing. One of those soldiers Doug Ferguson, a U.S. Air force Captain who was shot down over Laus on December 31, 1969, his remains were found last spring and he was buried in May 2013 in Tacoma Washington, his relatives are still in Michigan including his wife Sue Scott.

DAV Department of Michigan began the POW/MIA Committee with Commander Henry Rose during his term 1989-90 and I was appointed to serve on the committee that year.

DAV National Headquarters began their POW/MIA Committee during the 1991-92 years with National Commander Joseph Zengerle and I was appointed to serve on the National Committee that year.

depending on the amount of accidents and track repair that may be necessary.



It is a partnership between the artist and the Disabled American Veterans (DAV), a nationally recognized organization which advocates for disabled veterans.

"Since the first ArtPrize® in 2009," Carlson explains, "I've wanted to create an entry that has something to do with walking sticks. I've also wanted to make walking sticks for veterans of our Armed Forces. One day the two thoughts collided, and The Walking Art Project was born."

ArtPrize® is a radically open, independently organized international art competition and a 501(c)(3) non-profit organization.

For 19 days, three square miles of downtown Grand Rapids,

Michigan, become an open playing field where anyone can find a voice in the conversation about what is art and why it matters. Art from around the world pops up in every inch of downtown, and

it's all free and open to the public.

The Walking Art Project will be available for public viewing at the Spectrum Health Butterworth Hospital, 100 Michigan Ave, Grand Rapids, Michigan from September 24 - October 12, 2014 during the following hours:

Mon-Thurs 5:00 pm - 8:00 pm Fri & Sat 12:00 pm - 8:00 pm Sunday 12:00 pm - 6:00 pm

At the end of ArtPrize the individual pieces will be given to the DAV who will distribute them to disabled vets. In addition, visitors to the exhibit will have the opportunity to pledge a monetary donation to the DAV. A pledge of \$100 or more will give the pledgee the right to sponsor a walking stick of their choice to be given in their name. Pledges of less than \$100 will also gratefully accepted.

All of the sponsored walking sticks and 100% of the pledged donations will go

#### "Wow, you really drew that?"

#### In the Beginning

Art is known to be good therapy to deal with trauma. That was one of the reasons Ray Bakerjian started The Wounded Artist Project, a Michigan 501(c)(3) in 2009. The other, and more important in his mind, was to help the wounded recovering in military medical facilities develop art skills that might lead to a

college major or career path if they were going to be medically discharged from the service.

Ray is an Army vet from the Vietnam era and wanted to give something back. First, he volunteered as an artist for an hour a month at the John Dingell VA hospital near his home, and was encouraged by the work done by his veteran students there who were just drawing using simple circle, squares and lines. He eventually he got the idea to start a nonprofit to send free art kits to the wounded.

Doing a lot of perspective drawing may make a warrior want to be an architect or urban planner. Drawing the human body and looking at their charts and talking with their doctors and nurses may make them want to become a nurse. Drawing cars and other mechanical stuff may make them want to be a product designer or engineer. He does note to the kit users that the kit alone won't make them an architect, nurse or car designer, it's just the first step in their journey to become one.

The art kits include an off-the-shelf, art instruction book for beginners, a compilation book of easy-to-draw subjects (cats, dogs, buildings, athletes, cars, etc.) from a series of childrens' books, a sketchpad and an excellent pencil set donated free by the US company, General



Pencil. He knew that the books had to be simple enough so a young, inexperienced wounded warrior sitting in a hospital bed wouldn't get discouraged from the start and just pitch everything. Even with the very basic subjects included in the kits, he knew that the wounded would hear the same encouraging words he remembers getting as a young artist: "Wow, you really drew that?"

He also created a series of introductory, how-to-draw videos on YouTube with the help of a videographer friend from his son's Scout troop, Paul Garland. Other videos done with a small, pocket-sized video camera followed. He interviewed architects and scientific illustrators (one of whom had adopted a bat so she could study and draw it) who got into their careers because they loved to draw, and these were followed with interviews of advocates for veterans' affairs. There are also drawing demos by other artists on the channel.

#### **Future Plans**

With the winding down of combat operations in 2014 and the reduction in the numbers of wounded in hospitals, Bakerjian wanted to stay relevant for the VA systems so he contacted the PTSD staff at the Dingell in February to get their thoughts about expanding their mission to now include this community. During their meeting one of the staff attendees suggested that he look at serving all inpatient vets in the VA's 150 medical facilities.

He commented that he thought that there was another nonprofit doing this already. No, he was told. That organization was dismissed by the VA in 2012 and the medical facilities had not been

receiving supplies on-site for over a year and a half. So he called the VA Voluntary Services office in Washington, DC, to volunteer.

In discussing how this might be done, he asked his contact in DC if the VA could send a survey to all of the VAMCs to get an idea of what might be needed and in what quantities. He gave the VA a list of two dozen items, which included art supplies, leather craft and model kits, etc. He learned that 95 of the 150 VAMCs replied to the survey. This was accompanied by a note from his contact that the Voluntary Services managers were excited that their supplies would be coming in again.

During these conversations he found out that many times a VA doctor will actually prescribe a model kit or other activity as part of a patient's rehab.

Bakerjian's plan will be to have suppliers ship needed supplies directly from their own businesses so he doesn't have to create a large-scale warehousing operation. For those suppliers that can't ship for them, he knows he will have to have a small warehouse and

would like to hire several unemployed, combat-wounded veterans to staff it. He has even attended a local veterans court thinking, "if a vet has had trouble with the law, we can talk about that, too."

Bakerjian is willing to accept in-kind gifts from companies for supplies that can be used by the VAMCs. He would like to have car companies step up to buy model car kits for The Wounded Artist Project and can see having his shipping staff put stickers on them to the effect of, "This Camaro Was Bought For You By GM." He would like defense companies to help secure model aircraft, tanks and ships as well.

He plans to find a grant writer to secure funds from foundations (he contacted 500 foundations in March to see what kind of response he would get) and to work (cautiously) with fundraising companies. He is planning several campaigns with social media, the first with Kickstarter. He recently published a how-to tutorial for drawing US troops returning fire. He calls it, "In Contact" and can be found at bit.ly/WKows1.

It is an honor for the Care Team to provide assistance to our Wounded Warriors and Disabled Veterans, the Care Team members have experience working with individuals with varying injuries and disabilities including amputees, loss of eyesight and hearing, wheelchair bound, PTSD and anxiety.

Team members can also provide information on airline and airport procedures that may permit family members to surprise their loved ones at the arrival gate when they first walk off the place. Our team members enjoy welcoming military personnel home and assisting in the coordination of surprise reunions. Behind the Buddy-to-Buddy Volunteer Veteran Program is a simple concept: Military Service is unlike any other human experience. No one knows more about the issues facing a service member — in combat or on the home front — than a

fellow service member.

The mission of the program is to use trained volunteer veterans to help post-9/11 military service members and veterans overcome the stigma around asking for help and link those who are facing challenges throughout the deployment cycle with appropriate resources that will optimize their quality of life.

Volunteer veterans are recruited to the program from a variety of veteran service organizations and the community, and these trained volunteers are assigned to armories across Michigan. They provide assistance to service members who have concerns on a wide range of Issues including finances, employment, benefits, mental health and substance abuse, relationships and education.

"The effectiveness of the Buddy-to-Buddy Volunteer Veteran Program continues to amaze me," says Stephanie Zarb, program coordinator. "As a veteran myself, I know that making the transition to civilian life is a difficult process. In many ways, making that transition is much like waking up in a foreign country where you don't fully understand the language, customs and culture. Without help, it can be difficult to figure out how to move forward."

Since it was founded in 2009, the program has experienced significant growth. With more than 100 trained active volunteers working in 40 of Michigan's 42 Army
