## Adjutant –

The Holidays Are Upon Us! This is a good thing for most of us, particularly those of us with children or grandchildren to spoil! But it is also a time of increased stress, and for our comrades who may already be suffering from underlying physiological or mental issues, or find themselves alone as those around them are celebrating, the added stress can lead to depression or worse. So, we need to touch base with all the veterans we interact with regularly, and make sure they are doing well. Invite a single comrade over for Christmas dinner. Hold a holiday party for a struggling young veteran's family. You get the idea! Try and make sure it's a happy holiday season for all!

**Mentoring-** We brought this subject up at the Mid-Year Conference, but it bears repeating:

National puts a great emphasis on recruiting new members, which is critical: it's good for the Chapter, and it's good for the disabled veteran. But what are you doing with your new members once you have them?

We learned an important rule in the military: "No one can afford to be irreplaceable." This rule is just as true in the DAV. Mentoring of new members is critical: we have lost entire chapters because key officers were incapacitated or died! The chain of results were almost always the same: no remaining members knew how to do the job, and no one wanted to take it over "cold." When things stopped getting done, Chapter members stopped meeting, so elections weren't held, Officer Reports were not submitted, and National pulled the chapter's charter!

To avoid this fate, replacements must be ready: they must *want* to do the job, and must be properly trained. They are more likely to take over a position if they are trained to do so! They are even more likely to take over a position if you're still around to guide them when they do!

Of course, Chapter members need to buy in — after all, they need to vote in your replacement! — and they will be more accepting if they know you trained your replacement, and you think he or she is ready to do the job! There is a lot more that can be said about this subject. In fact, I built a presentation that does just that! Every chapter needs to take mentoring of new members seriously, and start training up their replacements!

## DAV INFORMATION SEMINARS

---

Information Seminars are held to educate veterans and their families on specific veterans' benefits and services. These free seminars are run by DAVs highly trained National Service Officers (NSOs) and are held around the country. NSOs are experts on Veterans benefits and are able to provide the best counseling and claims filing assistance that you and your family can get. These services are free of charge, and veterans do not need to be a DAV member to take advantage of this service.

We require at a minimum 8 weeks advanced notice prior to the date you want the seminar in order to send out letters and order materials. In addition to the seminar we can hold a claims clinic afterwards if your chapter desires one. Per the National Service Director, we cannot hold these seminars on a weekend unless it is in conjunction with a special event.

**I was told that at least one Chapter is doing fund-raising without getting permission from the Department.** I was told the Chapter believes the Department will demand half the funds raised by any Chapter. **This is NOT TRUE!** The only reason the Department must be notified of any fund-raising event in advance of the event, is to prevent conflicting activities and to ensure compliance with directives in the National Constitution and By Laws Section 15.3. The Department will only disapprove your event if it does not comply with the Constitution and ByLaws of the Department or National organization. If multiple Chapters in close proximity to each other request the same date(s) for fund-raising, the Chapters may be asked to coordinate with each other (change dates or combine) so that both Chapters have maximum potential for event success. The only way the Department gets any funds from Chapter fund-raising events is if your membership votes to donate to the Department.


