

It was a great day for the Disabled American Veterans while visiting our nation's capital on Tuesday, 28 February 2023. This was nearly the last day for many members attending the DAV 2023 Mid-Winter Conference held just across the Potomac River in Arlington, VA.

This years' conference began Saturday, February 25TH, concluding late Tuesday, February 28TH for most attendees.

It was a great opportunity to put faces to names and both listen and speak with our national leadership. The conference included attending various workshops focusing on Local Veterans Assistance Program, Inspector General Workshop, Employment and Entrepreneurship and Communications Workshops. Throughout the conference discussion was about what we have done and what we can do going forward focusing on our 2023 Critical Policy goals. It was very informative.

This conference is one of the most memorable demonstrations of DAV's dedicated advocacy in action. Hundreds of nationwide DAV leaders joined together to discuss the most pressing important veteran's issues today and then bringing our battle directly to our elected leaders and officials in Washington, D.C.

On that Tuesday, conference members were encouraged to attend a Joint House and Senate VSO hearing called "Legislative Presentation of Disabled American Veterans." Here there was open conversation between the Veteran Affairs Committee members and the National DAV leadership. It is here where our National Commander, Joe Parsetich presented his testimony before the Veterans' Affairs committee members.

As formal introductions were exchanged, it never made me personally feel prouder to be a DAV member when I heard the kind, respectful words stated by both attending House and Senate members on what they had to say about the DAV organization, our leadership, our mission and how much they appreciate the DAV helping them do their jobs better helping veterans. They expounded how the DAV walks the talk in our mission statement representing veterans.

Commander Parsetich went on to address pressing issues impacting our nation's veterans, including:

- Correcting inequities in compensation benefits for veterans and survivors
- Implementing the PACT Act and addressing gaps in toxic exposure benefits
- Ensuring equity in VA care, services and benefits for women, LGBTQ+ and minority veterans
- Providing a full spectrum of long-term care options for service-disabled and aging veterans
- Bolstering mental health resources to ensure continued
- progress in reducing veteran suicide
- Expanding the VA's capacity to deliver timely, high-quality health care to veterans

#### VETERANS MOVING AHEAD THROUGH MEANINGFUL WORK by Lynne Hunter, MSW, CSW-PIP, QMHP2

The Vocational Rehabilitation Program is among the many Departments of Veterans Affairs' (VA) initiatives in support of Veterans experiencing mental health, substance use, physical challenges, and homelessness.

The VA vocational rehabilitation program strives to match and support Veterans in competitive jobs, and to consult with businesses and industries regarding their specific employment needs. It is a recovery-



oriented, vocational service that involves many models of treatment. Transitional Work (TW) and Supported Employment (SE) are available through the Sioux Falls VA Health Care System. Vocational Rehabilitation Programs provide work experiences or employment opportunities in the community or VA medical facilities that provide vocational and clinical services to enable participants to gain work experience and work resilience to prepare for community-based competitive employment. The core philosophy of Vocational Rehabilitation is that all persons with a disability can contribute productively to the workforce given the right supports, and no one should be excluded from the opportunity to make a meaningful contribution.

Work is integral to our well-being and contributes to our defining ourselves. Income from work does more than sustain us. It provides meaningful activity; a way to be productive and useful. Vocational Rehabilitation clinical services are most effective when staff is integrated with the Veterans' interdisciplinary treatment team. Vocational rehabilitation staff coordinates employment services with other VA, federal, state, and local community partners. Services are outcome-oriented resulting in meaningful community-based competitive employment and evidence-based and evidence-informed employment practices are prioritized.

Approximately 800 Vocational Rehabilitation Counselors, Vocational Rehabilitation Specialists, Managers, and Peer Support Specialists provided vocational rehabilitation support services across the VA hospital system and work with Veterans every day to achieve and retain meaningful work. Over 52,000 Veterans are served through the Vocational Rehabilitation program each year. Through the program, Veterans are provided opportunities for social interactions, connecting Veterans with Veterans and communities, and increasing a sense of belonging, purpose, and accomplishment. The goal is to support Veterans to achieve and maintain permanent, community employment.

### SARA ACKERT Medical Center Director for VA Sioux Falls Health Care System

Effective March 12, 2023, Ms. Sara Ackert took the role as the Medical Center Director for VA Sioux Falls Health Care System, VISN 23. Ms. Ackert was the Associate Director of Resources and Operations for VA Central Iowa Health Care System. She

holds a Master of Healthcare Administration from Des Moines University and a Bachelor of Science Degree in Nursing with emphasis in psychology from Grandview College. She is a graduate of the VHA Executive Career Field (ECF) Leadership Development Program and is a member of the American College of Healthcare Executives (ACHE). Ms. Ackert has been with the Department of Veterans Affairs for over 33 years and has proven success in health care operations.

### LAWMAKERS FURIOUS OVER MISSPELT NAMES ON KOREAN WAR MEMORIAL

House and Senate lawmakers are demanding answers on how hundreds of service members' names were misspelled or mixedup on stone markers at the Korean War Veterans Memorial despite warnings from advocates about the potential for mistakes years ago.

"Errors of this magnitude should not have made it past the initial blueprints, much less carved into stone, and certainly not erected and unveiled to the public," a bipartisan group of key congressional leaders wrote in a March 3 letter to Defense Department leaders.

In spring 2021, ahead of plans to unveil a new remembrance wall at the memorial featuring the names of more than 36,000 Americans who died in support of the war, members of the Korean War Project warned of numerous discrepancies in the National Archives and Records Administration list officials planned to use to complete the project.

### HOW VA'S BIGGEST BUDGET EVER WILL IMPACT VETERANS

Last year, Congress sent several DAV-championed bills to the president's desk, including the historic expansion of benefits for veterans exposed to toxic substances. But another sizeable legislative package enacted in December includes dozens of other provisions that will touch the lives of veterans nationwide.

The \$1.7 trillion omnibus bill, which will fund the federal government through September, increases the Department of Veterans Affairs (VA) budget to over \$303 billion, the agency's highest ever.

"It's our responsibility to take care of the men and women in uniform who took care of us in protecting this country—and that starts by ensuring access to the care and benefits they've earned with this bipartisan package," said Sen. Jon Tester of Montana, chairman of the Senate Veterans' Affairs Committee. "I'm proud the Senate

came together to pass a full-year funding bill that'll help us make good on that promise, including to our toxic-exposed veterans."

Part of the increase in VA funding reflects an uptick in veterans' demand for claims and services under the Honoring our PACT Act, which expanded VA health care and benefits to millions of veterans. Within VA's new budget, \$119 billion is set aside for medical care, a 22% increase over fiscal year 2022 levels. It also dedicates nearly \$4 billion to administer benefits, including compensation, and \$5 billion solely for implementing the PACT Act.

However, that's not all there is for veterans.

The more than 4,000-page bill also includes more than 60 other DAV-supported provisions to further strengthen VA health care and veterans benefits. Veterans whose clothing has been damaged by a prosthesis, skin medication or orthopedic device—including wheelchairs—are eligible for a clothing allowance. But they were needlessly burdened by an annual application process, even for those requiring such equipment for the rest of their lives.

This provision cuts the red tape by allowing VA to provide these payments on a recurring and automatic annual basis.

It also makes the Homeless Veterans Reintegration Program permanent, providing employment and job training for homeless veterans, expanding Vet Center eligibility for mental health services, and setting money aside to study suicide prevention efforts and research traumatic brain injury and PTSD in post-9/11 veterans.

"We're heartened to see so many DAV's priorities make it into this final bipartisan funding package," said DAV National Legislative Director Low Hom. "And a

funding package," said DAV National Legislative Director Joy Ilem. "And a properly funded VA is crucial to providing our veterans the service and benefits they've earned. As a new Congress settles in, I encourage all DAV members to join the Commander's Action Network to stay on top of issues and take action on vital legislation."



SDDVA's Annual Report has been completed and has been provided to the legislators as required by statute. ## THE INDEPENDENT BUDGET 2024

The Department of Veterans Affairs must fill tens of thousands of health care and support positions, faithfully implement the largest expansion of veterans benefits ever and work with Congress to develop a new infrastructure strategy, according to The Independent Budget Veterans Agenda for the 118th Congress.

For more than three decades, the Independent Budget (IB) partners—DAV, Veterans of Foreign Wars and Paralyzed Veterans of America—have offered

crucial fiscal recommendations for the VA so the agency charged with caring for our nation's veterans can meet current and evolving needs.

The group released the annual report in February, providing an impartial picture of the budgetary requirements across five critical issue areas.

"After almost three years of the pandemic, it appears that COVID may be nearing its endemic stage, and one result could be greater predictability of VA's funding needs," the IB partners wrote.

For fiscal year (FY) 2024, the IB partners recommend \$139.9 billion in total medical care and \$157.2 billion for FY 2025 advance appropriations. This recommendation "reflects the increased funding baseline for all medical care programs established over the past two years, continuing enrollment increases, higher inflation, a federal pay raise and rising workloads," the report states.

Medical job vacancies have plagued health care systems nationwide. And as the nation's most extensive integrated health care apparatus, the VA has staffing issues that match those of the greater workforce. A 2022 VA staffing report said the department had more than 76,000 openings—double the number of vacancies from the previous year.

For FY 2024, the IB partners recommend that the VA "pursue an aggressive hiring trend" by filling 19,200 full-time employee positions, at a cost of about \$2.8 billion.

When the Honoring our PACT Act became law last year, it ushered in a new era for veterans exposed to toxic substances. The Independent Budget states that the law will require flexibility as it greatly expands VA health care eligibility.

"While it is too soon to assess how many veterans will apply under the PACT Act and what the resource requirement will be in the next few years, [the] VA and Congress must monitor enrollment and application trends closely and make any necessary adjustments to funding before and during FY 2024," according to the report.

Congress scrapped the VA's Asset and Infrastructure Review last year, rejecting a plan to close or overhaul medical facilities that do not meet veterans' health care needs. The commission was mandated by the 2018 MISSION Act, a bill to give veterans more medical care options.

The IB partners recommend that Congress and the VA reengage on infrastructure and develop a new strategy to build, repair and realign VA assets and properties. With a rapidly aging veteran population, that plan should also aim to meet the specialized long-term care needs of veterans, including those with spinal cord injuries.

"This Congress will be responsible for equipping [the] VA to provide the benefits and services veterans earned and at the quality they deserve," said DAV National Legislative Director Joy Ilem. "The Independent Budget is a critical guide for lawmakers who will consider many important issues directly impacting veterans' lives."
