# VA delays disputed change in how it pays for veterans' ambulance trips

Veterans Affairs officials will postpone a controversial rule change regarding ambulance service reimbursements after objections from industry officials and members of Congress who worried the move could endanger some veterans living in rural areas.

Department leaders have not completely given up on the plan, but promised lawmakers on Nov. 22 that they will not implement the changes until February 2025 at the earliest. The new rules had been set to go into effect by mid-February 2024.

VA press secretary Terrence Hayes said leaders are making the reimbursement changes "to better align with the rest of the health care industry." A VA inspector general report from 2018 found the department had been paying 60% more than typical industry rates for air ambulance services, potentially wasting taxpayer money.

In remarks at the National Press Club earlier this month, VA Secretary Denis McDonough said the goal of new reimbursement rules is not to cut costs for emergency medical care but instead to push local providers into formal contracts with VA for the services, ensuring stability and consistency in pricing.

"As near as we can tell, VA alone among all major health care systems in the country pays for each individual ambulance," he said. "We're just paying cash for each run."

But industry opponents have said sharp cuts in reimbursement rates for ambulance services could severely cripple operations in rural areas, potentially even forcing the closure of some emergency response services.

And lawmakers have decried VA's proposed fixes as too broad and possibly dangerous. In a statement, Senate Veterans' Affairs Committee Chairman Jon Tester, D-Mont., hailed the one-year delay as critical time needed to work out disagreements between VA and the emergency services companies.

"The availability of emergency air and ground transportation services in Montana and rural America can be the difference between life and death," he said. "VA's hasty implementation of its rate change for these services could have been the final straw for providers in rural America, and I'm glad to see VA answering my call and taking steps to fix this reimbursement issue."

Both the House and Senate are considering legislation on the issue. Lawmakers can now work on those proposals without a looming deadline early next year.

Ben Clayton, CEO of Life Flight Network, one of the groups involved in the lobbying efforts against the rule change, called the decision "a significant victory" for veterans.

"I look forward to working with the VA to ensure that reimbursement rates for air medical care are sustainable, protecting veteran access to this lifesaving service," he said. "Although there is still work to be done, this delay reflects a genuine effort by the VA towards a solution."



## What do the coins left on grave markers mean?

Have you ever been in a cemetery and saw coins cemeteries and state Veterans cemeteries is lying on a tombstone? All these coins have distinct meanings when left on the headstones of those who have perished, depending on their denomination. Leaving coins on the headstones of those who served in the military, especially those who died in combat, dates as far back as the Roman Empire.

A coin left on a headstone lets the deceased soldier's family know that someone has stopped by to pay their respect. Leaving a penny means you visited. A nickel means that you and the deceased soldier trained at boot camp together. If you served with the soldier in some capacity, you leave a dime. A quarter is significant because it means that you were there when that service member was killed.

Air Force fighter pilots throw nickels into the grass at grave sites. This tradition began in the early 50's when phone calls on the public phones given. were only a nickel. Prior to leaving on a dangerous mission, pilots would toss a nickel into the grass so didn't make it back

So what happens to all the coins? According to tradition, the money left at graves in national

collected, and the funds are put toward cemetery maintenance or paying burial costs for indigent Veterans. In the U.S., this practice became common during the Vietnam War due to the political divide in the country over the war; leaving a coin was seen as a more practical way to communicate that you had visited the grave. In general, this tradition can be traced back as far as the Roman Empire, as a way to give the deceased money for the hereaf-

It is a common ritual to leave mementos on and within the final resting places of loved ones, whether it be flowers, a letter or keep-sake. Veterans also may leave very special remembrances at the graves of deceased service-members such as challenge coins. These tokens identify their bearer as members of particular units and are prioritized and cherished by those to whom they have been

No matter what the original intention of the coinhis team mates could notify the next of kin if he leaver may be, it is clear that a coin left on a headstone is a symbol of remembrance and respect - a way of telling all who pass by that the person buried was loved and visited. So the next time you visit through a cemetery, bring a pocketful of pennies!

# Veteran honor guards adapt to aging population

Some South Dakota veteran honor guards are getting creative in how they maintain and grow their ranks.

**Why it matters:** Honor guards perform at funerals and on holidays such as Memorial Day and Veterans Day. It takes 14 volunteers to pull off each ceremony, with color guard, firing squad, bugler, officer of the day and commander.

**The challenge:** South Dakota ranks 22<sup>nd</sup> among U.S. states in the number of veterans per 100,000 adult residents. But the number of military veterans has declined nearly 20% since 2010, from 69,780 to 56,590, according to the U.S. Census Bureau. Veterans comprise 8.3% of the state's adult population, down from 11.4% in 2010 but still more than the national average of 6.2%.

"The average age is around 70, and a lot of them are slowing down," said Gonsor. "We're always trying to find younger members."

The problem is emblematic of a larger trend in South Dakota, where the number of military veterans has declined nearly 20% since 2010, from 69,780 to 56,590, according to the U.S. Census Bureau. Veterans comprise 8.3% of the state's adult population, down from 11.4% in 2010 but still more than the national average of 6.2%.

South Dakota ranks 22<sup>nd</sup> among U.S. states in the number of veterans per 100,000 adult residents, ahead of neighboring states North Dakota (25<sup>th</sup>), Nebraska (30<sup>th</sup>), Iowa (35<sup>th</sup>) and Minnesota (41<sup>st</sup>).

#### 176 WWII veterans in South Dakota

For Gonsor, honor guard duties were traditionally filled by those who served in World War II, Korea or Vietnam, proud members of the American Legion or Veterans of Foreign Wars who faced the inevitable drumbeat of time, accelerated in some cases by the COVID-19 pandemic.

Census data show that there are 176 World War II veterans (0.3%) alive in South Dakota, compared with the Korean War (2,056; 3.6%) and Vietnam (19,363; 34.2%). Those who served in the Gulf War before Sept. 11, 2001, (15,116; 26.7%) and after 9/11 (16,317; 28.8%) make up the majority in the state.

Connie Johnson, president of the South Dakota Veterans Council, pointed to research that veterans under age 65 are more likely than their older peers to seek mental health counseling, with services increasingly available through the U.S. Department of Veteran Affairs.

"A lot of older veterans were in organizations like the VFW and American Legion, and that's where they went to find that camaraderie," said Johnson. "In some ways, that served as mental health therapy for them. You see less of the (Gulf War veterans) in those groups because they can seek treatment and camaraderie through different levels of resources available."

## Military rites include 21-gun salute

Gonsor's first step in reviving the Custer Veterans Honor Guard was combining the ranks of Custer Post 46 and VFW Post 3442. That increased the number of volunteers available to perform military ceremonies such as the playing of taps, flag presentations and the 21-gun salute.

Still, there were growing pains as the squad – ranging in age from 47 to 85 – accepted requests to appear at sites throughout the southern Black Hills, as many as three funerals a month in addition to special ceremonies.

"Six years ago, there weren't two guys dressed the same," Gonsor said of the squad. "Now everybody has a uniform and we're all on the same page most of the time. A lot of the ceremonial weapons were showing their age for a while and would sometimes misfire. But now we've got a good set of rifles, the same type used in World War II."

It takes 14 volunteers to pull off each ceremony, with color guard, firing squad, bugler, officer of the day and commander. One of the more notable recent events was the 75<sup>th</sup> anniversary of D-Day on June 6, 2019, at the 1881 Courthouse Museum in Custer.

Among the World War II veterans honored at that event was Harold Stickney of Custer, who served in 41 missions as an engineer gunner on a B-24 in the U.S. Air Force. Stickney was a member of American Legion Post 46 and served as mayor of Custer.

## Burn pit legislation passed by Congress, but challenges await veterans needing care

Combat veterans in South Dakota are encouraged by new legislation in Congress to expand treatment and benefits for soldiers exposed to toxic burn pits during deployment overseas, but questions remain...

The honor guard suspended operations for a year during the pandemic and is still trying to meet the demand of military burials. The state Department of Health estimates that 3,281 people died from COVID-19 in South Dakota, with the elderly most at risk.

"Once we started back up, we were busy just about every weekend," Gonsor said. "With the cremation process, a lot of (veterans) were sitting on the shelf waiting to be buried. We're close to getting caught up."





## 'How can we help them?'

Connie Johnson served in the Army from 2002-05, spending 11 months in northern Iraq during the Second Gulf War. She received a Purple Heart for injuries suffered when her 101st Military Police Company convoy was struck by a roadside bomb.

She was able to return to duty but dealt with nerve damage and post-traumatic stress disorder after returning to South Dakota, with scars on her neck as a remnant of war.

Her <u>South Dakota Veterans Council</u> role keeps her active in advocating for former soldiers, with the recognition of changing times and shifting needs. In South Dakota, 12.4% of military veterans are female, according to Census data, compared to 7.7% in 2010.



More than one-third of all veterans in the state are under the age of 55. A recent study by the Rand Corp. showed that post-9/11 veterans are more diverse and educated than their older cohorts but also more likely to meet the criteria for serious psychological distress.

"As society changes, veterans change," said Johnson, noting the protests and resentment that many Vietnam veterans faced upon returning home. "War is the same, people are the same, but the way we deal with our veterans has evolved. It's more accepted today for veterans to seek mental health care because our society is recognizing that there are problems. There's more willingness to say, 'How can we help them?'"

## Suicide rate for vets higher than civilians

In 2020, the suicide rate for veterans was 57% higher than for non-veteran adults, according to the U.S. Department of Veterans Affairs. Earlier this year, the Sioux Falls VA Medical Center campus was expanded with a mental health outpatient clinic focused on substance abuse, vocational rehabilitation and suicide prevention services.

Some veterans still find solace and support in groups such as the American Legion and VFW, while others take a more personalized approach.

"I love the civic duty and being around that atmosphere," said Johnson, a South Dakota State University alum who serves as the school's coordinator of veteran affairs. "Other people do not. They don't like talking about their experiences or being reminded of them. Or maybe they prefer to do it behind closed doors with a counselor. It's about figuring out what works best."

Gonsor was drafted into the Army in 1969 and served 14 months in Vietnam as a combat engineer and gunner. Part of his inspiration for the honor guard comes from his late father, a World War II veteran.

"I went to the VSO (Veterans Service Officer) to inquire about military rites and was told they would take care of it," said Gonsor. "On the day of the funeral, we went to the cemetery and there was no military presence there. I vowed to myself that I would never let that happen again."

Part of that means finding younger honor guard members, with Custer County a good place to recruit. It ranks first among South Dakota counties in percentage of adults who are military veterans (15.2%), followed by Fall River (14.1%), Meade (13.2%), Pennington (11.9%) and Day (11.7%).

## Honor guard finds new members

Helping with the youth movement is Richard Bierle and his wife, Kristen, who are members of American Legion Post 46. In August 2023, Kristen became the first female member of the honor guard by helping to provide military honors at the funeral of a Custer veteran.

Their son, Brandon, a senior at Custer High School, has served as a flag bearer in the color guard and will soon be trained as a member of the firing squad, bringing youthful energy to the corps at a time when it's much needed.

That's a source of satisfaction for Johnson, who doesn't believe the dwindling number of veterans in South Dakota should impact the legacies of those who came before.

## Illnesses related to firefighting foam latest burden for South Dakota veterans

Military veterans who served at Ellsworth Air Force Base near Rapid City and at Joe Foss Field Air National Guard Station in Sioux Falls are part of new national class-action lawsuits seeking damages due to exposure to toxic chemicals in firefighting foam.



To help do that, she started the <u>Freedom Acres</u> initiative in which she puts on her uniform upon request and delivers flowers to the gravesites of veterans whose families want to memorialize their service.

"I feel like we need to continue to have these remembrances," she said. "No matter where you go, there's someone whose life has been affected by the service. Whether it's at a funeral or Veterans Day or Memorial Day, these things are worth acknowledging."

As for Gonsor, his future plans were made clear to his fellow honor guard veterans.

"I'm going to end up in the national cemetery up in Sturgis – that's my next move," he said. "I told the guys that it would be an honor for them to bury me."

## **Honoring South Dakota's bravest**

Ahead of Veterans Day, The Dakota Scout queried readers about their favorite South Dakota veterans. The response was enthusiastic. Not surprisingly, many readers chose a family member as their favorite veteran. Here are their stories.



My favorite veterans are my dad and three of his brothers who all served during World War II. Emerson R. Gross, the first World War II casualty from Lake County and my namesake, was the uncle I never knew – thus my middle name of Emerson.

Emerson left SDSU to join the Army Air Corps, the predecessor of the Air Force, and be a fighter pilot. I would like to read a few sentences from a book my grandmother, Emerson's mom, wrote in 1982.

"Elwood (grandpa) and I were named township leaders to assist in problems that might arise from the war. The day of June 2, 1942, we attended a meeting at the courthouse in the afternoon. I had washed cloths in the morning and the lines were full of them. We hadn't been home long until we saw our mailman and his wife drive into the yard. He handed us a telegram which stated that Emerson was killed in a plane crash that morning. It just couldn't be true. There it was, though, in the telegram. He was on a flight and had engine trouble. He tried to make it to a landing field instead of bailing out, as he could have, but the plane would have fallen on a schoolyard full of children. As it was, he lost altitude and couldn't get out. What a tragedy for our family."

Randy Gross, Elkton



My dad is Army, my uncle Jim is Navy, and their dad Wally Huff, the former Woodbury County Attorney, was also Navy. But if you think I am going to punt from my favorite Navy veteran, my wife Tracy, you are sorely mistaken.

She enlisted against parental wishes just out of her local high school, Chariton High School, in Chariton Iowa, where she was born and raised. She went fresh out of school into boot camp out in Jacksonville, Florida, and then her first assignment was to be stationed with the first group of women that were being integrated into active military service, on of all things an aircraft carrier, the USS Lexington. Not even a month into that service, there was a training accident which killed her bunk mate and boot camp friend Lisa Mayo, along with the pilot and two others.

Tracy served honorably and was discharged 6 years later, serving another 6 years in the Naval Reserves, drilling in Des Moines, Iowa until we were married and moved to South Dakota.

Steve Huff, Yankton

My father (passed away May 1997) John Riswold from Baltic, S.D. World War II, 7th Calvary Infantry 1943–1945 Pacific Theatre. A great American and father!

Upon returning from the war he helped his dad on his farm by Baltic, and also was store manager of C & E Department store in Dell Rapids. Got married in January 1946. In 1950 he started working at the John Morrell meat packing plant for 26 years and also farming operation until 1964. He was an active church member at East Nidaros Lutheran, Baltic. He played amateur baseball and was on the 1942 Renner state championship team.

Dennis Riswold, Chandler, Arizona

My favorite South Dakota veteran is my husband, Mike Mehlhaff, Jr. While he did not have to go overseas, he served Active Duty at Fort Lewis in Washington for four years. He then went on to serve in the South Dakota National Guards. He left the guards after 4 years but has continued to support local veterans through the Post 8 Legion in Pierre serving on their board and currently serving as a lobbyist for the South Dakota American Legion.

Terri Mehlhaff, Pierre

Being a public servant isn't a new concept for Monica Serling-Swank. In 1982 she became a member of the U.S. Navy and held a Petty Officer 3rd Class role while

stationed at NavCamEastPac in Wahiawa, HI. Here she served as a Cryptologic Technician Administrator before moving around the country and eventually meeting her wife Lynn, in New York.

Monica and Lynn were married in a civil union in Connecticut in June 2006. Following that year, they moved back to South Dakota — a state which approved a state constitutional ban on same-sex marriage and civil unions in 2006.

Since moving back, Monica has devoted countless hours to a multitude of causes including Sioux Falls Pride. In her volunteer role, she made it a point to ensure everyone in South Dakota had access to the same freedoms and respect we all deserve.

In 2014, Monica's public service took the form of signing on to South Dakota's marriage lawsuit. This solidified her stake in a fight that would later secure a win by way of the Supreme Court ruling in Obergefell v. Hodges on June 26, 2015.

He flew over 1,300 hours that year of which 600 were combat assault time. He returned to the USA in June 1968 and became a flight instructor. His military honors include National Defense service medal, Army Aviator badge, Good Conduct medal, Vietnam Service medal, Vietnam Campaign medal, Army Commendation medal and 35 air medals! He was honorably discharged. He then joined the Sioux Falls Fire Rescue and became a captain during his 23 years of service. He then owned his own business and served on many boards in our local community. After retirement is now serving in leadership with the South Dakota American Legion. A LIFE of SERVICE to others.

Sue Peters, Sioux Falls



My favorite South Dakota veteran is my grandfather, Emil Carlson, who served during W.W. I. He never talked to me about it but I have many artifacts that tell his story and I use them to share that story with my students. When I grew up in Rosholt, S.D., there was a good chance that on any visit to town (population 406) I would cross paths with a Vietnam vet, W.W. II vet, and W.W. I vet.

That is not the world my students live in and sometime they are unfairly characterized as not knowing or caring. I try to give them a chance. Being able to put those items in their hands and tell the story of a soldier who grew up on an island in a lake that served as a border for South Dakota and enlisted in Pig's Point, VA, gives them a chance to understand and appreciate what it might have meant to be a veteran.

When my grandfather was married years later the minister was Rex Johnson. Rex served in W.W.I also and was severely injured in a battle in France. After the combat ceased a wagon arrived to pick up wounded and administer aid. They walked past Rex and said, "This one's dead," and moved on. After rounds were made, the soldier driving the wagon said, "We have room for one more." Rex sat up and said, "I'll take that!"

Left for dead, a South Dakota soldier who help me get to where I am today by uniting my grandparents in matrimony.

Lee Carlson, St. James Minnesota

George O. Johnson, from Irene, S.D., was a W.W. II combat infantry man in Company C, 317th Regiment, 80th "Blue Ridge" Division. Following their landing on the Normandy coast they fought and largely walked their way across France. In the early morning hours of Sept. 5, 1944 while attempting to cross the Moselle River in eastern France, George was wounded by shrapnel fractures to his leg and ankle from German shells. This was George's longest day. That day he lay still in the high grass on the river bank. Other soldiers littered the river bank awaiting the cover of darkness which would allow rescue. It was a day of morphine and tourniquets until he was evacuated to an aid station and subsequently to a field hospital for his initial surgery to save his leg. Three days later he was flown to England for further surgery/treatments, then on to Halloran Army Hospital in New York and finally to Winter General Hospital in Topeka, Kansas. Following numerous surgeries over his 13 month hospital stay, he was discharged from the hospital and Army in September 1945. He would carry German shrapnel in his body the rest of his life. He earned a Purple Heart, which is quietly put away and rarely talked about. George subsequently became a lawyer, and lived his life in Sioux Falls with his family. He died in June 2022.

Phil Johnson, Sioux Falls



John Waldron, born Aug. 24, 1900 in Fort Pierre, was of Oglala Sioux heritage on his mother's side. He led a squadron of torpedo bombers, taking off the USS Hornett aircraft carrier, into the Battle of Midway. Waldron is credited with using his "Sioux Indian instincts" to actually find the Japanese aircraft carriers the morning of battle, June 4, 1942. Once airborne, he diverted from directions given by superior officers. He led the entire American attack force to the proper location. Waldron, along with 28 of the 30 flyers of his squadron, perished when their planes were shot down by the fast-flying Japanese Zeros. Waldron was a graduate of the U.S. Naval Academy, class of 1924. He studied law and was admitted to the bar, but never practiced. In recognition of his gallant service, the Naval Destroyer, USS Waldron carries his name and the bridge over the Missouri river (connecting Fort Pierre and Pierre) was named in his honor.

This includes open water fishing, ice fishing, pheasant hunts, and combo upland/waterfowl hunts. ## The Power of Choice

The Inspiring Story of Melissa Stockwell, an Army Veteran and Paralympic Athlete Melissa Stockwell served as a Second Lieutenant in the US Army, and was deployed to Baghdad, Iraq in March 2004. Sadly, just three weeks into her deployment, a roadside bomb hit her Humvee causing the loss of her left leg above the knee. After undergoing several surgeries to recover from multiple infections, Melissa was honorably discharged from the Army. As the first female soldier to lose a limb in active combat, she was awarded both The Bronze Star Medal and the Purple Heart.

Despite the tragic incident, Melissa turned to sports for recovery. She made history in April 2008 by becoming the first Iraqi War Veteran to qualify for the Beijing Paralympics. She then shifted her focus to Paratriathlon and went on to become a three-time World Champion. Her talent and hard work led her to win the Paralympic Bronze Medal at the Paralympic Games in Rio de Janeiro on September 11, 2016.
